We have performed an audit of the accompanying financial statements of **AHH, Inc. 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **AHH, Inc. 401(k) Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **AHH, Inc. 401(k) Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Plan Merger**

As described in Note 1 to the financial statements, all of the assets of the plan were merged into the HPI 401(k) Plan effective December 30, 2022. Our opinion is not modified with respect to that matter.

### **Emphasis of Matter - Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable preparation of the financial statements in the circumstances, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **AHH, Inc. 401(k) Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of **AHH, Inc. 401(k) Plan's** internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about **AHH, Inc. 401(k) Plan's** ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of delinquent participant contributions as of December 31, 2022 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1: DESCRIPTION OF PLAN

The following description of AHH, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General and Plan Merger:** The Plan was a defined-contribution plan established on January 1, 1995 to provide retirement and other related benefits to all employees of AdvantEdge Healthcare Holdings, Inc. (the “Company”). An employee who was age 21 or older and had completed one month of service was eligible to participate for purposes of salary reduction contributions. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

During 2022, the Board of Directors voted to suspend all contributions to the Plan effective December 30, 2022 and to merge the Plan into the HPI 401(k) Plan, a defined contribution plan. Participant accounts were mapped to investments in the HPI 401(k) Plan based on the funds in which they were previously invested. The assets were in transit on December 31, 2022 and posted to participant accounts in the HPI 401(k) Plan on January 3, 2023.

The merger initiated a “Black Out” period beginning December 23, 2022 and continuing through January 31, 2023 allowing the custodian time to accurately complete the merger. During this period, participants could not change their investment allocations, change deferral percentages, or elect to withdraw any money from the Plan.

**Participant Contributions:** Each year, participants could contribute an amount up to a certain percentage of their pretax annual compensation, as defined in the Plan. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions as prescribed by Treasury regulations. Participants, with the consent of the Plan Administrator, could deposit amounts received from any other retirement plan which satisfied the tax rules for rollovers.

Upon becoming eligible to participate in the Plan, employees were automatically enrolled in the Plan with a contribution equal to 1% of eligible compensation.

Participants could designate a portion, or all, of their deferred contributions as Roth contributions, which were includable in the participant's gross income.

**Employer Contributions:** Each Plan year, the Company could make a discretionary matching contribution. All participants who made employee contributions during the Plan year were eligible for this matching contribution. No employer match was made for the year ended December 31, 2022.

The Company is permitted to make a qualified non-elective contribution (QNEC) to the Plan each year. For the year ended December 31, 2022, the Company made a QNEC of \$3,995.

**Investment Options:** Participants directed the investment of contributions into various investment options offered by the Plan.

#### NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

**Participant Accounts:** Each participant's account was credited with the participant's contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) were based on account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

**Vesting:** Participants were immediately 100% vested in their voluntary contributions, rollover contributions and, QNEC, plus the investment earnings thereon. Company discretionary matching and related earnings were subject to a vesting schedule based on the number of years of service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
Two years but less than three years	50%
Three or more years	100%

**Notes Receivable from Participants:** Participants could borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan transactions were treated as a transfer to (from) the investment fund from (to) the participant notes receivable fund. Notes receivable terms could not exceed five years unless for the purchase of a primary residence. Loans were secured by the balances in the participants' accounts and were supported by a promissory note. Loans bore interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. Principal and interest were paid ratably through payroll deductions. If the participant terminated employment or retired, the outstanding loan balance was due immediately unless the participant remained a party-in-interest. Failure to repay would result in the loan being offset from the participant's account. The offset loan amount would be considered a taxable distribution to the participant. Participants could prepay an outstanding loan at any time without a penalty.

**Payment of Benefits:** On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installment distributions. If a participant terminated employment for any reason, his or her account became 100% distributable if below \$1,000.

A participant could also request a withdrawal upon attainment of age 59 1/2, or upon demonstration by the participant to the Plan Administrator that the participant was suffering from a hardship, as defined in the Plan document.

**Forfeited Accounts:** At December 31, 2022 and 2021, forfeited non-vested amounts totaled \$0 and \$18,757, respectively. These accounts were used to reduce Plan expenses or future employer contributions. During the year ended December 31, 2022, \$4,633 was used to reduce Plan expenses.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** The financial statements of the Plan were prepared using the modified cash basis of accounting, whereby contributions were recorded when received, investment purchases and sales were recorded on the settlement date, investment income was recorded when received rather than when earned, administrative expenses were recorded when paid, and investments were recorded at fair market value. The financial statements and supplemental schedule have been prepared to satisfy the reporting and disclosure requirements of ERISA.

**Investment Valuation and Income Recognition:** Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities were recorded on the settlement date. Interest and dividend income was recorded when received. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses:** Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation of fair value of investments.

**Use of Estimates:** The preparation of financial statements in conformity with the modified cash basis of accounting required Plan management to make estimates and assumptions that affected the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties:** The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it was reasonably possible that changes in the values of investment securities would occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of Benefits:** Benefit payments to participants were recorded when paid.

**Notes Receivable from Participants:** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded when received. Related fees were recorded as administrative expenses and were expensed when they were paid. No allowance for credit losses had been recorded as of December 31, 2022 or 2021.

#### NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Uncertain Tax Positions:** The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there were no uncertain positions taken or expected to be taken. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

#### NOTE 3: PLAN TERMINATION

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### NOTE 4: TAX STATUS

The Internal Revenue Service (“IRS”) had determined in its opinion letter dated June 30, 2020, that the non-standardized prototype plan document adopted by the Plan, constituted a qualified trust under Section 401(a) of the Internal Revenue Code (“IRC”) and was exempt from Federal income taxes under provisions of Section 501(a). Although the Plan had been amended since receiving the opinion letter, the Plan Administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC.

However, operational failures were identified during the year ended December 31, 2022 and 2021. These failures included the following:

- Participants were not given the opportunity to defer on bonus compensation, which was considered eligible compensation, unless specifically elected otherwise by the participant, as defined in the Plan document.
- A participant was not automatically enrolled in a timely manner and under the terms of the Plan.
- A participant’s deferral change increase was not implemented.

No provision for income taxes has been included in the Plan’s financial statements as Plan management is taking necessary corrective action in accordance with applicable IRS and Department of Labor (“DOL”) regulations.

#### NOTE 6: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021. There were no assets at fair value at December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The preceding method described may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

**NOTE 7: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments were held primarily in mutual funds offered by Capital Bank and Trust Company and the Plan paid certain related fees. As Capital Bank and Trust Company was the Plan's Trustee, they were considered to be exempt party-in-interest transactions.

**NOTE 8: LATE REMITTANCES**

As reported on Form 5500, Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions, certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's regulations, thus constituting nonexempt transactions between the Plan and the Company. The late remittances amounted to \$96,080 for the year ended December 31, 2022. The Company is in the process of correcting these late remittances in accordance with DOL regulations.

**NOTE 9: SUBSEQUENT EVENTS**

The date to which events occurring after December 31, 2022, the date of the most recent statement of financial position, have been evaluated for possible adjustment to the financial statements or disclosure is October 11, 2023, which is the date the financial statements were available to be issued.
