### Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter**

As disclosed in Note 1 to the financial statements, the Plan transferred out assets to the Sam Brown Sales, LLC 401(k) Plan effective May 10, 2022. The remaining account balances in the Plan were merged into the Successwise Pooled Employer Plan effective December 31, 2022. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## 1. Description of the Plan

### General

Niteo Products, LLC 401(k) Plan (the Plan), established July 1, 2015, is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Effective June 1, 2022, the Plan was amended and restated due to a new favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2022. The Plan covers substantially all employees of Niteo Products, LLC (the Company or Plan Administrator). Reliance Trust Company (Reliance or Trustee) serves as the Trustee of the Plan. Automatic Data Processing, Inc. (ADP) serves as record-keeper of the Plan. The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective May 10, 2022, assets of \$1,163,531 were transferred out to Sam Brown Sales, LLC 401(k) Plan. Effective December 31, 2022, the remaining account balances of the Plan totaling \$5,868,770 were merged into the Successwise Pooled Employer Plan (the Affiliated Plan). These transactions have been recorded in Transfers Out of \$7,041,299 in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

### Eligibility and Participant Accounts

All employees of the Company who have completed three months of service are eligible to participate in the Plan on the first day of the month once eligibility is attained except nonresident aliens, leased employees, and part-time and temporary employees. Subject to certain limitations on annual additions, each participant's account is credited with employee elective deferrals, the Company's discretionary matching contributions and an allocation of plan earnings or losses, and is charged with certain administrative expenses. Participants may modify investment elections, transfer existing account balances and obtain information regarding the investments on a daily basis.

### Contributions

The Plan is funded through employee elective deferrals and Company discretionary matching contributions. A participant may elect to contribute any combination of pre-tax elective deferrals and after-tax elective deferrals from 1% to 90% (in whole percentages) of eligible compensation per pay period, subject to certain Plan defined exclusions and maximum limitations imposed by the Internal Revenue Code (IRC) (\$20,500 for 2022). Employees who are eligible to make elective deferrals under the Plan and who have attained the age of fifty before the close of the plan year are also eligible to make catch-up contributions subject to the maximum limitation imposed by the IRC (\$6,500 for 2022). Rollover contributions, representing distributions from other qualified defined benefit or contribution plans, are permitted by the Plan, as defined in the plan document.

The Company makes discretionary matching contributions to the Plan each pay period based on participants' compensation in the amount of 50% of employee elective deferrals up to 6% of eligible compensation.

### Investment Options

The Plan provides for participants to direct both their contributions and Company matching contributions into a variety of investment options, in accordance with participant investment elections and the provisions of the trust agreement. Participants should refer to the plan website for additional fund information.

### **Benefits Paid to Participants**

Upon normal retirement age, death, disability or termination, a participant's benefits are payable in the form of a lump-sum amount or direct rollover into another qualified plan or individual retirement account (IRA) equal to 100% of the participant's vested account balance as of the valuation date of such event. In addition, distributions may be made based on financial hardship. Account balances of \$5,000 or less at the time of distribution will be "cashed out" as an involuntary lump sum payment.

### **Vesting**

Participants are immediately vested in both their contributions and actual earnings thereon. Vesting in the Company's discretionary matching contributions plus actual earnings thereon is based on years of continuous service. Participants vest 20% per year beginning after one year of qualified service and are 100% vested after five years of qualified service or upon occurrence of the participant's retirement, death or disability, as defined by the Plan document.

### **Forfeitures**

Any non-vested Company matching contributions and earnings thereon upon a participant's termination of employment will be forfeited and may be used by the Plan to pay administrative expenses and to offset future Company contributions. These amounts are reported as a component of net assets available for benefits. The amount of forfeitures available for use as of December 31, 2022 and 2021 totaled \$0 and \$2,566, respectively. During the year ended December 31, 2022, forfeitures of \$24,049 were used to reduce Company contributions and \$4,857 of forfeitures were included in transfers out. No forfeitures were used to pay administrative expenses.

### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to certain restrictions as defined by the Internal Revenue Service (IRS). The borrowings are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator. Note terms are generally limited to a maximum of 5 years or to a maximum of 30 years if the note is used to acquire or build the principal residence of the participant. Participants can have up to three loans outstanding at one time. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections. There were no notes receivable from participants outstanding as of December 31, 2022. Notes receivable from participants as of December 31, 2021 had interest rates ranging from 4.25% to 6.50% with maturity dates ranging from January 2022 through November 2049.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants and fees paid related to distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold, as well as, held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon terms of the plan document or loan policy of the Plan. Notes receivable are valued at amortized cost, which approximates fair value. No allowance for credit losses has been recorded as of December 31, 2021.

### **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Mutual funds of registered investment companies are valued at the net asset value (NAV) or quoted market prices of shares held by the Plan at year end.

Common collective trust is valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This NAV is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Information Certified by Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompany Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021 and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

### 5. Tax Status

Effective June 1, 2022, the Plan is based on a nonstandardized pre-approved profit-sharing/money purchase/CODA plan, developed by ADP, LLC, which received a favorable advisory letter dated October 6, 2020, from the IRS stating that the nonstandardized pre-approved profit-sharing plan with CODA, constitutes as a qualified plan under Section 401 of the IRC. Through May 31, 2022, the Plan was based on a prototype non-standardized profit sharing plan developed by ADP, LLC, which received a favorable advisory letter dated July 16, 2014, from the IRS stating that the prototype plan constitutes a qualified plan under Section 401 of the IRC. The Plan Administrator believes the Plan, as adopted and amended, is operating within the guidelines of the IRC, and continues to be tax-exempt. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, concentration, market and credit risks. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### 7. Related-Party and Party In Interest Transactions

The Plan issues notes receivable to participants, which are secured by the participant's account balances. These transactions also qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by an officer or employees of the Company. No such officer or employee receives compensation from the Plan.

### 8. Reconciliation of Financial Statements to Form 5500

There are no reconciling items between the net assets or change in net assets reported in the audited financial statements and Schedule H of the Form 5500 as of December 31, 2022 and 2021, and for the year ended December 31, 2022.

### 9. Subsequent Events

In accordance with the Financial Accounting Standards Board Accounting Standards Codification 855, *Subsequent Events*, the Plan has evaluated events or transactions occurring after December 31, 2022, the Statement of Net Assets Available for Benefits date, through October 12, 2023, the date the financial statements were ready to be issued, and determined there were no events or transactions that would impact the financial statements for the year ended December 31, 2022, except as follows:

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.
