Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of AHMC Central Health LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AHMC Central Health LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

As discussed in Note A Section 1 to the financial statements, AHMC Central Health LLC 401(k) Plan was merged with Bright Health Management, Inc. 401(k) Plan (Bright Plan) effective December 31, 2022. All assets of the plan were transferred to the Bright Plan as of the effective date. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about AHMC Central Health LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Notes to Financial Statements

A. Description of Plan

The following description of the AHMC Central Health LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General*

The Plan is sponsored by AHMC Central Health LLC (ACH) and the following subsidiaries: Central Health MSO, Inc. (MSO) and Central Health Plan of California, Inc. (CHP) (the "Employers" or "Sponsors"). CHP was purchased by Bright Health of California (Bright) effective April 1, 2021; as part of consideration of the sale, ACH received shares in the parent company of Bright. As a consequence of the purchase by Bright of CHP, the Plan was merged with Bright Health Management, Inc. 401(k) Plan (Bright Plan) effective December 31, 2022. All assets of the Plan were transferred to the Bright Plan as of the effective date.

The Plan was adopted effective June 1, 2000. The Plan is a defined contribution plan wherein the sponsors have adopted the deferred compensation election under Section 401(k) of the Internal Revenue Code.

Employees of the sponsors are eligible to participate once they complete three continuous months of service or one year-of-service if earlier. As of December 31, 2022, there were 0 participants.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

2. *Contributions*

Each year, participants may contribute up to the maximum amount allowed by law, \$20,500 in 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For 2022, the sponsors make matching contributions of 50% of the first 5% of base compensation that a participant contributes to the Plan. The sponsors may also make discretionary profit sharing contributions.

3. *Participant Accounts*

Each participant account is credited with the participant's contribution, any matching contribution of sponsors, and an allocation of Plan earnings; each account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

A. Description of Plan (Continued)

4. *Vesting*

Participants are immediately vested in their voluntary contributions (including rollover contributions) plus actual earnings thereon. Vesting in the sponsors' contribution portion of their accounts is based on years of vesting service. A participant is 100% vested after five years of vesting service.

5. *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 3.25% to 5.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through periodic payroll deductions. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

6. *Payment of Benefits*

- a) On termination of service due to death, disability, or retirement, a participant becomes 100% vested in all of his or her accounts. For termination of service due to other reasons, a participant is entitled to receive only the vested percentage of his or her account balance. Vested benefits under \$5,000 are distributed in a single lump-sum payment. For benefits over \$5,000, the participant or his or her beneficiary may elect to receive a lump-sum payment, annual installments over a period of not more than the participant's or beneficiary's assumed life expectancy, or partial withdrawals of at least \$1,000. Normal retirement age for participants is 65 years old.
- b) After attaining age 59 1/2, a participant is permitted to take distributions from those accounts in which he or she is vested 100%.
- c) A participant may apply for a financial hardship withdrawal on his/her deferral contributions.

7. *Forfeited Accounts*

At both December 31, 2022 and 2021, forfeited non-vested accounts totaled \$0. These accounts are used to reduce future employer contributions and to offset investment and administrative expenses. In 2022, participant forfeitures of \$3,194 and dividends of \$1 were added to forfeited non-vested accounts; employer contributions were reduced by \$3,195 from forfeited non-vested accounts, and fees of \$0 were paid from such accounts.

B. Summary of Significant Accounting Policies

1. *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The insurance company asserts that, within a retirement plan, contract value is an approximate measurement for fair value. Therefore, the Statements of Net Assets Available for Benefits presents the fair value of the fully benefit-responsive investment contracts as contract value. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

2. *Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

4. *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements. All Plan assets were transferred to the Bright Plan as of December 31, 2022.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

5. *Payment of Benefits*

Benefits distributed to participants are recorded when paid by the Plan.

6. *Operating Expenses*

Administrative expenses incurred in connection with the Plan are paid by the Plan, unless paid by the sponsors at their option.

7. *Subsequent Events*

In preparing these financial statements, Plan management has evaluated events for potential recognition or disclosure through October 12, 2023, the date the financial statements were available to be issued.

C. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurement, defines fair value, establishes a framework to measure fair value, and enhances disclosure requirements about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the FASB ASC 820 fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

C. Fair Value Measurement (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Shares of pooled separate accounts: Valued daily based on the market value of the underlying net assets in each separate account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

D. Investment Contract with Insurance Company

The Plan entered into a benefit-responsive investment contract with Standard Insurance Company ("The Standard"). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting rate is calculated based on the investments underlying the contract. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

D. Investment Contract with Insurance Company (Continued)

As described in Note B, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value, which is approximated by contract value, per The Standard's assertion. In prior years, when the fair value differed from contract value, an adjustment from fair value to contract value was shown, such that the net assets available for benefits were at contract value. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The value of the investment contract at December 31, 2022 and 2021 was \$0 and \$1,778,927, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a monthly and quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with The Standard. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. Upon occurrence of any of these events, a market value adjustment may apply. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by The Standard, a market value adjustment may apply. The Plan administrator believes that it is in compliance with The Standard's conditions and that The Standard therefore has no reasonable cause to terminate the contract.

I. Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate sections of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan adopted the Standard Retirement Services, Inc. Volume Submitter Profit Sharing Plan, which has obtained a favorable tax determination letter from the Internal Revenue Service. Therefore, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to December 31, 2019.

J. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
