Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Diversified Roofing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

DIVERSIFIED ROOFING 401(K) PLAN NOTES TO FINANCIAL STATEMENTS

Note 1 Description of the Plan

The following description of the Diversified Roofing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of DV Management Company, LLC (the “Company”, “Plan Sponsor”, and “Plan Administrator”) or any affiliate who has adopted the Plan. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees of the Company are eligible to participate in the Plan after completing two months of service. Once eligible, participants are allowed to enter the Plan on the first day of the calendar month, coincident with or next following the date the employee completes the required two months of service.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan under the provisions of a Roth feature, wherein the contributions are taxed to the participant. The subsequent disbursements under the Roth feature are non-taxable at the time of the distribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company has elected Safe Harbor status and makes Safe Harbor matching contributions equal to 100% of the first 3% of eligible earnings that employees defer as an elective deferral and an additional 50% on the next 2% of eligible earnings that employees defer as an elective deferral. Contributions are subject to regulatory limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s Safe Harbor matching contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their contributions and employer contributions plus actual earnings thereon.

Note 1
Description of the Plan (Continued)

Payment of Benefits

On termination of service due to disability or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or in the case of death, pursuant to the election of the participant or designated beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Forfeitures

All contributions and earnings are immediately vested. Therefore, there are no forfeitures.

Note 2
Summary of Significant Accounting Policies and Use of Estimates

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Summary of Significant Accounting Policies and Use of Estimates (Continued)

Expenses

Certain expenses of maintaining the Plan, primarily legal, third-party administrator, and audit fees, are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value investments.

Note 3

Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2022 and 2021, and net appreciation/depreciation in fair value of investments, interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the trustee of the Plan).

Note 5
Party-In-Interest Transactions

Certain Plan investments are managed by Capital Bank and Trust Company (Capital Group/American Funds), the trustee, and Capital Group Retirement Plan Services, the recordkeeper, and other companies that provide investment management services to the Plan. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Administration fees paid by the Plan also qualify as party-in-interest transactions. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Note 6
Plan Termination

Although it has not expressed any intention of doing so, the Company has the right to terminate the Plan subject to the provisions of ERISA and discontinue its contributions at any time.

Note 7
Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8
Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

Note 9
Untimely Contributions

During the years ended December 31, 2022, 2021 and 2020, the Plan failed to remit certain participant contributions within the time period permitted by the Department of Labor. As a result of the untimely contributions, the Plan is responsible for contributing all lost earnings to the participants and filing Form 5330 with the Internal Revenue Service. As of the date of this report, the Plan has estimated the amount of lost earnings and interest due to the respective participants and is in the process of remitting the amounts to the Plan. Further, it is anticipated that the Plan will file the Form 5330. No accrual for lost earnings or penalties and interest was made at December 31, 2022 and 2021 as the amounts were considered immaterial by Plan management.
