Opinion

NOTE A - Description of Plan

The following description of the **Jaffe, Raitt, Heuer & Weiss Professional Corporation Medical Plan** provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan provides health and other benefits covering all eligible Jaffe, Raitt, Heuer & Weiss employees working 20 hours or more per week. The Plan was established in 1989 and the Trust was established on January 2, 2008. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Plan provides health benefits (medical, prescription drugs, dental and vision) to eligible employees, their spouses and dependents beginning as of the first day worked assuming authorization to deduct a premium, if any, has been made. If a participant's spouse is eligible for coverage under his or her own employer's group health plan for medical benefits, the spouse will not be eligible to participate in or be covered under the plan for that coverage. If the medical coverage for the spouse does not qualify as "minimum essential coverage" the spouse is eligible for coverage under the Plan. Coverage for adult children ends at the last day of the month in which the child attains the age of 26. Coverage ends at termination of employment, unless COBRA coverage is elected.

The Plan provides participants the option to enroll in a high deductible health plan (HDHP) which includes the ability to participate in a health savings account (HSA). For employees that enrolled in the HDHP, the Plan Sponsor provides an annual HSA contribution in the amount of \$500 for single participants and \$1,000 to participants with family coverage.

The Plan also provides other benefit Programs including various types of insurance coverage, including long-term disability, accidental death & dismemberment, life, hospital indemnity and critical care. All applicable activity relating to these benefits is included in the financial statements.

Self-Insured Benefits - The medical, prescription drug and dental claims of benefits are self-insured and are processed by ASR Health Benefits (third party administrator) but the responsibility for payment to participants and providers is retained by Jaffe, Raitt, Heuer & Weiss, P.C. Optical benefits are insured and claims are processed by Vision Service Plan.

Long-term disability, accidental death & dismemberment, and life benefits are insured and claims are processed by Unum Life Insurance Company of America. Hospital indemnity & critical care benefits are insured and claims are processed by Continental American Insurance Company.

Stop-Loss Coverage - The Plan has entered into a stop-loss insurance arrangement in an effort to limit expenses for self-insured benefits.

Contributions - Participating eligible employees contributed premiums that ranged from \$50 to \$600 per month. Exact premiums are determined by classification of employee (attorney, staff), type of coverage (employee, employee + 1, family) and full-time/part-time status.

NOTE B - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting. Unpaid claims at year end are reported in the Statements of Changes in Benefit Obligations.

NOTE B - Summary of Accounting Policies (continued)

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Stop-Loss Premiums - Premiums for stop-loss insurance are included in the premium payments in the accompanying statement of changes in net assets available for benefits. Stop-loss refunds for the years ended December 31, 2022 and 2021 were \$835,453 and \$260,960, respectively.

Subsequent events - Subsequent events were evaluated through October 13, 2023, which is the date the financial statements were available to be issued. The Plan is currently under audit by the Department of Labor. The audit is ongoing as of October 1, 2023, but management does not anticipate any adverse results in connection with the audit.

On December 31, 2022, the Company merged with the law firm of Taft, Stettinius & Hollister, LLP.

NOTE C - Other Matters and Tax Status

The Company, as Sponsor of the Plan, has established and maintains the Plan. The Company has set aside assets in the Plan, as described in the Internal Revenue Code section 419(e) and subject to limitations under Code section 419A, for the sole purpose of paying benefits under the Plan. Contributions to the Plan shall be held in a trust and the Company, at all times, is treated as the owner of the property. The Plan administrator and the Plan's tax counsel believe the Plan, as amended, continues to qualify and operate in accordance with applicable provisions of the Internal Revenue Code.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

NOTE D - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to active employees and COBRA recipients, to discontinue its contributions at anytime, and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE E - Claims Incurred but Not Reported

Since the Plan's inception, and based on prior experience of the Plan, the third-party administrator has not estimated obligations for claims incurred but not reported. Therefore, no liability is included in the financial statements for the years ended December 31, 2022 and 2021.

NOTE F - Administrative Expenses & Related Party/Party-in-interest Transactions

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators including ASR Health Benefits, Call-A-Doctor, Bank of America, and Vision Service Plan. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses and are considered party-in-interest transactions. Fees paid by the Plan amounted to \$109,477 and \$106,076 for the years ended December 31, 2022 and 2021. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.
