NOTE 1 - DESCRIPTION OF PLAN AND SIGNIFICANT ACCOUNTING POLICIES

Plan Description

The following description of the Doss Enterprises, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan, established January 1, 2014, is a defined contribution 401(k) plan available to all employees, who are not covered by a collective bargaining agreement, a leased employee, or non-resident alien, of Doss Enterprises, LLC (the Plan Sponsor), who attains 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective August 20, 2019, the Plan was amended to allow entry into the Plan immediately upon hire.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Each year, participants may contribute up to the maximum allowable amount as permitted by the Internal Revenue Code. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also permits participants to make catch-up contributions. The Plan Sponsor will make a safe harbor employer matching contribution to the Plan equal to 100 percent of the Participant's elective deferrals, including catch-up contributions, that do not exceed 3 percent of the Participant's compensation, plus 50 percent of the amount of the Participant's elective deferral that exceeds 3 percent of the Participant's compensation but that do not exceed 5 percent of the Participant's compensation.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Participant Investment Options

Each participant has the right to direct all contributions and earnings thereon among alternative investment options made available by the Plan Sponsor under the Plan. Participants should refer to the most recent annual report and prospectus of pooled separate accounts for information on risk factors, asset concentrations, investment objectives and other financial data. Participants may transfer funds between investment options at any time.

Participant Accounts

Each participant account is credited with the participant's elective contributions and contributions by the Plan Sponsor. In addition, each participant's account is credited with the specific earnings (losses) of the investments owned in self-directed participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The Plan provides for immediate vesting of salary reduction and safe harbor matching contributions and earnings thereon. In connection with any profit sharing and nonelective contributions, the Plan provides for a six year vesting schedule, as shown below:

Forfeited Accounts

These accounts will be used to pay for administrative expenses or reduce future employee contributions.

Payment of Benefits

Effective August 20, 2019, the Plan was amended to allow loans. The loans are secured by the balance in the participant's account and bear interest at the local prevailing rates. The participant notes receivable balance as of December 31, 2022 and 2021 was \$39,903 and \$32,976, respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Excess contributions payable represents contributions remitted to the Plan that were not in compliance with Plan provisions.

NOTE 2 – PARTIES-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. During the year ended December 31, 2022, administrative expenses of \$25,141 were paid to an entity considered to be a party-in-interest to the Plan. Administrative expenses for legal, accounting and other professional services are paid directly by the Plan Sponsor and are not charged to the Plan. In addition, certain administrative functions are performed by officers or employees of the Plan Sponsor at no cost to the Plan

NOTE 3 – INVESTMENT INFORMATION

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2022 and 2021 and investment income, which includes net appreciation/(depreciation), were obtained and derived from information supplied to the Plan Sponsor and certified as complete and accurate by the Trustee. Investments as of December 31, 2022 and 2021 consisted of Pooled Separate Accounts valued at \$3,203,206 and \$3,942,269, respectively. Investment (loss), certified by the Trustee, for the year ended December 31, 2022 was \$(663,677).

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Pooled separate accounts: The value of a unit in a pooled separate account is the fair market value of investments in the account as of the valuation date, plus cash balances and accruals less accounts payable, expenses and taxes that are allocable to the account, divided by the number of outstanding participation units in the account. Securities held in the pooled separate accounts are valued based on quoted market prices. If there is no readily available market value for a particular security, the investment manager will determine the fair market value of such investment in accordance with accepted practices and applicable laws and regulations. As of any date, using the practical expedient method, the value of the Plan's share of a pooled separate account will equal the number of participation units held by the Plan multiplied by the participation unit value, which represents Net Asset Value (NAV).

At December 31, 2022 and 2021, investments held by the Plan measured at NAV were \$3,203,206 and \$3,942,269, respectively. In accordance with FASB ASC 820 all investments held by the Plan are measured at NAV using the practical expedient method and are excluded from the fair value hierarchy.

NOTE 6 - PLAN TERMINATION

Although it has not expressed intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participant account will become 100 percent vested.

NOTE 7 – TAX STATUS

The Internal Revenue Service has determined and informed the Plan Administrator by a letter dated March 31, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the determination letter.

NOTE 8 – SUBSEQUENT EVENT

The Plan has evaluated events and transactions occurring after December 31, 2022 through the date of the Auditor's report, which is the date the financial statements were available to be issued.
