## Independent Auditors' Report

### The Plan Administrator of The Frick Collection Tax Deferred Annuity Plan

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of The Frick Collection Tax Deferred Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

**1. Description of Plan**

The following description of The Frick Collection Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of The Frick Collection (the "Museum") and was established on November 1, 1992. The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Board of Trustees of the Museum oversees governance of the Plan. The Museum's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Museum's Board of Trustees.

***Eligibility***

Participation in the Plan is voluntary and employees may enroll in the Plan at any time immediately following their date of hire with the Museum.

***Contributions***

Participants may elect to have a percentage or specified dollar amount deducted from their compensation as defined by the Plan. The money that is deducted are "pre-tax" dollars. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Museum. There is an annual limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Those participants may increase their contributions by an additional amount up to \$3,000 annually (\$15,000 lifetime maximum). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Museum does not make contributions to the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and the investment earnings thereon. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

**1. Description of Plan (continued)**

***Vesting***

A participant is fully vested in his or her own contributions, rollover contributions and earnings thereon at all times.

***Payment of Benefits***

Upon termination of service due to retirement, disability or death, a participant or beneficiary may elect to receive either the entire amount credited to the participant's account in either a lump-sum or, at the participant's election, in periodic installments. For termination of service due to other reasons a participant may receive the current value of the participant's vested account in a lump-sum distribution.

Hardship withdrawals are allowed under the Plan and are generally defined as an immediate and heavy financial need for which funds are not reasonably available from other resources. Hardship situations are limited to purchase of a primary residence, certain tuition expenses, certain funeral expenses, deductible unreimbursed medical expenses and the need to prevent eviction from, or foreclosure of a mortgage on, a principal residence. The withdrawal cannot exceed the amount of the immediate need, including amounts necessary to pay any federal, state or local income taxes or penalties reasonably anticipated to result from the withdrawal. In accordance with Internal Revenue Service ("IRS") Regulations participants must first exhaust all other assets reasonably available to them prior to obtaining a hardship withdrawal.

***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000 (whichever is less). Participants may take a loan once in any 12 consecutive-month period, subject to the IRC limits, on the total amount that can be borrowed. Participants may only have one outstanding loan at a time. The interest rate must be reasonable and loans must be repaid within five years, unless the loan is used to purchase a principal residence of the participant. The notes are secured by the balance in the participant's account. Principal and interest are paid directly by the participant through periodic monthly or quarterly payments. Interest rates on outstanding loans range from 2.95% to 5.75% with maturity dates through 2026 at December 31, 2022.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), using the accrual basis of accounting, which recognizes revenue when it is earned, and expenses as they are incurred.

The Plan was viewed as an amalgamation of individual annuity and custodial accounts, and the Plan and its record-keepers did not maintain financial information at the Plan level. Because certain historical records were not maintained or are not available at a Plan level, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009. This accounting policy election is permitted by the Department of Labor's ("DOL") Field Assistance Bulletin No. 2009-02 ("FAB 2009-02"), "Annual Reporting Requirements for 403(b) Plans", however, U.S. GAAP requires that these accounts and the related income and distributions be included in the accompanying financial statements. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable.

***Use of Estimates***

In conformity with U.S. GAAP, the Plan's management makes estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

**2. Summary of Significant Accounting Policies (continued)**

***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the Lincoln Fixed Account and Lincoln NY Stable Value Account, which are stated at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers in (if any), less any withdrawals and transfers out (if any). The contract value is derived from a discounted cash flow analysis and other factors. Registered investment companies are stated at fair value and classified as Level 1 in the fair value hierarchy as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Museum and are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 12, 2023.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2022 and 2021, and interest and dividends, net depreciation in value of investments, and interest on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. (“Lincoln”) and Lincoln Life and Annuity Company of New York, qualified institutions.

**4. Lincoln Fixed Account**

The Lincoln Fixed Account (the “Fixed Account”) is a fully benefit-responsive investment contract with Lincoln. The Fixed Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least quarterly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. Lincoln has an internal committee that reviews and sets interest rates quarterly based on a variety of proprietary factors. Lincoln’s standard crediting methodology is to apply a portfolio interest rate to the Fixed Account. That is, a single interest rate applies to the entire balance of the participant’s Fixed Account. The declared portfolio interest rate is published quarterly in advance of the quarter for which the rate will be effective. The rate of interest actually credited to the Fixed Account will be the greater of the declared rate of interest or the guaranteed minimum interest rate specified in the contract. Lincoln may vary the interest crediting methodology from time to time. A contribution allocated to the Fixed Account is credited with interest beginning on the next calendar day following the day the contribution is received in good order and processed to the participant’s account. The processing date is the same as the date of receipt if all participant data is complete.

The Fixed Account represents approximately 26% and 23% of the Plan’s net assets available for benefits as of December 31, 2022 and 2021, and represents an obligation from Lincoln as amounts come due. Contributions allocated to the Fixed Account are guaranteed to be credited with a minimum interest rate. The standard guaranteed minimum interest rate is 3.00%.

A participant may transfer or withdraw all or a portion of his or her Fixed Account balance without limitation. Withdrawals are subject to contract surrender charges and annual contract administration charges, if applicable. Surrender charges may be waived under certain conditions, as described in the group annuity contract. In addition, some contracts may have elected an optional free withdrawal provision that permits one withdrawal on behalf of the participant of up to 20% of the participant’s total account balance (i.e., Fixed Account balance plus any variable subaccount balances) each contract year without incurring a surrender charge. Lincoln National Life Insurance Company, is evaluated by nationally recognized statistical rating agencies. The financial ratings from these agencies are as follows: A.M. Best (A+ as of November 2022), Standard and Poor’s (AA- as of November 2022), Moody’s (A1 as of November 2022), and Fitch (A+ as of December 2022).

The Plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value.

**5. Lincoln Stable Value Account**

The Plan offers the Lincoln NY Stable Value Account (the “Contract”) as an investment option under the Plan. The Contract is a fully benefit-responsive fixed annuity contract issued by The Lincoln National Life Insurance Company and is backed by the general assets of the issuing company. The Contract is designed to provide Plan participants with liquidity, yield and stability. Benefit payments from the Contract are allowed whenever qualifying life events occur (upon retirement, termination and other life events), but voluntary withdrawals for the purpose of transfer to other investments are limited by 90-day equity wash provisions. The crediting rate is determined and declared periodically by a Lincoln executive committee.

The Contract is not material to the Plan’s net assets available for benefits as of December 31, 2022 and 2021, and represents an obligation from Lincoln as amounts come due. The credit risk of the issuer, Lincoln National Life Insurance Company, is evaluated by nationally recognized statistical rating agencies. The financial ratings from these agencies are as follows: A.M. Best (A+ as of November 2022), Standard and Poor’s (AA- as of November 2022), Moody’s (A1 as of November 2022), and Fitch (A+ as of December 2022).

**6. Plan Termination**

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**7. Tax Status**

The Museum has adopted a plan document that has been designed to satisfy the IRC Section 403(b) regulations. The Plan is an adopter of an Internal Revenue Service approved volume submitter plan which received an opinion letter dated March 31, 2017 from the Internal Revenue Service. The Museum believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition and/or disclosure. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2019.

**8. Party-in-Interest Transactions**

Certain investments are managed by Lincoln Financial Group Trust Company, Inc. and Lincoln Life and Annuity Company of New York Lincoln, the Plan's custodians and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Museum who participate in the Plan, provide administrative services to the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2022 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
