Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

As discussed in Notes 1 and 10 to the financial statements, the Plan was merged into another plan on October 6, 2022. The Plan Administrator is currently evaluating the continuance of the Plan. Our opinion is not modified with respect to that matter.

1. Description of the Plan

The following description of the Blackstone Valley Mayoral Academy 401(k) Plan and Trust (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant directed defined contribution 401(k) plan covering substantially all employees of the Rhode Island Mayoral Academy Blackstone Valley (BVP or the Plan Sponsor) who are at least twenty-one (21) years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Trustee and Administrator of the Plan is an employee of BVP. Empower Retirement, LLC (Empower) is the appointed recordkeeper and custodian of the Plan and acts at the direction of the Plan Administrator. During 2022, the Plan Administrator and BVP's Board of Directors approved the merger of the Plan into the OneDigital Open Pooled Employer Plan FBO Rhode Island Mayoral Academy Blackstone Valley. All assets of the Plan were transferred on October 6, 2022 (Note 10). The Plan Administrator is currently evaluating the continuance of the Plan.

Contributions

Participants may elect to contribute up to 100% percent of their eligible compensation, not to exceed annual limitations as permitted by the Internal Revenue Code (IRC). In addition, participants may make Roth contributions into the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

BVP contributes a safe harbor matching contribution to the Plan. The amount of this safe harbor matching contribution is equal to 100% of a participant's elective deferrals, not to exceed 5% of the participant's compensation. BVP may, in its sole discretion, make matching contributions in addition to those described above (non-safe harbor matching contributions). During 2022, BVP did not elect to make any non-safe harbor matching contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, BVP's safe harbor matching contribution, and BVP's non-safe harbor matching contribution, and their allocation of earnings and losses. Allocations are based on compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, BVP's safe harbor contributions, and BVP's non-safe harbor matching contribution, plus the allocation of Plan earnings on those contributions at the time of allocation.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. A participant may have only one note outstanding at a time. Note terms range from one to five years or longer for the purchase of a primary residence. The notes are secured by the participant's vested balance and bear interest at a rate determined by the Plan Sponsor. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Benefits are available for distribution upon retirement, termination of service or disability in a single lump-sum distribution. In the event of a participant's death, payment of vested benefits will be made to the beneficiary in accordance with the procedures described in the Plan. If a participant's vested balance is greater than \$1,000 but is less than \$5,000, an individual retirement account (IRA) will be established on the participant's behalf if a distribution is not otherwise elected. If a participant's vested balance is less than \$1,000, the participant will receive an immediate cash-out of the vested account balance. Participants who have attained age 59½ may elect to withdraw all or a portion of the vested account while still employed. In addition, if a participant has reached age 70½, distributions are required to be made if the participant is still employed by the Plan Sponsor. Lastly, participants may receive a distribution from their rollover contribution account at any time.

Early Withdrawals

Hardship distributions are permitted from participant elective deferral accounts, subject to the limitations imposed by the IRC.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value except for the group annuity contract (Note 4), which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-responsive Investment Contracts

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

During the period from January 1, 2022 to October 6, 2022 and the year ended December 31, 2021, the Plan had investments in the MassMutual Guaranteed Interest Account, which is a group annuity contract issued and backed by the general accounts of MassMutual, which meets this requirement.

The Plan's investment in this fund, which represents contributions and reinvested interest income, less withdrawals and expenses, plus or minus net participant-directed transfer activity with the Plan's other investment funds is recorded at contract value.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Contributions

Participant and BVP safe harbor matching contributions are recorded bi-monthly when BVP remits the payroll deductions for investment into the Plan. BVP non-safe harbor matching contributions are recorded at the end of the year, if applicable.

Payment of Benefits

Benefits are recognized when paid or payable to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by BVP, unless BVP directs that the expenses be paid by the Plan. Expenses that are paid by BVP are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments were held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements with the custodian. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through October 13, 2023, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2021, the Plan's investment in mutual funds are reported at level 1 within the fair value hierarchy. As a result of the plan merger, there are no investment balances at December 31, 2022 (Note 10).

4. Group Annuity Contract

The Plan had an investment in the MassMutual Guaranteed Interest Account (or "GIA"), an investment with a guaranteed rate of return and a guarantee of principal that was backed by the general account of MassMutual.

The GIA was credited with participant contributions, plus earnings and charged with participant withdrawals and administrative expenses. Under the contract, a crediting rate was established for a six-month period of time and all assets invested in the GIA were credited with that rate. At the expiration of each rate period, a new crediting rate was declared. MassMutual assumes market, credit, and interest rate risks for the assets supporting the GIA. The contract value of funds allocated to the GIA at December 31, 2021 was \$274,536. As a result of the plan merger, there was no balance in this investment at December 31, 2022 (Note 10). The average crediting interest rate was 1.10% at October 6, 2022 and December 31, 2021, respectively. The GIA's minimum guaranteed rate was a National Association of Insurance Commissioners (NAIC) based formula based upon the prevailing treasury rate and in no instance will be less than 1.00%.

The Plan Sponsor believed the occurrence of events that would limit the Plan's ability to transact at contract value with Plan participants was not probable since the investment choice was backed by the general account of MassMutual.

5. Plan Termination

BVP expects to continue the Plan indefinitely. However, BVP reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

6. Income Tax Status

The Plan has been designed using a volume submitter plan and trust, in which the IRS stated in a letter dated March 31, 2014 that form of the Plan satisfies the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter in order to comply with the latest applicable tax laws and regulations. BVP and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Summary of Financial Data Certified by the Custodians

The following is a summary of financial information and data certified by the custodians, Empower and Reliance Trust Company (Reliance) on behalf of Empower:

Statements of Net Assets Available for Plan Benefits at December 31, 2022 (Empower) and 2021 (Reliance); and

Investment income, interest income from participant notes receivable and net depreciation in fair value of investments on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2022.

8. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

9. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Empower, the recordkeeper and custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for custodial, recordkeeping and administrative services amounted to \$21,424 for the year ended December 31, 2022. Participant notes receivable also qualify as party-in-interest transactions. In addition, an employee of BVP served as the Trustee of the Plan.

10. Plan Merger

The Plan Administrator adopted a resolution to merge the Plan into OneDigital Open Pooled Employer Plan FBO Rhode Island Mayoral Academy Blackstone Valley on October 6, 2022. As a result, all participant balances were transferred to the OneDigital Open Pooled Employer Plan FBO Rhode Island Mayoral Academy Blackstone Valley on that date. The assets transferred from the Plan totaled \$10,251,440, including participant notes receivable of \$32,618.
