Notes to Financial Statements

December 31, 2022 and 2021

NOTE 1 - Description of Plan:

The following brief description of the Pacific Orchard Development, Inc. 401(k) Profit Sharing Plan H – L is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

Pacific Orchard Development, Inc. 401(k) Profit Sharing Plan H – L is a trustee, defined contribution plan established for the benefit of eligible employees of Pacific Orchard Development, Inc. (the Company). The Plan was originally effective September 1, 2019, and has been amended and restated to conform to new tax laws and provisions. Employee participation in the Plan is voluntary. Employees who have reached the age of 21 and are not covered by a collective bargaining agreement, are not a leased employee, and not a non-resident alien, are eligible to participate in the Plan. Plan entry dates are January 1 or July 1 coincident with or next following the date you attain age 21 and complete one year of eligibility service.

Participants may elect to contribute a percentage of their before-tax compensation (401(k) contributions) or after-tax basis (Roth contributions) as defined, not to exceed a certain dollar limit as set by law. The Company makes a matching contribution in an amount equal to 100 percent of the participant's contribution, not to exceed 4 percent of the participant's compensation, as defined. Plan income or loss is allocated to the participant's account based on the participant's account balance as specified in the Plan. The Plan also provides that the Company, at its discretion, may make additional profit-sharing contributions which, if made, will be allocated among all active participants based upon each participant's compensation for the year. During 2022 and 2021, the Company did not make an additional profit-sharing contribution.

Participant contributions and safe harbor matching contributions made by the Company to the Plan and earnings thereon are fully vested at all times. Company non-elective contributions to the Plan and earnings thereon vest to the participants based upon their years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2	0%
2 - 3	20%
3 - 4	40%
4 - 5	60%
5 - 6	80%
6 or more	100%

Participants are 100 percent vested upon reaching age 65, upon death, in the event they are totally and permanently disabled or upon Plan termination, regardless of the participants' years of service. Forfeited non-vested Company matching contributions of terminated participants may be used to fund a portion of Company contributions but will, under certain circumstances, be restored to the participants who previously forfeited the contribution upon re-employment. During 2022 and 2021, no forfeited amounts were utilized by the Plan and there were no forfeited amounts available to fund future Company contributions at December 31, 2022 and 2021.

Upon termination of employment or retirement, a participant may elect to receive benefit payments through any one of the several methods provided by the Plan. Under circumstances defined by the Internal Revenue Service (IRS), the Plan allows, subject to approval by the Company, the withdrawal of an employee's account due to an immediate and heavy financial need.

As of December 31, 2022 and 2021, there were no net assets allocated to the accounts of employees who have withdrawn from the Plan but have not yet been paid out.

Amendment and termination of Plan

The Company shall have the right to amend the Plan by resolution of the Employer's Board of Directors, provided that no amendment shall attempt to cause any of the assets of the Plan to be used for or diverted to purposes other than for the exclusive benefit of participants or their beneficiaries.

In the event the Employer elects to terminate the Plan or discontinue operation of its business, the entire interest of the participants shall vest 100% immediately and be non-forfeitable.

Merger

On October 5, 2022, the Board of Directors of Pacific Orchard Development, Inc. approved the termination and merger of this Plan into the Pacific Orchard Development, Inc. 401(k) Profit Sharing Plan A-G as of December 31, 2022. As a result, all investments were transferred from this Plan into the Pacific Orchard Development, Inc. 401(k) Profit Sharing Plan A-G on that date.

Administrative expenses

The majority of administrative expenses relating to the Plan for the year ended December 31, 2022 were paid by the Company.

Subsequent events

Management has evaluated subsequent events through October 11, 2023, the date on which the financial statements were available to be issued.

NOTE 2 - Summary of significant accounting policies:

Basis of accounting

The accounts of the Plan are maintained on the cash basis of accounting. For financial reporting purposes, however, the financial statements have been prepared on the accrual basis of accounting using information provided by the Trustee and present the net assets available for Plan benefits and changes in those net assets at current values. The difference between the current value and the cost of the investments is reflected in the statement of changes in net assets available for Plan benefits as appreciation (depreciation) in fair value of investments.

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Fair value of financial instruments

Unless otherwise indicated, the fair value of all reported assets and liabilities that represent financial instruments (none of which are held for trading purposes) approximates the carrying value of such amounts.

Concentration of credit risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of investments, which are subject to market fluctuations. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investments

All contributions to the Plan are invested with American Funds Service Company, a transfer agent, in certain US mutual funds and CIT's. Plan participants direct the investment of their contributions into any of the investment options offered by the Plan, and can change their investments at any time. The Plan currently offers various mutual funds as investment options for participants.

Related party transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such person.

Certain Plan investments are shares in funds managed by the Plan's custodian which is a party-in-interest. At December 31, 2022 and 2021, the Plan had investments in related funds of \$-0- and \$22,003 respectively.

Tax status

The Plan has not received a determination letter from the IRS. However, the Plan relies on the latest determination letter for the CCH Incorporated DBA fwilliam.com Pre-Approved Profit Sharing Plan document dated June 30, 2020, in which the Internal Revenue Service stated that the CCH Incorporated DBA fwilliam.com Plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code Section 401. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt. The Pacific Orchard Development, Inc. 401(k) Profit Sharing Plan H – L files an annual information return/report (Form 5500) with the Internal Revenue Service under the tax-exempt status allowed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2019.

Information certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's Trustee has certified that the following data included in the accompanying financial statements is complete and accurate: (a) investments as shown in the statements of net assets available for plan benefits as of December 31, 2022 and 2021, and (b) investment income (loss) as shown in the statement of changes in net assets available for plan benefits for the year ended December 31, 2022. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 3 - Investments:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses the appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Level 1 fair value measurements: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission.
