Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Easter Seals Hawaii 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Easter Seals Hawaii 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Easter Seals Hawaii 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Easter Seals Hawaii 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2022 and 2021

1. Description of the Plan

A description of the Easter Seals Hawaii 401(K) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for vesting and benefit provisions and for more complete information concerning the Plan.

General – The Plan covers substantially all employees of Easter Seals Hawaii (Organization) that were employed as of the inception of the Plan on May 1, 2003. Employees hired after May 1, 2003, are eligible to participate after completing one hour of service within a six-month period from date of hire and are at least 21 years of age. Employees become eligible for employer match and profit sharing contributions after one year of service in which at least 1,000 hours were worked and if they were employed as of the plan year end. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan provides for a plan administrator who is responsible for keeping accurate and complete records with regard to the Plan and operations, informing participants of changes or amendments to the Plan, ensuring that the Plan conforms to the law and to government regulations, and providing participants with any reports and documents required by law.

Contributions – Eligible participants may make voluntary contributions to the Plan of up to 100 percent of their eligible compensation subject to certain limitations. Such contributions are non-forfeitable and are credited to the individual account of the participant. Employer match contribution rates and profit sharing contributions are determined annually at the discretion of the Organization’s Board of Directors. Annual employer profit sharing contributions are allocated to each participant in proportion to their compensation. During 2022 and 2021, the Organization provided matching contributions of approximately \$65,000 and \$81,000, respectively. In addition, there were no profit sharing contributions to the plan during 2022 and 2021.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Organization’s contributions and (b) Plan earnings. The forfeited, non-vested accounts are used to reduce future employer contributions. The assets of the Plan are valued at the end of each plan year and any gains or losses are allocated among the participants’ accounts in proportion to each participant’s interest in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of the Plan, continued

Vesting – Participants are immediately vested in their voluntary and rollover contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested upon participation in the Plan for the elective deferrals and safe-harbor match contributions. Employer’s matching and profit sharing contributions are 100% vested after five years of service except upon death or disability, in which case, the contributions immediately become fully vested.

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum distribution of his/her entire vested account balance, or a single sum distribution of a portion of his/her vested account balance. If a participant’s account balance is less than \$5,000 but greater than or equal to \$1,000 upon termination of service, and the participant fails to elect a lump-sum cash out or rollover into another qualified plan, a distribution of the participant’s account will be automatically rolled over into an individual retirement account that is designated by the plan administrator.

Forfeitures – The nonvested portion of participants’ accounts, as defined by the Plan, is utilized to reduce plan expenses or to reduce any matching contribution. At December 31, 2022, there was no balance in the forfeited account. At December 31, 2021, forfeited nonvested accounts totaled approximately \$4,000.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting – The statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

2. Summary of Significant Accounting Policies, continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions – Participant, safe-harbor, and employer match contributions are recorded by the Plan in the period in which the Organization makes payroll deductions from the participants' earnings. Employer profit sharing contributions are recorded when approved by the Organization's Board of Directors.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of Plan assets at the date of the financial statements. Actual results could differ from those estimates.

Subsequent Events – The Plan's management has considered subsequent events through the date of the independent auditors' report, which is the date the financial statements were available to be issued.

3. Information Certified by the Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator obtained a certification from the custodian of the Plan that all information provided by the custodian is complete and accurate. Information included in the accompanying financial statements as to investment assets, transactions and income, is presented solely in reliance upon the certification.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's investments are held in mutual funds which are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and therefore are measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

5. Related-Party Transactions and Party In Interest Transactions

Capital Bank and Trust Company (CB&T) is the custodian of the Plan and invests in units of mutual funds managed by American Funds (AF). CB&T and AF transactions qualify as party in interest transactions.

6. Plan Termination

In June 2022, the Retirement Plan Committee voted to terminate the Plan and cease all participant and employer contributions effective September 30, 2022. During 2022, the plan assets were either transferred into the Organization's parent entity's retirement plan, Catalight Foundation 403(b) Plan, or distributed to plan participants.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

8. Tax Status

The prototype plan sponsor has obtained an opinion letter dated March 31, 2008, in which the Internal Revenue Service (IRS) stated that the prototype document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the IRS determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operates in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Reconciliation of Financial Statements to Schedule H of Form 5500

Schedule H of the Form 5500, reports \$6,245,655 of benefit payments to participants. This amount includes \$898,629 of participant funds transferred into Catalight Foundation's 403b as discussed in Note 6. This transfer is reported in the 2022 Statement of Changes in Net Assets Available for Benefits as an adjustment to net assets available for benefits.
