Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Barrons Enterprises, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis (in Liquidation) as of June 6, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits – modified cash basis (in Liquidation) for the period ended June 6, 2022 and year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended June 6, 2022, and as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Barrons Enterprises, Inc. 401(k) Profit Sharing Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Barrons Enterprises, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) adopted on January 1, 2002. It covers all non-union full-time employees of Barrons Enterprises, Inc. who have completed six months of service. The Plan entry date is the first day of the following month after completing the eligibility requirements. Eligibility for the Company discretionary nonelective contributions is based on whether an employee is an active participant on the last day of the year and has completed 1,000 or more hours of service in the plan year.

The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

As described in Note 7 to the financial statements, Barrons Enterprises, Inc., the plan sponsor, sold its business on December 1, 2021, and the governing body of the Plan approved the termination of the Plan effective December 1, 2021.

Contributions

Participants may contribute on a pre-tax or after-tax basis up to 100% of their annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and a guaranteed investment contract as investment options for participants.

The Plan includes an auto-enrollment provision whereby all eligible employees are auto-enrolled in the Plan, with a default pre-tax deferral rate set at 1% of eligible compensation and will increase each year (on January 1st) by 1%, up to a maximum of 4%, unless they affirmatively elect not to participate in the plan. These contributions are invested in a designated investment until changed by the participant.

The Company provides a matching contribution for all eligible employees, equal to 25% of participants' contributions up to 4% of their eligible compensation. The Plan also allows for employer discretionary nonelective contribution at the option of the Company's Board of Directors. Any discretionary nonelective contribution to the Plan are determined by the Company on an annual basis and are allocated based on a participant's eligible compensation relative to total compensation of all eligible participants. The Company's matching and discretionary contributions totaled \$0 and \$269,627 for the period ended June 6, 2022 and for the year ended December 31, 2021, respectively.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contribution and allocations of the Company's contributions, if any, and Plan earnings, and charged with an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals and rollovers, plus actual earnings thereon. Vesting in the company's matching and discretionary contributions is based on years of continuous service. After two years of service, a participant becomes 20 percent vested in the Company contributions to the Plan; the vesting percentage increases by 20 percent each year until the participant becomes fully vested in his or her account after six years of service.

All participants became fully vested in the Company's contributions on the Plan termination date of November 30, 2021 (refer to Note 7).

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 (reduced by the balance of any prior loans from the Plan) or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The maximum duration of a loan is not to exceed five years, except in cases where funds are used to purchase a principal residence. Plan participants may be granted five loans during any one-year period, but may have only one loan outstanding at any one time. Principal and interest are paid ratably through payroll deductions. There were no outstanding loans at June 6, 2022. The interest rates of the outstanding loans as of December 31, 2021 ranged from 4.25% to 6.50%.

Payment of Benefits

Upon retirement, death, disability, or termination of employment, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in the form of a lump sum payment, a direct rollover into a qualified retirement plan, a distribution in the form of an installments, or a combination of methods. Hardship distributions and in-service withdrawals at age 59 1/2 are also permitted, subject to the provisions described in the Plan document. Hardship withdrawals are subject to specific statutory and regulatory requirements.

Forfeited Accounts

Forfeitures may be used to pay plan expenses or reduce employer matching contributions at the discretion of the Company. During the year ended December 31, 2021, forfeitures of nonvested accounts in the amount of \$185 were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the Plan termination effective November 30, 2021, the 2022 and 2021 financial statements are prepared on a liquidation basis of accounting. The financial statements for both years have been prepared on the modified cash basis of accounting, which differs from accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting utilized, the Plan does not recognize employer or employee contributions receivable and the respective contributions are recognized when received.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value equals the accumulated cash contributions and interest credited to the Plan's contract. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of June 6, 2022 and December 31, 2021, no allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be either paid out of the Plan or paid directly by the Company. Plan expenses paid by the Company are excluded from these financial statements. The Plan is not required to reimburse the Company for expenses paid on behalf of the Plan. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

Use of Estimates

The preparation of the financial statements in conformity with the modified cash basis requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates. In particular, the novel coronavirus ("COVID-19") pandemic and the resulting adverse impacts to global economic conditions, as well as the Plan's operations, may affect future estimates including, but not limited to, fair value measurements, downward adjustments to investments in equity securities or asset impairment charges.

NOTE 3 - CERTIFIED INFORMATION

Information regarding investments and notes receivable from participants held at June 6, 2022 and December 31, 2021, and net appreciation (depreciation) in fair value of investments, and interest and dividend income for the period ended June 6, 2022 and for the year ended December 31, 2021, disclosed in the accompanying financial statements, and the investment information included in the supplemental schedule of assets (held at end of year) as of June 6, 2022, is derived from statements which have been certified by Principal Life Insurance Company and Principal Trust Company (collectively Principal), the custodian of the Plan, as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority.

Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds

Mutual Funds represent investments with various investment managers. The mutual funds are valued at the daily closing net asset value (NAV) as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSA)

The PSA invest mainly in domestic stocks and mutual funds which have observable level 1 quoted pricing inputs. The NAV of the PSA is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, those investments are considered to have a readily determinable fair value, which is represented by a unit of account whose per unit value is the result of the accumulated values of the underlying investments.

The Plan liquidated all assets during 2022 and as such held no investments at June 6, 2022.

NOTE 5 - GUARANTEED INTEREST CONTRACT

The Plan has a fully benefit-responsive investment contract (FBRIC) with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The FBRIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The FBRIC is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer. The crediting rate is currently reset on a semiannual basis and will not be less than the guaranteed minimum interest rate.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The FBRIC is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value (i.e., no market value adjustments or surrender charge adjustments) for withdrawals due to retirement, termination of employment, disability, loans, plan termination, death, or other participant-directed transfers. A plan fiduciary-directed surrender or transfer will be subject to 12 months' advance notice or a 5% surrender charge (subject to additional contractual limitations), whichever the plan sponsor chooses.

Certain events limit the ability of the Plan to transact at account value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Effective November 30, 2021, management made the decision to terminate the plan. The payment plan outlined above would continue after the plan termination and transfer of the affected participant accounts.

NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's investments are managed by Principal. Therefore, the transactions in these funds qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the plan.

There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and the accounts will be distributed in accordance with the Plan agreement.

On November 30, 2021, Barrons Enterprises, Inc. was sold to an unrelated company and the governing body of the Plan approved the termination of the Plan effective November 30, 2021, and adopted a plan of liquidation on December 1, 2021. On December 1, 2021, the plan sponsor informed Principal that contributions to the plan would cease effective December 1, 2021. This was also communicated to all active participants in the Plan. The plan sponsor has completed an automatic rollover agreement with Principal to distribute participant accounts according to the terms of the plan document. Final distributions will be determined based on all participants being 100% vested and will be made as soon as possible after the termination date of November 30, 2021. Participants will receive a lump sum payment from the plan and may elect to have their lump sum payment rolled over to another tax-qualified plan or into an Individual Retirement Account (IRA). At the time of Plan termination, Plan participants who have outstanding loans must either repay the unpaid balances on such loans, or the unpaid balances will be considered a distribution and may be subject to income taxes. All plan assets were distributed as of June 6, 2022.

NOTE 8 - TAX STATUS

The Plan has adopted a prototype non-standardized profit sharing plan sponsored by Principal. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, which states that the prototype profit sharing plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - LATE REMITTANCES

As a result of an oversight that occurred in December 2021, the Company failed to remit to the plan's custodian two participant loan repayments totaling \$3,821, within the period prescribed by Department of Labor regulations. These loan repayments are considered nonexempt party-in-interest transactions. The errors were identified subsequent to December 31, 2021. Lost earnings on the delinquent remittances was approximately \$10. The Company was unable to make a contribution to the affected participants accounts as by the time the error was identified all plan assets were distributed.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The COVID-19 pandemic, whose effects first became known in January 2020, had a broad and negative impact on commerce and financial markets around the world, leading to economic uncertainties and significant volatility in the investment markets. The resulting substantial fluctuations in the value of the Plan's investments may continue for an extended period of time.

NOTE 11 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 13, 2023, which is the date the financial statements are available to be issued.
