NOTE A—DESCRIPTION OF PLAN

The following description of Orthopaedic Associates of Muskegon, PC Cash Balance Plan (Plan) provides only general information. For a more complete description of the Plan's provisions, refer to the agreement governing the Plan (Plan Document).

General

The Plan was established on January 1, 2016 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. The Plan is a noncontributory cash balance plan covering substantially all employees of Orthopaedic Associates of Muskegon, PC and certain employees of Yousif I. Hamati, MD, PLC and Muskegon SC, LLC who have one year of service and are age 21 or older.

The Plan is sponsored and administered by the Company. The assets of the Plan are held by Voya Institutional Trust Company (Trustee).

Tax Status

While the Plan has not received an IRS determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC) and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a governmental authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Plan Termination

The Company has the right under the Plan to discontinue its contributions after three years from inception and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. See Note C on further information regarding the Plan termination as of December 31, 2021.

Funding

Each year, the Plan Sponsor is required to contribute an amount to the Plan that is actuarially determined. The amount of contribution may vary from year to year, depending on, for example, participant turnover, benefit payments, and investment gains or losses of the trust fund. If the Plan Sponsor fails to meet minimum funding requirements, it can be subject to penalties, benefit payments may be restricted, and certain notices to the participants may need to be provided.

Participant Accounts

A hypothetical account is maintained for each participant. All participants are categorized into groups. The hypothetical allocation amount is based on the group and ranges from 0% - 140% of the determination period compensation. Hypothetical allocations and interest credits are credited to the participant's account for the benefit of the individual. There were no hypothetical allocation amounts for the year ended December 31, 2022, as the Plan was terminated effective December 31, 2021 and benefits were frozen as of that date. See Note C for further information regarding the Plan termination.

Vesting

A participant is 100 percent vested after three years of credited service or upon termination of the Plan.

Benefits

The accrued benefit payable upon death, disability or retirement is equal to the greater of a) the balance of the participant's hypothetical account or b) if the Plan is top-heavy, the amount of any top-heavy minimum benefit. There are limits on the amount of benefits that can be paid. In general, the maximum annual benefit that can be paid may not exceed the lesser of 100% of a participant's average compensation or \$220,000 for the Plan year beginning in 2018. A participant will attain normal retirement age at 65 years old. If a participant terminates employment for reasons other than those listed above, the participant is entitled to receive only the vested percentage of the accrued benefit.

Forfeitures

When certain terminations of participation of the Plan occur, the nonvested portion of the participant's accrued benefit, as defined by the Plan, represents a forfeiture. The non-vested portion of an accrued benefit will be forfeited on the earlier of the distribution of a vested accrued benefit or once five consecutive one-year breaks in service have incurred. Forfeitures do not get applied to future obligations nor do they affect the hypothetical accounts of other participants. The hypothetical account for a participant with a forfeiture ceases to exist.

NOTE B—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the benefit-responsive traditional guaranteed investment contract which is valued at contract value (Note F). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisor/bank trustees. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to a) retired or terminated employees or their beneficiaries, b) beneficiaries of employees who have died, and c) present employees or their beneficiaries. Benefits payable under all circumstances are included to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits under the Plan are based on the participant's hypothetical account balance.

The actuarial present value of accumulated plan benefits is determined by the Plan actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death or retirement) between the valuation date and the expected date of payment.

NOTE C—PLAN TERMINATION

Effective December 31, 2021, the Plan was terminated. Benefits were accrued through December 31, 2021 and were considered to be fully vested for all participants. No additional valuation or hypothetical allocations were performed or awarded subsequent to the termination date. During the Plan year ended December 31, 2022, the assets of the Plan were allocated for payment of Plan benefits to the participants in order of priority determined in accordance with ERISA, applicable regulations thereunder, and the Plan document.

NOTE D—INVESTMENTS

Information Certified by the Plan's Trustees

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Institutional Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, the schedule of assets (held at end of year) as of December 31, 2022, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021.

NOTE E—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

Pooled separate accounts: Valued based on the accumulation unit values which are determined daily based on the net asset values of the underlying mutual fund shares, dividends on those mutual funds and separate account charges.

NOTE F—TRADITIONAL GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANY

In 2021, the Plan entered into a benefit-responsive traditional guaranteed investment contract with Voya Insurance and Annuity Company (Voya) for the Voya Fixed Account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the traditional guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the traditional guaranteed investment contracts. The traditional guaranteed investment contracts are presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2022 and 2021 was \$2,954 and \$6,079,865, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, as amended. The Plan administrator does not believe that any events that that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

NOTE G—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term.

Plan contributions are made and the actuarial present value of accumulated plan benefits reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE H—PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. Certain Plan investments are investment contracts managed by Voya Institutional Trust Company (trustee) and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than direct payment.
