### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Great Lakes Coca-Cola Distribution Union 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years then ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Plan Merger**

As disclosed in Note 1 to the financial statements, the Plan merged into the Reyes Holdings Retirement Plan effective December 1, 2022. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF THE PLAN**

The following description of the Great Lakes Coca-Cola Distribution Union 401(k) Plan (the “Plan”) is provided for general information purposes only. Users of these financial statements should refer to the plan document for more complete information.

**General**— The Plan is a defined contribution plan established in June 2015 by Reyes Holdings, L.L.C. (“Reyes”) for all eligible employees covered by a collective bargaining agreement (“CBA”) between Great Lakes Coca-Cola Distribution, L.L.C. (the “Company”) and International Brotherhood of Teamsters Local 330 or Local 727, (“Local 330 or 727”) and any subsidiary or affiliate which is a member of its related group as defined in the plan document who have completed the necessary service requirements as defined within the plan document. Leased employees, residents of Puerto Rico, and other individuals who are classified as independent contractors are not eligible to participate in the Plan. The Plan includes former employees of Coca-Cola Refreshments USA, Inc. (“CCR”) that were hired beginning in 2015 as a result of various business acquisitions since May 29, 2015.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Employee Benefits and Retirement Plans Committee (the “Committee”) of the Company, which consists of various people appointed by the Company’s shareholders. John Hancock Trust Company LLC serves as the trustee of the Plan (“Trustee”).

**Plan merger and Transfers-** Effective August 23, 2021, the Plan was amended to cease eligibility to participate in the Plan for participants who are subject to collective bargaining agreements. This would include agreements between Great Lakes Coca-Cola Distribution, L.L.C. and the International Brotherhood of Teamsters Local 662 (Wausau); the Retail, Wholesale and Department Store Union Local 93/UFCW (Lansing); or the International Brotherhood of Teamsters Local 662 (Eau Claire). Instead, these participants would become eligible to actively participate in the Reyes Holdings Retirement (“Reyes Plan”). As a result, account balances of \$13,691,198 were transferred to the Reyes Plan.

Effective March 1, 2022, the Plan was amended to cease eligibility to participate in the Plan for participants who are subject to collective bargaining agreements. This would include agreements between Great Lakes Coca-Cola Distribution, L.L.C. and the International Brotherhood of Teamsters Local 344 (Milwaukee). Instead, these participants would become eligible to actively participate in the Reyes Plan. As a result, account balances of \$6,129,585 were transferred to the Reyes Plan.

Effective December 1, 2022, the Plan was amended to reflect the merger of the Plan into the Reyes Plan. As a result, account balances of \$701,553 were transferred to the Reyes Plan.

**Contributions**—Generally, participants may elect to contribute from 1% up to 100% of annual compensation on a pre or post tax basis, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover contributions”). The Company contributes an amount equal to 50% of the percentage contributed by the participant to a maximum matching contribution of the first 6% of compensation contributed as elective deferrals for eligible Local 330 participants. Effective January 1, 2018 the Company provides for supplemental employer matching contributions to eligible participants, as defined in the plan document, to receive their full eligible matching contributions for the Plan year. Company contributions are subject to the applicable limits of the IRC.

**Participant Accounts**—Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, and allocations of Company discretionary contributions and plan earnings or losses. Each participant’s account is charged with withdrawals, an allocation of plan earnings or losses, and administrative expenses. Allocations are based on participant earnings, specific participant transactions, or account balances, as defined within the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Notes Receivable from Participants**—A participant may borrow from their vested fund accounts an amount that shall not exceed the lesser of \$50,000 or one-half of their vested account balance. Loans are secured by the participant’s account and are repayable through quarterly, monthly, bi-weekly, or weekly payroll deductions over periods ranging up to 5 years or up to 15 years for the purchase of a primary residence. Terminated employees are required to repay loans in full in order to avoid the loan being deemed a distribution. A default will occur on the last day of the calendar quarter in which the loan repayment was due. Interest is assessed at rates commensurate with local prevailing rates at the time funds are borrowed equal to the Prime Rate. Loans were at interest rates ranging from 3.25% to 8.25% prior to the transfer of all outstanding notes receivables effective December 1, 2022 into the Reyes Plan. Principal and interest repayments are reinvested in the investment option(s) selected by the participant.

**Payment of Benefits**—Upon termination of service as a result of termination, retirement, death, or disability, the participant may elect to receive his or her full account balance or to defer distribution until a later date, but no later than age 70-1/2. A lump-sum payment, an annuity and monthly installment payments are optional forms of benefit payment available under the Plan.

Participants in service may make hardship withdrawals from their voluntary contributions upon demonstrating immediate financial need, as defined in the plan document. No withdrawals may be made from Company contributions. In-service withdrawals after attaining age 59-1/2 may be made to certain eligible active participants as defined in the plan document.

**Vesting of Benefits**—Participants are immediately vested in the Plan for their own contributions plus actual earnings thereon.

For Local 330 and 334 participants, Company matching contributions Company plus earnings thereon generally vest based on the following schedule:

If an employee became an employee of the Company on May 29, 2015 due to the Company's acquisition of a certain portion of CCR, past service will be counted for vesting purposes under the Plan.

***Forfeited Accounts***—At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$0 and \$15,416, respectively. The amount forfeited shall be used to pay Plan administrative expenses or used to reduce Company contributions under the Plan. All account balances must be used by the end of the following year. For the years ended December 31, 2022 and 2021, amounts used to offset administrative expenses were \$0 and \$2,750, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***—The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***— Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded as of the trade date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants*— Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. Interest income is recorded on an accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of both December 31, 2022 and 2021.

*Administrative Expenses*—The Company pays certain legal and accounting fees for the Plan. All other expenses in connection with the administration of the Plan are paid from plan assets as provided in the plan document. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

Plan administration fees cover the day-to-day expenses of administering the Plan, and may be charged directly to a participant's account, covered by a portion of the asset-based fees deducted directly from investment returns, or paid through revenue-sharing payments made from investment managers to the recordkeeper. The Company may, from time-to-time, change the manner in which expenses are allocated.

*Payment of Benefits*—Benefit payments to participants are recorded when paid. As of December 31, 2022, the Plan had no pending distributions to participants who elected to withdraw from the Plan.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

The Plan's interests in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The collective trust fund is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**4. INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA for the years ended December 31, 2022 and 2021. Accordingly, the Trustee of the Plan has certified to the completeness and accuracy of all investments reported in the accompanying statement of net assets available for benefits as of December 31, 2022 and 2021, and the related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021.

**5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds investments in the Reyes Capital Preservation Fund, which is a synthetic guaranteed investment contract ("GIC") issued by the Prudential Insurance Company of America ("Prudential"). The underlying financial instrument, the Prudential Stable Value fund, is 100% invested in the Prudential Core Conservative Bond, a collective trust. To enable the Plan to realize a specific known value for the assets if it needs to liquidate them to make benefit payments, synthetic GICs utilize a benefit-responsive wrapper contracts. The wrapper contract is issued by Prudential, and does not have a separate value associated with it. The synthetic contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the synthetic investment contract at December 31, 2022 and 2021 were \$0 and \$1,273,400, respectively.

The wrapper contract provides a guarantee that the credit rate will not fall below zero percent. Cash flow volatility (for example, timing of the benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in the contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed quarterly for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Participant-directed redemptions from the Reyes Capital Preservation Fund are made at contract value and have no restrictions. The Plan may terminate the synthetic GIC contract at any time by giving 30 days' notice to Prudential. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract.

Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts

3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**6. ADMINISTRATION OF PLAN ASSETS**

The Plan's assets were administered under a contract with the Trustee of the Plan. The Trustee invests funds received from contributions, investment sales, interest, and dividend income and makes distribution payments to participants.

**7. RELATED-PARTY AND PARTIES IN INTEREST TRANSACTIONS**

Certain investments held by the Plan are invested and maintained by the Trustee and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation or depreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Trustee also performed administrative and recordkeeping services for the Plan. The fees for these services paid by the Plan were \$13,500 and \$23,272 for the years ended December 31, 2022 and 2021, respectively. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain employees of the Company provide administrative services to the Plan. Neither these employees nor officers of Reyes and the Company receive compensation from the Plan for their services. Certain other administrative expenses are paid by the Company on behalf of the Plan.

**8. PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants would become fully vested in their accounts.

**9. FEDERAL INCOME TAX STATUS**

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated February 27, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan holds certain investments that represent 10% or more of the Plan's net assets available for benefits. The Plan held no investments as of December 31, 2022. As of December 31, 2021, the Plan had investments of \$3,364,017 that were concentrated in two funds.
