We have performed audits of the financial statements of the Covercraft Industries, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is accurate and complete to the best of their knowledge.

#### Note 1. Description of Plan

The following description of the Covercraft Industries, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information.

**General:** The Plan is a defined contribution plan sponsored by Covercraft Industries, LLC (the Company) covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA). The Company has appointed BOK Financial, N.A. (BOK) to be the trustee and BOK manages the Plan's certified investments. Plan management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility:** Employees are generally eligible to participate in the Plan after attaining the age of 21 and completing three months of service.

**Contributions:** Participants may make voluntary contributions to the Plan of a minimum of 1% of their compensation and a maximum subject to the annual limitations imposed by the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled employees have their deferral rate set at 1% of eligible compensation. Employees may elect to change or discontinue deferrals at any time. Plan participants age 50 and older are eligible to make additional catch-up contributions to the Plan. Rollover contributions are permitted under the Plan agreement.

The Company may make discretionary matching contributions each quarter to eligible participants who are employed on the last day of the quarter. During the year ended December 31, 2022, the Company made quarterly discretionary matching contributions equal to 100% of eligible participants' deferrals of 1%.

Annually, the Company may make a discretionary nonelective contribution. This contribution is allocated based on eligible compensation of all Plan participants that completed 1,000 hours of service in the Plan year and are employed at the end of the Plan year. No such contribution was made during the year ended December 31, 2022.

**Investment options:** Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

**Participant accounts:** Each participant's account is credited with the participant's contributions and Company contributions and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is limited to that benefit which can be provided from the participant's vested account balance.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Company contributions and earnings thereon vest ratably at 20% per year of service. Participants are 100% vested after 5 years of service or due to death or permanent disability, while an employee.

**Forfeitures:** Amounts forfeited by reason of termination or severance of employment prior to full vesting are used to fund Company contributions or to pay Plan expenses. At December 31, 2022 and 2021, there were approximately \$1,800 and \$2,500, respectively, remaining in the forfeitures account to be used to fund or pay the aforementioned items. Approximately \$12,500 of forfeitures were used during the year ended December 31, 2022, to pay Plan expenses.

#### Note 1. Description of Plan (Continued)

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at a rate of national prime plus 1%. Loan terms may not extend past five years, except for loans made for the purpose of the participant purchasing their primary residence, which can be up to 15 years. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:** On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of his or her vested account balance. In certain circumstances, participants may make hardship withdrawals as defined in the Plan. In-service distributions are permitted by active participants who have attained the age of 59½ and by participant's who qualify for hardship distributions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of estimates:** The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Agreement.

Notes receivable from participants have been classified as an investment asset for Form 5500, *Annual Return/Report of Employee Benefit Plans*, reporting purposes and, accordingly, have been included as an investment in supplemental Schedule H, line 4i—schedule of assets (held at end of year).

**Benefits paid to participants:** Benefits are recorded when paid.

**Administrative expenses:** Certain administrative expenses of the Plan are paid by the Company, and others are paid by the Plan. Administrative expenses that are paid by the Company are excluded from these financial statements. In addition, certain investment-related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent events:** Management has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued.

BOK also certified the completeness and accuracy of \$2,114,809 of net depreciation in fair value of the investments, \$83,654 of interest and dividends related to the aforementioned investments and \$20,067 of interest income on notes receivable from participants for the year ended December 31, 2022.

#### Note 4. Fair Value Measurements

Accounting standards established the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under accounting standards are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### Note 4. Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used between December 31, 2022 and 2021.

**Mutual funds:** Certain of the Plan's investments are maintained in mutual funds, the fair values of which are based on quoted prices available in an active market.

**Collective trust funds:** Collective trust funds are valued at the net asset value (NAV), as reported by the investment advisor using the audited financial statements of the fund at year-end. The fund's underlying assets are generally U.S. equities or mutual funds. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5. Income Tax Status

The Plan has adopted a non-standardized pre-approved plan sponsored by BOKF, NA. BOKF, NA has received a determination letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the pre-approved plan received the determination letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6. Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants would become 100% vested in their accounts.

#### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2022 statement of net assets available for benefits.

#### Note 8. Related-Party Transactions and Party-in-Interest Transactions

Parties-in-interest are defined under the Department of Labor's Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, transactions conducted by the Company and BOK, the Plan's trustee, qualify as party-in-interest transactions.

The Plan also holds investments in Cavanal Hill Cash Management funds. The funds are managed by Cavanal Hill Investment Management, Inc., a wholly owned subsidiary of BOK and, therefore, transactions in those funds qualify as party-in-interest transactions.
