### Report on the Audit of the Financial Statements



**NOTE 1 DESCRIPTION OF PLAN**

The following description of Seminole Hard Rock Support Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan qualifying under Section 401(k) of the Internal Revenue Code (IRC). The Plan was originally effective January 1, 2018 and most recently amended and restated June 1, 2022. The sponsor of the Plan is Seminole Hard Rock Support Services, LLC, which is ultimately controlled by Seminole Tribe of Florida (the Tribe). The Tribe is a sovereign Indian tribe, and the Plan is subject to the reporting provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Merger**

Effective October 5, 2022, Seminole Hard Rock Support Services, LLC 401(k) Plan merged into the Hard Rock FutureCare 401(k) Plan, and all participants of the Seminole Hard Rock Support Services, LLC 401(k) Plan were eligible to participate in the Hard Rock Futurecare 401(k) Plan upon the merger date. Plan assets as of October 5, 2022 in the amount of \$16,099,421 were transferred directly to the Hard Rock Futurecare 401(k) Plan.

**Eligibility**

An employee becomes an eligible participant in the Plan immediately upon employment. Participating employees will be eligible for employer matching contributions and nonelective contributions, if any, after the participant completes one year of service, given 1,000 hours of service have been credited. Part-Time/Temporary/Seasonal employees may enter the Plan once they meet the age eligibility requirement and complete 1,000 hours of service during the year following the employment commencement date. Participants must complete one year of service based on the elapsed time method. For the purposes of matching contributions and nonelective contributions, if any, participants' enter the Plan on the first date of each quarter following the date on which they meet the eligibility requirements.

**Allowable Investments**

When a participant becomes eligible to participate in the Plan, they may select from a variety of professionally managed investment funds.

**Participant Contributions**

An employee participating in the Plan may elect to contribute up to 80% of annual compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. The Plan also includes an automatic escalation feature where by deferrals increase by 1% each year up to a maximum of 15% of eligible compensation. Any participant, age 50 or over, may make an additional catch-up contribution as determined by the Internal Revenue Service (IRS).

**Participant Contributions (Continued)**

Participants may also contribute post tax Roth amounts and amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

A participant may suspend contributions or may increase or decrease their level of participation in the Plan at any point in time. Contributions are subject to certain IRS limitations.

**Employer Contributions**

Support Services may contribute to the Plan, on behalf of the participants, a discretionary matching contribution based on participants' deferrals contributed to the Plan or a discretionary nonelective contribution. Catch-up contributions are not matched by Support Services. For the period January 1, 2022 to October 05, 2022, Support Services contributed a matching contribution equal to 25% of the participant's contribution, up to the first 16% of eligible compensation. No nonelective contributions were authorized or paid for the period ended October 05, 2022.

**Participant Accounts**

Individual accounts are established for each participant. The Plan offers a variety of mutual funds and collective funds with varying investment objectives as investment options. Participants may change their investment options at any time. Each participant's account is credited with the participant's contributions, the employer matching contributions, and the proportionate share of Plan earnings since the preceding valuation date. Each participant's account is reduced by withdrawals, losses on investments, any forfeitures and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in all salary deferral contributions and in all employer matching and nonelective contributions once they are actually made, plus actual earnings thereon.

**Benefit Payments**

At termination, the participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account under several options, including lump sum, rollover distribution, or annuity. In the event that the participant's vested accrued benefit is less than \$5,000, the Plan administrator may make a distribution without the election or request of a terminated participant. The Plan requires that such distributions of amounts less than \$5,000 but greater than \$1,000 be rolled over to an individual retirement account unless the participant elects to receive the distribution directly. The Plan also allows for in-service distributions for serious financial hardship such as certain expenses for medical care, the purchase of a primary residence, and tuition payments.

**Notes Receivable from Participants**

Participants are able to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable may be repaid over a period of up to five years, however the repayment period may be set for a term that will extend up to 15 years for the purchase of a primary residence.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

The financial statements of the Plan for the period ended October 05, 2022 and the year ended December 31, 2021 have been prepared in accordance with accounting principles generally accepted in the United States of America as applied to governmental units, using the accrual method of accounting. The Governmental Accounting Standards Board (GASB) is the accepted standards setting body for establishing governmental accounting and financial reporting principles.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

All expenses, except for account maintenance fees, transactions fees, and investment fund management fees have been paid by Support Services, and are excluded from these financial statements. Participants are charged for service fees for any loan and distribution transactions they request which are included in administrative expense.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of the October 05, 2022 and December 31, 2021. Delinquent notes receivable are recorded as distributions based on the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through October 11, 2023, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

State Street Bank and Trust Company, Massachusetts Fidelity Trust Company, and Transamerica Life Insurance Company, the qualified institutions, have supplied the Plan administrator with certifications as to the completeness and accuracy of notes receivable from participants and all investment information reflected on the accompanying statements of fiduciary net position as of October 05, 2022 and December 31, 2021, and the statement of changes in fiduciary net position for the period January 1, 2022 to October 5, 2022.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

GASB 72 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There were no investments at October 5, 2022, due to the transfer of assets to HardRock Futurecare 401(k) Plan (see Note 1).

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021:

*Mutual Funds/Money Market Fund* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Funds* – Valued at the NAV of units as determined by the bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective fund, the issuer reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner. Therefore, they are valued at Level 2.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

In 2021, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company (TRS). TRS maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semi-annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TRS, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer. The contract was terminated as of October 5, 2022, as a result of the plan merger to other plan. There was no adjustment to contract value.

**NOTE 6 INVESTMENTS**

Investment securities are exposed to various risks that can affect the value of the Plan's investments such as custodial risk, interest rate risk, credit risk, concentration risk, and foreign currency risk. The Plan invests in registered investment companies (mutual funds and money market funds) and collective funds. Mutual funds and money market funds with holdings in equity securities respond to such factors as economic conditions, individual company earnings performance, and market liquidity, which holdings in debt securities are particularly sensitive to credit risk and changes in interest rates. Since all investments are participant directed, risks exists at the participant level.

Custodial Credit Risk – Custodial credit risk is the risk that in the event of a failure by the counterparty, the Plan will not be able to recover the value of its investments that are in the possession of an outside party. The Plan’s policies do not specifically address custodial credit risk, but all of the Plan’s investments are held by the Plan or its agent in the Plan’s name.

Foreign Currency Risk – Foreign currency risk is the risk that changes in exchange rates will adversely impact the fair value of an investment denominated in a foreign currency. The Plan does not hold any direct investment or instruments denominated in foreign currency.

The Plan’s foreign currency risk exposure resides within the following mutual fund holdings at December 31, 2021 (there were none at October 5, 2022 due to the transfer of assets to HardRock Futurecare 401(k) Plan, see Note 1):

Interest Rate Risk – Interest rate risk arises from the likelihood that interest rates will rise or fall during the holding period of a fixed rate security and adversely affect the selling price of the security prior to maturity. The price of a debt security typically moves in the opposite direction of the change in interest rates.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of fiduciary net position.

**NOTE 8 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letters. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds managed by Transamerica Retirement Solutions, LLC on behalf of State Street Bank and Trust Company and Massachusetts Fidelity Trust Company. Transamerica Retirement Solutions, LLC on behalf of State Street Bank and Trust Company is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
