### Note 1: Description of the Plan

The following description of Cheetah Digital Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

#### **General**

The Plan was created on July 15, 2017 and was a defined-contribution plan sponsored by Cheetah Digital, Inc. (Company) for all employees with one month of service. Wayin, Inc. was a participating employer of the Plan. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Ascensus Trust Company (Ascensus Trust) served as the Plan trustee. Vanguard Retirement Plan Services, a division of Vanguard Group, Inc., in conjunction with Ascensus, Inc. was the Plan's recordkeeper.

During February 2022, the Company merged with Marigold (fka CM Group) and the Plan merged into the CM Group 401(k) Plan in January 2023. The employees of the Company became participants of the CM Group 401(k) Plan effective January 1, 2023. The Plan transfer initiated a blackout period beginning January 20, 2023. During this period, participants were unable to direct or withdrawal the assets held in their accounts. Final transfer of Plan assets occurred on January 27, 2023. The December 31, 2022 employer contribution receivable will be deposited to the CM Group 401(k) Plan.

#### **Contributions**

The Plan permitted eligible employees through a salary deferral election to have the Company make contributions of up to 50% of eligible compensation, each payroll period, up to the maximum allowed by law. Employee rollover and Roth contributions were allowed by the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

Company matching contributions were safe harbor matching contributions of 100% of participants' salary deferral on the first 4% of eligible compensation calculated annually. The Company could also make discretionary profit-sharing contributions as determined by the Company's Board of Directors for those employed on the last day of the Plan year unless terminated due to death, disability or normal retirement age. Contributions were subject to certain limitations.

#### **Participant Investment Account Options**

Investment account options available included various funds. Each participant had the option of directing their contributions into any of the separate investment accounts and could change the allocation daily.

### ***Participant Accounts***

Each participant's account was credited with the participant's contribution, the Company's contributions and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### ***Vesting***

Participants were immediately 100% vested in their voluntary contributions and Company contributions plus earnings thereon.

### ***Payment of Benefits***

Upon termination of service, a participant could elect to receive a lump-sum amount equal to the value of their account. Terminated participants with account balances less than \$1,000 would be automatically distributed for force-out rules provided by the Plan. In-service withdrawals were available under certain circumstances provided by the Plan.

### ***Forfeited Accounts***

During 2022 and 2021, corrections to contributions of approximately \$10,000 and \$18,000 were deposited into a suspense account, which were used to offset employer contributions. The December 31, 2022 and 2021 employer contribution receivable is net of prefunding of employer contributions of approximately \$45,000 and \$10,000, respectively.

### ***Notes Receivable From Participants***

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only two loans could be outstanding at a time. The loans were secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest were paid through periodic payroll deductions.

Notes receivable from participants were measured at their amortized principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

### ***Plan Termination***

The Plan was not terminated but was merged into CM Group 401(k) Plan in January 2023.

### Note 2: Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements were prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Valuation of Investments and Income Recognition***

Investments were reported at fair value. Quoted market prices, if available, were used to value investments. Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the common collective trust was valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end, which used NAV as the practical expedient. The investment objective was to preserve the value of money invested, perform better than the average money market fund and earn consistent, reliable returns. There were no redemption restrictions or unfunded commitments, and redemption frequency was daily.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Plan Tax Status***

The Plan operated under a nonstandardized adoption agreement in connection with a prototype retirement plan and custodial document sponsored by Ascensus, LLC, effective July 1, 2021, and Ascensus, Inc, prior to July 1, 2021. The Plan had not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype documents had received a favorable opinion letter from the IRS. The Plan had been amended since the prototypes received opinion letters. However, the Plan Administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

#### ***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

### **Administrative Expenses**

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion.

### **Note 3: Certification of Plan Trustee**

The Plan Administrator had elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust, a qualified institution, had certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules was complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of January 31, 2023, December 31, 2022 and 2021
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended January 31, 2023 and years ended December 31, 2022 and 2021
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

### **Note 4: Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There was a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There were no significant changes in the valuation techniques during the period ended January 31, 2023, and the year ended December 31, 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

### Investments

Where quoted market prices were available in an active market, securities were classified within Level 1 of the valuation hierarchy. Level 1 securities held by the Plan included mutual funds. Where quoted market prices were not available, fair values were estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows and were classified within Level 2. There were no Level 2 securities held by the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities were classified within Level 3 of the hierarchy. There were no Level 3 securities held by the Plan.

### Note 5: Party-in-Interest Transactions

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, an employee organization whose members were covered by the Plan, a person who owned 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invested in certain funds of the Plan's recordkeeper. The Plan paid recordkeeping fees to Vanguard Group, Inc. of \$54,032 and \$46,624 for the years ended December 31, 2022 and 2021, respectively

The Company provided certain administrative services at no cost to the Plan.

### Note 6: Nonexempt Transactions

Defined-contribution plans were required to remit employee contributions to the Plan as soon as they could be reasonably segregated from the employer's general assets. Participant contributions and loan repayments totaling \$2,388, \$81,820 and \$79,432 were not remitted within the required time period for the period ended January 31, 2023 and years ended December 31, 2022 and 2021. Amounts were deposited in 2022 and 2023.

### **Note 7: Reconciliation of Financial Statements to Form 5500**

The net assets available for benefits per the financial statements at December 31, 2022 include an employer contribution receivable that is not included on the Form 5500. This employer contribution receivable was deposited to the CM Group 401(k) Plan after the transfer of the Plan in January 2023.

### **Note 8: Subsequent Events**

Subsequent events had been evaluated through October 12, 2023, which was the date the financial statements were available to be issued.
