NOTE A DESCRIPTION OF PLAN

The following description of the Galvion LTD 401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering employees of the Company. There is no age or service requirement for elective deferral contributions. Employees must be over 21 for all other contributions and require 1 year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally adopted January 1, 2009.

Contributions

The employer may elect to make Qualified Nonelective contributions as selected in the Adoption Agreement. The amount of such contribution, if the Employer as will determine any, to the Plan for each plan year, described in the Plan document, subject to IRS dollar limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are vested in employer contributions at a rate of 20% per year starting after two years of service.

Payment of Benefits

On termination of service due to death or disability, a participant may elect to receive a lump sum in the same plan year in which the forfeiture occurs in the amount equal to the value of the participant's vested interest in their account, or annual installments.

Investment Valuation

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment contracts held by a defined contribution plan are required to be reported at fair value.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits

Benefits are recorded when paid.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Allowance for Doubtful Accounts

The plan considers allowance for doubtful accounts to be amounts that would not be collectible by the plan. All participant loans are secured by vested participant balances. Therefore, there is no allowance for doubtful accounts at December 31, 2022 and 2021.

NOTE D FAIR VALUE MEASUREMENTS

Fair value measurements establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under described below:

Basis of Fair Value Measurement

- Level 1- Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
  
- Level 2- Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly. (market approach)
  
- Level 3- Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table presents by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2022 and 2021. As required by ASC Topic 820, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

\* In accordance with Subtopic 820-10 (under ASU 2015-07), certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

*Pooled Separate Accounts:* Composed primarily of mutual funds. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Restrictions on redemption include the following:

- a. when the New York Stock Exchange is closed, or trading on the New York Stock Exchange is restricted;
- b. when an emergency exists and as a result of which (1) disposal of the securities held in the Sub-Accounts is not reasonably practicable, or (2) it is not reasonably practicable for the value of the net assets of the Separate Account to be fairly determined; or
- c. when the Securities and Exchange Commission may, by order, permit for the protection of Contract Owners. The conditions under which trading will be deemed to be restricted or emergency is deemed to exist is determined by rules and regulations of the Securities and Exchange Commission.

*Common/Collective Trusts:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Transfers resulting from employer-initiated events require 12 months' advance written notice to the Trustee for the fund. The Trustee for the fund may waive or reduce the 12-month requirement to the extent that the trustee for the fund determines that such waiver or reduction would not negatively impact the Fund or the Participating Trusts. Subject to limitations in the Trust Document for the fund, participants may make withdrawals to make bona fide benefit payments in accordance with the plan provisions, to direct their own investments, to make participant loans, and to pay fees.

Pooled separate accounts and common/collective trusts are not leveled. Assets held at fair value are valued using Net Asset Value per share as a practical expedient (\$1,725,968 and \$1,346,684 at December 31, 2022 and 2021, respectively).

NOTE E PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan at any time to terminate the Plan subject to the provisions of ERISA.

NOTE F TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Consideration has been given to uncertain tax positions. The federal income tax returns for the years ended after December 31, 2020, remain open for potential examination by the Department of Labor, generally for three years or, in cases of fraud or concealment, six years after the date they were filed.

NOTE G RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H ADMINISTRATIVE EXPENSES AND PARTY IN INTEREST TRANSACTION

The plan sponsor provides administrative services to the plan at no cost. Some administrative expenses were paid by the plan. During the year ended December 31, 2022 and 2021, the plan paid \$21,802 and \$18,095, respectively for third party administrative fees.

Certain plan investments are managed by Principal Trust Company investments. Principal Trust Company is the custodian for the plan and performs record-keeping services for the plan and therefore these transactions qualify as party in interest transactions. Principal Trust Company received indirect compensation for these services.

NOTE I PROHIBITED TRANSACTIONS

The DOL and the IRS require employers who sponsor defined contribution retirement plans to remit employee contributions as soon as administratively possible. During 2022 it was noted that the Plan's sponsor failed to remit employee contributions to the Plan within the required time frame. These failures constituted prohibited transactions. The Plan's sponsor will bear the cost of the lost earnings, IRS penalties and any liabilities that may arise from noncompliance issues with the Department of Labor.

NOTE K SUBSEQUENT EVENTS

The Company has evaluated subsequent events through October 13, 2023, which is the date these financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2022 and 2021, have been incorporated into these financial statements herein.
