We have performed audits of the financial statements of Partners Health Plan, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period January 1, 2022 through March 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of March 31, 2022 and December 31, 2021, and the period January 1, 2022 through March 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

As further discussed in Note 5 to the financial statements, the Board of Directors of the Plan Sponsor approved a plan of organizational transition, merger of the Plan assets into the Care Design NY 401(k) Plan (affiliate plan) sponsored by Care Design New York, LLC, Plan sponsor's affiliate under common ownership. As a result, Plan assets were transferred to the affiliate plan on March 31, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

1. Description of Plan

Partners Health Plan, Inc. (PHP) was organized in November 2012 as a tax-exempt not-for-profit corporation. PHP is a Health Maintenance Organization that was issued a Certificate of Authority by the New York State Department of Health in April 2016 to operate a Fully Integrated Duals Advantage program for Individuals with Developmental Disabilities (IDD) plan in the five boroughs of New York City and Nassau, Suffolk, Westchester, and Rockland counties. PHP provides medical and developmental disability coverage for Medicare and Medicaid qualified individuals with IDD. Partnerships for Healthcare Solutions, Inc. (Partnerships) is the sole member of PHP.

The following description of the Partners Health Plan, Inc. 401(k) Plan (the Plan) sponsored by PHP provides only general information. Participants should refer to the Plan agreement for a comprehensive description of the Plan's provisions.

General

The Plan was a participant-directed, defined contribution plan covering all full-time employees of PHP. Eligible employees were eligible to participate in the Plan on the first day of the month following date of hire. It is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

An employee could contribute by payroll deduction any of his or her pre-tax compensation up to the Internal Revenue Service (IRS) allowable limit of \$20,500 for the period January 1, 2022 through March 31, 2022 and \$19,500 for the year ended December 31, 2021, plus \$6,500 in catch-up contributions for those 50 years or older for the period January 1, 2022 through March 31, 2022 and the year ended December 31, 2021. PHP matched 50% of the employees' contributions for the first 6% of their gross compensation at year-end. PHP contributed the match for those participating in the plan each pay cycle during their term of employment.

Participant Accounts

Each participant's account was credited with the participant's contributions, PHP's contributions made on behalf of that employee, and the employee's proportionate share of Plan earnings or losses. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their salary reduction contributions and the earnings or losses thereon. PHP matching contributions and related earnings or losses on PHP contributions made to an employee's account were gradually vested with 20% after two years of service and 20% for each additional year of service up to 100% after six years of service.

Notes Receivable from Participants

Participants were able to obtain a maximum of two loans from the Plan, subject to various requirements set forth in the Plan, in cumulative amounts up to 50% of their vested account balance

with a maximum loan of \$50,000 and a minimum loan of \$500. The loans were secured by the balance in the participants' accounts and bore interest at a fixed rate determined at the time of issuance. Loan principal and interest payments were made through payroll deductions over a period of up to five years unless the loan was used for the purchase of a primary residence.

According to the Plan document, if a participant defaulted on the loan, the outstanding loan balance was deemed distributed. There were no loan defaults for the period January 1, 2022 through March 31, 2022.

Payment of Benefits

Participants were eligible to receive benefit payments when they terminated service or reach age 65. On termination of service, a participant was able to elect to receive a rollover or a lump-sum amount equal to the participant's account. Benefit payments were also permitted for death, disability, and hardship.

Forfeitures

Forfeitures of nonvested contributions and related earnings or losses were used to reduce employer contributions. As of March 31, 2022 and December 31, 2021, respectively, the Plan had \$0 of forfeitures available to offset future required contributions. There were no forfeited accounts used to satisfy required contributions for the period January 1, 2022 through March 31, 2022.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenue and expenses, as well as the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date (an exit price). Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that inputs that are most observable be used when available. Observable inputs are inputs that market participants operating within the same marketplace as the Plan would use in pricing the Plan's asset or liability based on independently derived and objectively determined market data. Unobservable inputs are inputs that cannot be sourced from a broad active market in which assets or liabilities identical or similar to those of the Plan are traded. The Plan estimates the price of any assets for which there are only unobservable inputs by using assumptions that market participants that have investments in the same or similar assets would use as determined by the money managers administering each investment based on the best information available in the circumstances. The input hierarchy is broken down into three levels based on the degree to which the exit price is independently observable or determinable, as follows:

Level 1 - Valuation was based on quoted market prices in active markets for identical assets or liabilities. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products did not entail a significant degree of judgment.

Level 2 - Valuation was based on quoted market prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly, or derived principally from or corroborated by observable market data. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Valuation was based on inputs that are unobservable and reflect management's best estimate of what market participants would use as fair value.

Common Collective Trusts

The common collective trusts (CCTs) were valued based on the net asset value (NAV) of the CCT. The NAV was used as a practical expedient to estimate fair value, and NAV is based on the fair value of the CCTs' underlying investments less liabilities. The CCTs primarily invest in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities and money market funds. The Plan's investment in the CCT could be redeemed immediately at the current NAV per share. There were no unfunded commitments as of March 31, 2022.

Mutual Funds

Mutual funds were valued at unadjusted quoted market prices which represent the NAV of the shares owned by the plan at year end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are included in Level 1 of the hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of March 31, 2022.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to participant contributions. There were no excess contributions for the period January 1, 2022 through March 31, 2022. The Plan distributed the excess contributions for the year ended December 31, 2021 in the amount of \$6,547 to the applicable participants on February 17, 2022.

Payment of Benefits

Benefits were recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Plan sponsor. Expenses that were paid by the Plan sponsor were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participants account and are included in administrative expenses.

3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of March 31, 2022 and December 31, 2021.
- Interest income, net appreciation in fair value of investments, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period January 1, 2022 through March 31, 2022.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Plan Assets Transfer

On March 31, 2022, as a result of merger with and into the Care Design NY 401(k) Plan sponsored by Care Design New York, LLC (CDNY), all the Plan assets were transferred into CDNY 401(k) Plan, subject to the provisions of ERISA. CDNY is a PHP affiliate. CDNY is a tax-exempt not-for profit care coordination enterprise of which Partnerships is the sole member. CDNY delivers the coordination of home and community-based services to individuals with IDD. All benefits accrued under the Plan

were incorporated into the CDNY 401(k) plan for use solely with respect to the funds transferred from the Plan to the extent required by law. Because PHP transferred Plan assets into a 401(k) plan sponsored by an affiliate, participant vesting status will not be disrupted and benefit payments will be payable under the new plan.

6. Risks and Uncertainties

The Plan provides for various investment securities within the Plan. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Income Tax Status

The Plan was adopted under a volume submitter plan and received an IRS opinion letter on July 8, 2014 stating that the volume submitter plan is designed in accordance with the applicable provisions of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter. The Plan administrator and the Plan's Trustee believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRS.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Related Party Transactions and Party-in-Interest Transactions

Reliance Trust Company is the Trustee for the Plan and, therefore, notes receivable from participants qualify as party in interest transactions.
