In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date of the financial statements are issued, in accordance with accounting principles generally accepted in the United States of America.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2022 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### **Supplemental Schedules Required by ERISA**

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements Years Ended December 31, 2022 and 2021

### 1. Description of Plan Provisions

The following description of the Vivitide, LLC 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined-contribution plan established April 1, 2000 and was amended and restated as of January 1, 2021. The Plan covers all employees of Vivitide, LLC, which was acquired by Biosynth International Inc. in March 2022. Effective October 1, 2022, the Plan was amended to allow employees of Biosynth International Inc. that were not previously part of the Vivitide plan eligibility to join the plan. The Plan also acknowledges years of service with the following employers: New England Peptide, Inc., Peptides International, Inc., and NE Peptide, LLC. The assets of the Plan are held by John Hancock Life Insurance Company (U.S.A.) (“John Hancock”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

#### Eligibility

All employees who have completed forty-five days of service and have attained the age of 18 may elect to participate in the Plan.

#### Contributions

Employees can elect to make pre-tax or Roth contributions through payroll deductions up to 100% of their annual compensation but not more than the government-imposed limit established each year. Participants who are age 50 or older before the close of the Plan year may also elect to make catch-up contributions, subject to certain Internal Revenue Code (“IRC”) limitations. Participants may also roll over amounts representing distributions from other qualified benefit plans or certain Individual Retirement Accounts into the Plan. The match contributions begin with the participant’s first pre-tax deferred contribution. The employer may make a discretionary matching contribution of 4% of eligible wages up to \$4,000 annually.

#### Investment Options

Upon enrollment into the Plan, participants may direct the investment of their contributions and all matching contributions into various investment contracts offered by the Plan.

#### Withdrawals

In the event of retirement (as defined), death, permanent disability, termination of employment, or financial hardship (as defined), the balances in the participants’ accounts may be distributed to the participants or the participants’ beneficiaries in a lump sum or through payments in such other forms as may be available under the Plan. The participant is also entitled to receive the “vested percentage” of his or her matching contribution. The amount of the participants’ hardship distribution may not be in excess of the amount of the participants’ financial hardship, as specified in the Plan.

#### Vesting

Participants are immediately and fully vested in employee contributions and rollover contributions plus actual income or loss thereon. The Plan provides that the Company’s discretionary contributions, including earnings thereon, vest fully at the end of five years of service, as defined by the Plan, upon termination of employment due to death or permanent disability, with partial vesting as follows:

### Notes Receivable from Participants

Employees may request loans for allowable uses which are repaid through payroll deductions. The minimum loan amount is \$1,000 up to a maximum of the lesser of \$50,000 reduced by the highest outstanding loan balance during the 12-month period prior to the date of the participant's request or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account, bear interest at prime plus 1% at the time the loans are made and are to be repaid over a period not to exceed five years, except as related to the purchase of a personal residence in which case the loan repayment may be a longer term. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on an accrual basis. As of December 31, 2022, the interest rates on the outstanding notes receivable from participants ranged from 4.25 – 7.25%. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

### Participant Accounts

Each participant's account is credited with the participant's contributions, allocation of associated employer's contributions, Plan earning and losses, and charged with withdrawals and allocations of administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Forfeiture Amounts

As of December 31, 2022 and 2021, forfeited non-vested accounts totaled \$21,275 and \$11,543, respectively. Forfeitures of the employer's discretionary matching contributions may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During 2022, \$0 of plan expenses were paid from the forfeiture account.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no amounts payable to participants who elected to withdraw from the Plan but had not been paid at December 31, 2022 and 2021.

### Administrative Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

### 4. Fair Value Measurement

The Financial Accounting Standards Board's Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

- Pooled separate accounts: Valued at the net fair value of the underlying assets as determined by quoted market prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies

or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

Although it has not expressed any intention to do so, the plan sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, affected participants who are actively employed by the Company at the time of termination shall be fully vested in their employer contributions.

### 6. Income Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated June 30, 2020 that the Plan was designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving this determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in accordance with the applicable requirements of the Internal Revenue Code ("IRC").

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan's management and its tax counsel have analyzed the tax positions taken by the Plan, and have concluded that as of both December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's management and its tax counsel believe it is no longer subject to income tax examinations for years prior to 2019.

### 7. Risks and Uncertainties

The Plan invests in funds that invest in investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

### 8. Party-in-Interest Transactions

Certain Plan investments are investments managed or issued by the trustee. Additionally, administrative expenses are paid by the Plan to John Hancock, who is the trustee and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. The Plan allows participants to receive loans under Section 72(p) of the IRC. Participant loans are considered to be permitted party-in-interest transactions.

### 10. ERISA Fidelity Bond

ERISA requires all persons who handle assets of benefit plans to be bonded. This requirement protects plans against losses sustained due to acts of fraud or dishonesty by those persons whose positions require them to come in direct contact with or exercise discretion over plan assets. From April 8, 2022 to December 31, 2022, the Plan Sponsor did not have a fidelity bond in place. As a result, the bonding requirement of the Plan Sponsor was not met.

### 11. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2023, the date these financial statements were available for issuance. As of January 1, 2023 the Plan was amended to be renamed Biosynth International 401(k) Plan and require the Plan Sponsor to make Safe Harbor matching contributions for eligible participants equal to 100% of the first 3% of eligible participant compensation contributed to the plan plus 50% of the amount of contributions exceeding 3% of eligible participant compensation. The Plan no longer permits other employer matching contributions.
