## INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Randall Family Companies 401(K) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE 1 DESCRIPTION OF THE PLAN**

**Organization**

Randall Family Companies 401(K) Profit Sharing Plan (the “Plan”) is a defined contribution multiple employer plan (MEP) covering all eligible employees of Randall Construction Holdings, Inc. (the “Company” or the “Employer”) as well as the eligible employees of participating employers. The Plan was established on September 1, 1999 and amended most recently on December 12, 2020 with an amendment effective date of January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The following brief description of the Plan provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

**General**

The Plan is a multiple employer defined contribution profit sharing and safe harbor plan covering all employees of the Company and participating employers, who generally have completed three consecutive months of employment and are age twenty-one or older. If an employee does not complete three consecutive months, the employee is eligible after one year of service. The entry date will be the first day of the quarter following the date the employee meets the eligibility requirements. The Voya Retirement Insurance and Annuity Company serves as the trustee and custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

**Deferrals**

Each year, participants may contribute up to 100% of their annual compensation pursuant to a salary reduction agreement, subject to Internal Revenue Code (“IRC”) limitations. Compensation is defined as wages, tips and other compensation on Form W-2, excluding bonus compensation. The maximum deferral in the taxable year may not exceed a dollar limit set by federal law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Employees have the option to not participate in the Plan.

**Rollover Contributions**

Participants may also contribute amounts representing distributions from other qualified retirement plans. Rollover contributions may not include Roth contributions from other plans.

**Matching Contributions**

The Company may make matching contributions equal to a discretionary percentage or dollar amount, to be determined by the Company, of the participant’s elective deferrals on a uniform basis for all participants.

**Safe Harbor Matching Contribution**

The Company will contribute an amount equal to the sum of 100% of the amount of the participant's elective deferral that does not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferral that exceeds 3% of the participant's compensation but does not exceed 5% of the participant's compensation. Participants are eligible for the matching safe harbor contribution after one year of service. The matching safe harbor contribution will be applied on the plan year basis.

**Profit Sharing Contribution**

Additional discretionary profit sharing amounts may be contributed at the option of the Company.

**Investment Options**

Upon enrollment, a participant may direct participant and employer contributions to one or more of the Plan's investment fund options. The Plan currently offers a money market account and a variety of mutual funds.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of Employer discretionary matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and Safe Harbor/Matching contributions, plus actual earnings thereon. Vesting in the profit sharing contribution of their accounts plus actual earnings thereon is based on years of continuous service as shown in the table below:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000. The notes are secured by the balance in the participant's account and bear interest at 1% over the prime rate of interest. Principal and interest is paid ratably through payroll deductions. A participant may only have one loan outstanding at any time.

**Payment of Benefits**

Upon termination of service, a participant has the option of rolling over to an IRA or other qualified plan in addition to receiving a lump sum amount equal to the value of the participant's vested interest in their account.

If the participant terminates employment with a vested account balance at the date of termination that does not exceed \$5,000 (excluding rollover contributions), a lump sum distribution of the vested account balance may be made, regardless of whether consent was received, and will be distributed as soon as administratively feasible following termination of employment.

Upon termination due to death, a participant's designated beneficiary will be entitled to a lump sum distribution of 100% of the account value.

Withdrawals – Participants may take an in-service distribution of their balances from all accounts upon attaining age 59.5.

Hardship distributions are permitted from pre-tax elective deferral accounts.

Forfeited Accounts – Forfeitures of non-vested employer contributions may be used to reduce future employer contributions or to pay administrative expenses. At December 31, 2022 and 2021, there was approximately \$17,000 in the forfeiture account.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to amend or discontinue the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the account of each participant will be 100% vested.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting and in conformity with generally accepted accounting principles in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

As of December 31, 2022 and 2021, all Plan investments are valued at fair value as provided and certified by The Voya Retirement Insurance and Annuity Company.

The underlying securities in each mutual fund account are listed on national securities exchanges and valued on the basis of year-end closing prices. Securities traded in the over-the-counter market are valued at the closing price on the last business day of the year. Gain or loss on securities sold is based on average cost. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Plan Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (participant distributions) are charged directly to the participant's account.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2022 and 2021, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Subsequent Events**

In accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") Topic 855, *Subsequent Events*, the Plan evaluated subsequent events through July 17, 2023, the date the financial statements were available for issue.

**NOTE 3 FAIR VALUE MEASUREMENTS**

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan assessed the guidelines for measuring fair value. These guidelines provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. FASB ASC 820 establishes three levels of fair value hierarchy that are described as follows:

- Level 2            Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in inactive markets. Inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data are also included. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following valuation methodologies are used for the Plan's assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Money market account – The money market account represents cash bearing interest invested in a deposit account with fair value equal to the amount payable on demand and is a level 1 investment.

Mutual Funds and Self-Directed Accounts - Level 1 investments are measured using publicly available quoted prices in active markets for identical assets. Level 1 investments include mutual funds.

**NOTE 4 INCOME TAX STATUS**

The Department of the Treasury has determined and informed the Plan administrator by a letter dated January 1, 2018, that the form of the Plan is acceptable under section 401 of the Code for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. As a result, no provision for income taxes has been included in the Plan's financial statements.

GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is subject to income tax examinations for up to three years after tax returns are filed.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by Section 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee of certain Plan assets has certified as to the completeness and accuracy of the funds held by them as reflected in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2022 and 2021, and net appreciation/(depreciation) in fair value of investments, interest, and dividends for the year ended December 31, 2022.

**NOTE 7 PARTIES IN INTEREST AND RELATED PARTY TRANSACTIONS**
