Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The 401(k) Plan of United Generations, LLC (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets held at end of year for the year ended December 31, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Description of the Plan

The following description of The 401(k) Plan of United Generations, LLC (the Plan), formerly known as the Employees Retirement Savings Plan of United Conveyor Corporation, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible U.S. employees of United Generations, LLC (the Company), United Conveyor Corporation, United Conveyor Supply Company, or Pangborn Corporation and their divisions, and subsidiaries which adopted the Plan (the Employers). To be eligible for all contributions, employees must complete 30 days of service or two months of service and attain the age of 21 if the employee is covered by the agreement between United Conveyor Supply Company or United Automobile, Aerospace, and Agricultural Implement Workers of America Local #5 (Mishawaka). The Plan Administrator is responsible for the oversight of the Plan. The Plan's trustee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Administrator.

Contributions: Each year, participants may contribute up to the maximum dollar limit of pre-tax annual compensation, as defined in the Plan, as allowed by the Internal Revenue Service (IRS) starting on the first day of the calendar month immediately following the participant's date of hire. Participants are automatically enrolled to have a pre-tax deduction equal to 6% of eligible compensation unless they elect to enroll at a different deferral rate or elect not to enroll in the Plan. All automatically enrolled participants have the option to increase, decrease, or eliminate their automatic enrollment contribution prior to it becoming effective. Effective February 22, 2021, participants with a deferral rate greater than zero will have that deferral increased annually by 1% until a deferral rate of 15% is reached. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants may also contribute in the form of Roth contributions.

Participating employees of United Generations, LLC, United Conveyor Corporation, or United Conveyor Supply Company will receive matching contributions equal to 100% of the participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the next 2% of the participant's compensation (for a maximum matching contribution of 4%).

Effective January 1, 2021, participants of the Pangborn Corporation will receive matching contributions equal to 100% of the participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the next 2% of the participant's compensation (for a maximum matching contribution of 4%). Prior to January 1, 2021, participants of Pangborn Corporation were receiving matching contributions equal to 100% of the participant's elective deferrals up to 2%.

Participating employees covered by the agreement between the United Conveyor Supply Company and the United Automobile, Aerospace, and Agricultural Implement Workers of America Local #5 (Mishawaka) will receive matching contributions as defined by their respective agreement.

The Company may also make discretionary profit-sharing contributions to the Plan as approved by the Company's Board of Directors for eligible participating employees of United Conveyor Corporation and United Conveyor Supply Company who have completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. All eligible participants receive an allocation of the profit-sharing contribution based on a percentage of participants' eligible compensation during the Plan year. The Company made a discretionary profit-sharing contribution equal to 7% of participants' eligible compensation for the year ended December 31, 2022, totaling \$1,620,475. This discretionary profit-sharing contribution is included in Company receivables on the statement of net assets available for benefits

Note 1. Description of the Plan (Continued)

Investment options: Upon enrollment in the Plan, participants may direct all contributions into a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Participant accounts: Under the Plan, separate accounts are maintained to reflect the interests of each participant. Each participant's account is credited with the participant's contribution and Company matching contributions, and allocations of the Company's discretionary profit-sharing contributions, forfeitures and investment earnings. Each participant's account is also charged with an allocation of administrative expenses. Allocations are based on participant earnings, Plan account balances, or specific participant contributions, as defined.

Terminated or retired participants with undistributed benefits remaining as part of the Plan's assets continue to earn pro rata allocation of investment income.

Vesting: Participants are immediately vested in their contributions and the Company's matching contributions, plus actual earnings thereon. Participants become 100% vested in their discretionary profit-sharing allocations after two years of service. Participants who are employees of Pangborn become 100% vested in their respective Company matching contributions and discretionary profit-sharing allocations after one year of service.

Notes receivable from participants: The Plan allows each participant to borrow a minimum amount of \$1,000 and a maximum amount not to exceed the lesser of one-half of the participant's vested account balance or \$50,000. The loan term may not exceed five years unless it is for the purchase of a principal residence, in which case the term will be within a reasonable amount of time, not to exceed 15 years. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan Administrator. Interest rates for the Plan years ended December 31, 2022 and 2021, ranged from 3.25% to 7.25%. Loans are repaid ratably through weekly or semi-monthly payroll deductions.

Payment of benefits: On termination of service due to death, permanent disability, retirement or separation from service, a participant may elect to receive their vested balance in a lump-sum amount or in the form of equal installments over a period of time not exceeding the participant's life expectancy or the joint life expectancy of the participant and their beneficiary.

Administrative costs: Administrative expenses of the Plan are paid by both the Company and the Plan.

Forfeited accounts: At the Company's discretion, forfeited balances may be used to pay administrative expenses or to reduce the Employer's contributions. As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$69 and \$24,368, respectively. Forfeitures of \$29,217 were used to reduce Company matching contributions during the year ended December 31, 2022.

Note 2. Summary of Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification.

Valuation of investments and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies using information provided by the trustee and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivables from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule of assets (held at end of year).

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Payment of benefits: Benefit payments are recorded when paid.

Note 3. Summary of Investment Information Certified by Fidelity Management Trust Company, the Trustee

The following is a summary of the Plan's asset and income information as of December 31, 2022 and 2021, and for the year ended December 31, 2022, included throughout the Plan's financial statements and supplemental schedule that were prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certification from the trustee that information provided to the Plan Administrator by the trustee related to the following assets and income is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodologies include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Shares of registered investment companies: Shares of registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Shares of common/collective trust: Investments are valued using the NAV provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2022, there were no transfers in or out of Level 3.

Note 5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of a common/collective trust fund and of mutual funds managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for management services amounted to \$138,889 for the year ended December 31, 2022.

Certain employees of the Company provide administrative services to the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan.

Note 6. Plan Termination

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

Note 7. Tax Status

The Plan has adopted a volume submitter plan sponsored by Fidelity Management & Research Co. The volume submitter plan provider has received an advisory letter from the IRS as to the non-standardized pre-approved profit-sharing plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset), or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Effective January 1, 2023 the Retirement Plan Committee spun-off the Pangborn Savings Plan out of this plan for ease of administration purposes. All assets were transferred out of the Plan's Fidelity accounts on January 3, 2023 and March 28, 2023. All assets transferred out of the Plan was approximately \$9,600,000. Additionally, the Plan name was changed to The 401(k) Plan of UCC Holdco, LLC.

The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through October 16, 2023, the date the financial statements were available to be issued.
