## INDEPENDENT AUDITORS' REPORT

**NOTE 1 - DESCRIPTION OF PLAN**

Microporous, LLC (the Company) established the Microporous, LLC 401(k) Profit Sharing Plan (the Plan) on April 4, 1991. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Company who have completed 90 days of employment and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code as pre-tax or after-tax Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several pooled separate accounts and a fixed account as investment options for participants. Newly hired employees will be automatically enrolled in the default investment at a deferral amount of 3 percent, unless the employee specifies otherwise. The Company contributes 100 percent of each participant's contributions limited to 3 percent of eligible compensation. In addition, the board of directors elected to make an additional discretionary contribution of 1 percent of each participant's compensation for the years ended December 31, 2022 and 2021. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25 – 7.25 percent, which is commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through regular payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a period not exceeding the life expectancy of the participant or the joint life expectancy of the participant and his or her designated beneficiary. For a termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants who do not make an election as to the treatment of their account balance, but who have a vested account balance less than \$5,000, are subject to the Plan's mandatory cash out provision. This provision provides for the lump sum distribution of a participant's account if no distribution method is elected by the participant. Benefits are recorded when paid.

**Forfeited Accounts**

Forfeitures may be used to pay the administrative expenses of the Plan or to reduce employer contributions. Forfeitures are used by end of the plan year following the plan year in which they occurred. During 2022 and 2021, forfeitures of \$40,000 and \$49,075 were used to reduce employer contributions, respectively. During 2022 and 2021, forfeitures of \$8,500 and \$11,145 were used to pay Plan expenses, respectively. Unallocated forfeitures were \$18,278 and \$39,137 as of December 31, 2022 and 2021, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Operating Expenses**

The majority of the expenses of maintaining the Plan are paid by the Company. Direct fees are charged against participant accounts for the use of the Plan's loan or withdrawal features. Certain direct expenses related to the Plan totaling \$18,300 and \$19,495 were charged to the Plan for the years 2022 and 2021, respectively. Additionally, indirect expenses are applied to participant accounts prior to earnings, gains, and losses and are netted with investment income on the statements of changes in net assets available for benefits.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service, and earnings thereon, are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15<sup>th</sup> of the following year, as required.

**NOTE 3 - FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

**NOTE 3 - FAIR VALUE MEASUREMENT (CONTINUED)**

The pooled separate accounts invest directly in designated mutual funds. These investments own and hold underlying mutual funds which are valued daily at their net asset values (NAV), which is considered a practical expedient to estimate fair value. The Plan holds units of participation in the pooled separate accounts. The accumulation unit value (AUV) is the value of each unit in the pooled separate account. The pooled separate accounts are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts (typically the beginning AUV is \$10) and is then determined daily based on the NAV of shares of the underlying fund, the fund's dividends and the contract's separate account charges. Transactions occur daily in and out of these investments. There are no unfunded commitments or redemption restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

**NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has entered into an investment contract with VOYA Retirement Insurance and Annuity Company (VOYA). VOYA maintains the funds in a fixed account credited with declared rates of interest and subject to a minimum rate. Amounts allocated to the fixed account are held in VOYA's general account which supports insurance and annuity obligations. VOYA's general account is managed on an aggregate basis and supports all of VOYA's financial commitments. No portion of the general account is attributable to a particular plan nor do plans have undivided ownership interest in general account assets. As of December 31, 2022 and 2021, the contract value was \$2,339,367 and \$2,404,602, respectively.

Certain conditions or restrictions apply to transfers in connection with the fixed account. Withdrawals to pay participant benefits from the fixed account are made at book value. Market value adjustments or surrender charges are based on certain formulas as described in the investment contract. The investment contract itself does not have a maturity date. VOYA may retain the right to defer payments from the general account in the event of certain emergency conditions or as provided by applicable law.

The crediting interest rates for the VOYA Fixed Account and VOYA Fixed Account A during 2022 and 2021 were 3 percent and 1 percent, respectively. The guaranteed minimum interest rates for the VOYA Fixed Account and the VOYA Fixed Account A during 2022 and 2021 were 3 percent and 1 percent, respectively.

**NOTE 5 - RELATED-PARTY TRANSACTIONS**

Certain Plan investments are units of pooled separate accounts and two guaranteed investment accounts managed by VOYA Retirement Insurance and Annuity Company, the certifying entity of the Plan. These transactions qualify as party-in-interest transactions.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9 - CERTIFICATION**

The following is a summary of the unaudited information, included in the Plan's financial statements and supplemental schedule that were prepared or derived from information prepared by VOYA Retirement Insurance and Annuity Company, the certifying entity of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from VOYA Retirement Insurance and Annuity Company that such information is complete and accurate.

*Statements of Net Assets Available for Benefits* – all items and amounts except for contributions receivable, notes receivable from participants, and excess contributions payable.

*Statements of Changes in Net Assets Available for Benefits* – all items and amounts except for interest income on notes receivable from participants, contributions, benefits paid to participants, and plan expenses.

*Supplemental Schedule* – all items and amounts except for participant loans.

**NOTE 10 - SUBSEQUENT EVENTS**

The Company has evaluated subsequent events through October 16, 2023, the date which the financial statements were available to be issued.

**NOTE 11 - SECURING A STRONG RETIREMENT ACT (SECURE 2.0)**

In December 2022 SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions will become effective in 2024 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
