The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Emphasis of Matter

As described in Notes 2 and 5 to the financial statements, The Cornerstone of Recovery, Inc. was purchased by Bradford Health Services. According to the terms of the sale, the 401(k) plan adopted a resolution to terminate the plan. Effective with the Plan's termination date of December 31, 2022, all participants with an account balance in the Plan became fully vested in all contribution sources. As of the Plan termination date, all plan assets were transferred to merged plan as of December 28, 2022.



NOTE 1 - DESCRIPTION OF PLAN

The following description of the Cornerstone of Recovery, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Copies of this booklet are available from the Company.

General – The Plan is a defined contribution plan sponsored by the Plan Sponsor. The Plan Sponsor is a member of a controlled group, and Allied Medical Clinic, Inc. dba Cornerstone Integrative Health Associates, an affiliated employer, adopted the Plan as a participating employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees, regardless of age or service, other than certain excluded employees (union employees, nonresident aliens, leased employees, and temporary/support living work program employees), as defined, are eligible to become participants in the Plan and make elective deferrals upon first day of employment. Participants who were 19 or older and have completed one year of service, as defined, are eligible for the Plan Sponsor discretionary matching and nonelective profit sharing contributions generally effective on the first day of the Plan year or first day of the seventh month of the Plan year after the age and service requirements are met.

Investments – The investments of the Plan are held by Ascensus Trust Company (the Custodian), who maintains the investments in various mutual funds and the Wilmington Trust Retirement and Institutional Services Company Collective Investment Trust for MetLife Guaranteed Annuity Contract 25554. Participants direct the investments in their accounts into the various investment options offered by the Plan. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

Plan Contributions – Each year, the Plan Sponsor may make nonelective profit sharing contributions to the Plan. For 2022 and 2021, the Company elected to fund a discretionary matching contribution of \$55,313 and \$77,659 respectively. Contributions are subject to certain limitations.

The Plan Sponsor may; make discretionary matching contributions of participant's elective salary deferrals. The Plan Sponsor made a discretionary matching contribution in 2022 equal to 25% of each participant's elective salary deferrals up to 1.5% of eligible compensation.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions are invested in a target date mutual fund until changed by the participant. Effective January 1, 2019, the Plan was amended to include automatic escalation provision, whereby participants' deferral rates are increased by 1 % each year to a maximum of 6%.

Participants may elect to contribute a percentage of their annual compensation or a fixed amount per pay period, on a pre-tax or after-tax basis, as a salary deferral. These deferrals are subject to the annual limitations defined in the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Contributions receivable, if any, are unsecured.

Participant Accounts - Individual accounts are maintained for each participant to reflect the participant's contribution, Plan Sponsor discretionary matching and profit-sharing contributions, and investment earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's discretionary matching and profit-sharing contribution portion of each participant's account is based on years of continuous service, and participants become fully vested in the Plan Sponsor's contributions after six years of service as follows:

Participants may also become 100% vested as a result of death, total and permanent disability, or reaching normal retirement age at 65.

Participant Loans – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loans bear interest at commercially reasonable rates determined by the Plan Administrator and are generally repayable in level periodic payments over various terms of up to five years, except if utilized for the acquisition of a qualified principal residence, which may be repaid over a reasonable period of time in excess of five years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – On termination of service due to death, disability or retirement, a participant (or a participant's beneficiary in the event of the death of a participant) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service due to other reasons, a participant may receive the value of vested interest in his or her account as a lump sum distribution, or installment payments. In-service hardships are available in certain circumstances.

Forfeited Accounts – Forfeitures of terminated participants' non-vested accounts can be used to reduce future Plan Sponsor contributions or pay certain Plan administrative expenses. If a terminated employee is rehired by the Plan Sponsor, then the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan document. At December 31, 2022 and 2021, the forfeited nonvested accounts totaled \$0 and \$0, respectively. For the year ended December 31, 2022, forfeited non-vested accounts amounting to \$0 were applied to reduce administration expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America (U.S. GAAP). As discussed in Note 5 to the financial statements the Plan has been terminated and liquidated as of December 31, 2022, which indicates that the Plan is not a going concern. The financial statements do not require any liquidating adjustments that might have been necessary upon termination. My opinion is not modified with respect to that matter.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, the Custodian, and an insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Participant Loans - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

Benefit Payments - Benefit payments are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivables from participants are charged directly to the participants' accounts and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation in the fair value of investments. (See Note 8).

NOTE 3 – CERTIFIED INFORMATION

The Custodian holds the Plan's investment assets and executes transactions therein. Financial information relating to those assets is included in the accompanying financial statements based on information provided and certified as complete and accurate by the Plan Custodian. The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified as complete and accurate by Ascensus Trust Company.

Net realized and unrealized appreciation in the fair value of investments totaled \$688,222 in 2022. Additionally, the Plan had investment income in interest and dividends amounting to \$62,700 in 2022.

Participant loans totaled \$0 and \$68,097 as of December 31, 2022 and 2021, respectively, Interest income on these notes totaled \$1,838 in 2022.

Administrative fees paid by the Plan to a party-in-interest totaled \$42,478 in 2022 (see Note 8).

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels; Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2022, are reported in net appreciation in fair value of investments.

The Plan’s policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2022, there were no transfers between Level 1 and Levels 2 and 3.

The following is a description of the valuation methodologies used at December 31, 2022 and December 31, 2021:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust: Valued at NAV as provided by the administrators of the fund. The NAV is used as the practical expedient to estimate fair value. The NAV is based on the value of the underlying assets of the fund, less liabilities, and then divided by the number of units outstanding. The following table presents the Plan’s investments using the NAV practical expedient at December 31:

The collective investment trust, through its investment in the group annuity contract, simulates the performance of a guaranteed investment contract through the issuer’s guarantee of a specific interest rate and portfolio of financial instruments that are opened by the issuer, MetLife Insurance Company.

NOTE 5 – PLAN TERMINATION

During 2022, The Cornerstone of Recovery, Inc. was purchased by Bradford Health Services. Per terms of the sale, Cornerstone adopted a resolution to terminate the Plan. Effective with the Plan’s termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources. As of December 31, 2022, all plan assets were transferred to the merged plan on December 28, 2022 with an effective termination date of December 31, 2022.

NOTE 6 – TAX STATUS

The IRS has determined and issued a letter dated March 31, 2014, that the Volume Submitter Profit Sharing Plan and Related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) for an exemption from federal income taxations under IRC Section 401(a) and IRC Section 501 (a). Accordingly, no taxes have been provided for in the accompanying statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative plan expenses paid by the Plan totaled \$42,478 for the year ended December 31, 2022, as described in Notes 2, the Plan pays all expenses of maintaining the plan, unless otherwise paid by the Plan Sponsor. Investment expenses paid to the custodian are netted against investment returns. Related party transactions include contributions from the Plan Sponsor.

The above party-in-interest related party transactions are exempt from the prohibited transaction rules of ERISA,
