1. Description of Plan

The following description of the My Alarm Center, LLC 401(k) Plan (the “Plan”), provides only general information. The Plan was originally effective January 1, 2004 and was most recently amended and restated effective August 1, 2021. Empower Trust Company, LLC, formerly known as Great-West Trust Company, LLC, is the trustee of the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of My Alarm Center, LLC (the “Company”) and related participating employers, who have met the minimum service requirement of 90 days with the exception of collectively-bargained employees, non-resident aliens who do not have United States source income. The Plan also excludes covered employees acquired in an asset or stock acquisition, merger, or similar transaction, until the Company extends the Plan to such employees. Eligible employees who satisfy the service requirement enter on the first day of each calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On April 25, 2021, the Company filed voluntary petitions for relief under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware. In June 2021, the Company completed a deleveraging and recapitalization transaction and emerged from Chapter 11 protection. In December 2021, the Company and Alert 360 signed a definitive merger agreement.

As part of this merger, effective January 1, 2023, the My Alarm Center, LLC 401(k) Plan was merged with and into the Alert 360 401(k) Retirement Plan. The plan merger initiated a “Black Out” period beginning December 23, 2022 and continued through February 12, 2023. During this period, participants’ plan accounts were not available for investment fund exchanges, and distribution requests, including participant loan withdrawals. During the Black Out period, funds were transferred from Empower Trust Company, LLC, the trustee of the Plan, to Fidelity Management Trust Company, the trustee of the Alert 360 401(k) Retirement Plan. As a result of the plan merger, \$5,598,345 of plan investments, \$356,485 of participant loans and other net assets of \$125,947 consisting of participant contributions receivable, employer contributions receivable and excess contribution payable were transferred from the Plan to the Alert 360 401(k) Retirement Plan on December 30, 2022. Management believes that there was no participant-initiated activity after December 30, 2022 and the Plan was merged into the Alert 360 401(k) Retirement Plan on December 30, 2022 for financial reporting purposes. Additionally, for Form 5500 purposes, all assets, liabilities and participants ceased to be part of the Plan as of December 30, 2022 and such amounts are reported as zero on the December 30, 2022 Form 5500.

Contributions

Each year participants in the Plan may contribute amounts of eligible pretax compensation as 401(k) contributions to the Plan up to the maximum allowable under the Internal Revenue Code (“IRC”). Contributions may also be designated as Roth 401(k) contributions. The Plan includes an automatic enrollment of salary deferral contributions of 2% of eligible compensation, unless the participant opts out or elects a different deferral amount or percentage. Automatic deferral provisions are applicable for participants who are hired on or after September 1, 2018. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make contributions on any employer-paid bonus. The amount of contributed bonus amount may be from 1 percent to 100 percent of the bonus amount. Participants may also roll over amounts from other qualified plans, 403(b) annuities, 457 plans and individual retirement accounts.

The Plan provides for a discretionary matching contribution by the Company. For the period from January 1, 2022 to December 30, 2022, the Company’s discretionary matching contribution was 25% of employees’ 401(k) contributions up to 4% of eligible compensation. Participants must complete at least 1,000 hours of service during the Plan year and be employed by the Company on the last day of the Plan year to receive the discretionary matching contribution.

The Plan also permits for the Company to contribute an additional discretionary non-elective contribution, as determined by the Plan Sponsor. No such contributions were made for the period from January 1, 2022 to December 30, 2022.

Participant Accounts

Each participant's account is credited with the participant's contribution, Company matching contributions, if any, and allocations of Company non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct their investments in 1% increments among the various investment options offered by the Plan.

Vesting

A participant, at all times, has a fully vested (100%) interest in their own contributions, and rollover contributions, including actual earnings thereon.

The discretionary matching and discretionary non-elective contributions vest according to the following schedule:

2 or more years	100%

Notwithstanding the above vesting for the discretionary matching and discretionary non-elective contributions, a participant will become 100% vested in these accounts upon their attainment of normal retirement age (65) while an employee, death, or disability.

Forfeited Accounts

If a former participant is re-employed by the Company within five years of the termination date, previously forfeited amounts may be used to reinstate the participant's account. Forfeitures may be used to pay administrative expenses and to reduce future Company contributions. Total unallocated forfeitures were \$0 and \$5,276 as of December 30, 2022 and December 31, 2021, respectively. For the period from January 1, 2022 to December 30, 2022, forfeitures of \$5,276 were used to reduce Company contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts at a minimum amount equal to \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence. A participant may have up to one loan outstanding at any given time.

Payment of Benefits

In the event of a participant's death, retirement, disability or termination of employment for other reasons, the participant or their beneficiary may elect to receive the entire account balance in a lump sum or in installment payments. Account balances which do not exceed \$5,000 will be paid in a lump sum or rolled over to an individual retirement account as elected by the participant. Unless elected otherwise by the participant, account balances which do not exceed \$1,000 will be distributed as a lump-sum as soon as administratively feasible by the plan administrator. A participant may also withdraw all or a portion of their entire account balance upon attainment of age 59 ½ or in the case of financial hardship, as defined.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's oversight committee determines the Plan's valuation policies utilizing information provided by trustees, custodians, insurance companies and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the period from January 1, 2022 to December 30, 2022.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 and 2021 excess contributions to the applicable participants during 2023 and 2022, respectively.

Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee, custodial and third-party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 30, 2022 and December 31, 2021.
- Investment activity, including net depreciation in fair value of investments, interest and dividend income, other income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period from January 1, 2022 to December 30, 2022.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 30, 2022 and December 31, 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the merger of the Plan with and into the Alert 360 401(k) Retirement Plan, there were no Plan investments to measure at fair value as of December 30, 2022.

5. Tax Status

Effective August 1, 2021, the Plan was amended and restated by adopting a CBIZ Benefits & Insurance Services Non-Standardized Defined Contribution Pre-Approved Plan. The Internal Revenue Service (“IRS”) issued an opinion letter dated June 30, 2020, stating that the CBIZ Benefits & Insurance Services Non-Standardized Defined Contribution Pre-Approved Plan document was designed in accordance with applicable Internal Revenue Code (“IRC”) requirements as of that date. Although the Plan has since been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 30, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

6. Related-Party and Party-In-Interest Transactions

Plan investments included shares of mutual funds managed by Empower Trust Company, LLC (“Empower”). Empower is the trustee and recordkeeper as defined by the Plan. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Empower or its affiliates generate income to the Plan through revenue sharing agreements. More specifically, Empower or its affiliates may receive revenue from mutual fund service providers for services Empower or its affiliates provide to the mutual funds. This revenue may be used to offset certain amounts owed to Empower or its affiliates for administrative services to the Plan. If the revenue received by Empower or its affiliates from such mutual fund service providers exceeds the amount owed as agreed to by Empower and the Plan for administrative services, Empower or its affiliates is to remit the excess to the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants.

During the period from January 1, 2022 to December 30, 2022, the related amounts deposited into the Plan were \$23,302. During the period from January 1, 2022 to December 30, 2022, \$23,302 of the related amounts were used to pay administrative expenses. As of December 30, 2022 and December 31, 2021, the balance in this account totaled \$0 and \$0, respectively. The Plan or Plan Sponsor may make a payment to Empower or its affiliates for administrative expenses not covered by revenue sharing.

During 2022, the Company failed to remit to the Plan's trustee certain employee contributions totaling \$2,316 within the period prescribed by the Department of Labor regulations. During 2023, the Company plans to make contributions to the affected participant accounts to compensate the participants for potential lost income due to the 2022 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and is taking actions prescribed by the regulations to remedy such errors.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would become 100% vested in their employer contributions, and all remaining assets in the Plan are to be distributed to the participants by the trustee in accordance with the accrued benefits of such participants as of the date of termination.
