Basis for Disclaimer of Opinion on the 2022 and 2021 Financial Statements

Because of the inadequacy of accounting records for the prior years, we were unable to perform sufficient auditing procedures with respect to the participants' individual account balances accumulated from inception of the plan and therefore are unable to form an opinion regarding the balances as of January 7, 2022 and December 31, 2021, or the propriety of the distributions to terminated participants during the period and year then ended.

The Plan's records and procedures are not adequate to assure the completeness of participants' data on which contributions and benefit payments are determined, and we were unable to perform any other auditing procedures with respect to participants' data maintained by the participating employer.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alexander McQueen Trading America, Inc. Retirement and Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of Alexander McQueen Trading America, Inc. Retirement and Savings Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion on the 2022 Financial Statements section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Alexander McQueen Trading America, Inc. Retirement and Savings Plan to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

ALEXANDER MCQUEEN RETIREMENT AND SAVINGS PLAN

NOTES TO FINANCIAL STATEMENTS JANUARY 7, 2022 AND DECEMBER 31, 2021

1. THE PLAN

The following description of the Alexander McQueen Trading America, Inc. Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide benefits to eligible employees of Alexander McQueen Trading America, Inc. (the "Company"). The Plan is administered by management of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Transamerica Retirement Solutions Corporation is the record-keeper of the Plan.

During 2022, the Company approved a plan to merge the Plan into the Kering Americas, Inc. Retirement and Savings Plan. As a result, the Plan transferred approximately \$3,268,000 of assets into the Kering Americas, Inc. Retirement and Savings Plan on January 7, 2022.

Eligibility

As defined in the Plan document, all employees of the Company who are age 21 are eligible to participate in the Plan, except for the following:

- Nonresident aliens with no U.S. source income
- Leased employees
- Employees of any Controlled Group Employer (or affiliated service group Employer) that does not affirmatively adopt this plan
- Part-time, temporary, or seasonal employees and interns who work less than 1,000 hours of service in the relevant computation period

Once an employee has completed one year of service, defined as 1,000 hours, he or she is eligible for the Company's match and discretionary contributions. Eligible employees may begin contributing to the Plan on the first day of the month coinciding with or next following the date on which an employee meets the eligibility requirements. Eligible employees may begin to receive matching contributions and discretionary contributions, if any, on the first day of the payroll period coinciding with or next following the date on which an employee meets the eligibility requirements, or as soon as administratively feasible thereafter.

Contributions

Each year, participants may elect to contribute a percentage of their annual wages on a pre-tax basis to the plan. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans.

During the Plan years ended 2022 and 2021, the Company provided a matching contribution equal to 4% of an eligible participant's compensation. The Company may also make a discretionary contribution; however, there were no discretionary contributions made into the Plan during 2022 or 2021. The Company's contributions are subject to limitations imposed by federal laws for qualified retirement plans.

1. THE PLAN (Continued)

Vesting

A participant in the Plan shall always have a fully vested and non-forfeitable interest in his or her employee contributions and employer matching contributions.

Employer discretionary contributions vest over five years of service (25% after the second year of service and 25% each year thereafter). If a participant terminates employment and is less than 100% vested, they will forfeit the non-vested portion of their account.

Participant Accounts

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, Company matching contributions, an allocation of discretionary contributions, if any, and actual earnings (losses) thereon. Each participant's account is charged with the actual amount of distributions taken and an allocation of administrative expenses.

Investment Options

Participants may elect to have their contributions and Company contributions invested in a variety of investment funds, including various mutual funds and a guaranteed annuity contract.

Payment of Benefits

Upon termination of employment after the attainment of age 65 or for reasons of disability or death, the participant or his or her beneficiary shall receive the full value of his or her accounts. However, if termination of employment is for reasons other than the attainment of age 65, disability or death, the participant shall receive only the value of the vested funds in his or her account.

Forfeited Accounts

As of January 7, 2022 and December 31, 2021, there were no balances of forfeited non-vested accounts. Forfeited non-vested accounts are used primarily to offset Plan expenses or reduce future employer contributions. During 2022 and 2021, there were no forfeited non-vested accounts that were used to reduce employer contributions.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from Plan assets. Substantially all administrative expenses associated with the Plan are paid by Plan participants as a reduction of investment income allocated to participant accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum amount that is equal to the lesser of \$50,000 or 50 percent of the value of the vested portion of the participant's accounts and greater than \$1,000. The maximum repayment terms of loans are 5 years for general purpose loans and 10 years for principal residence loans. The amounts borrowed are transferred from the investment funds in which the participant's accounts are currently invested. Repayment and interest thereon are credited to the participant's current investment funds through payroll deductions made each pay period. The loans are secured by the vested balance in the participant's account and bear interest ranging from 4.25% - 6.00%. The interest rate for loans is based on the prime rate at the time of the loan plus one percentage point.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

In accordance with U.S. GAAP, fixed annuity contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Risk and Uncertainties

The Plan provides investment options in a variety of investment securities. Investment securities are exposed to various risks, such as interest rate risk, financial market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of assets available for benefits.

Use of Estimates

U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. The Plan has determined an allowance for uncollectible notes receivable from participants is unnecessary at January 7, 2022 and December 31, 2021.

Investment Valuation and Income Recognition

Investments in mutual funds are stated at fair value based upon quoted market prices at the Plan's year end. Interest bearing cash held within investments is stated at amortized cost, which approximates its fair market value. Fully benefit responsive guaranteed annuity contracts are stated at contract value, as this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's interest in the guaranteed annuity contract is held with Transamerica Life Insurance Company (TLIC). Funds under these contracts that have been allocated and applied to purchase annuities are excluded from the Plan's assets. Purchased annuities are contracts under which the insurance company is obligated to pay benefits to named participants or their beneficiaries. The fund is fully benefit-responsive, which means withdrawals from the fund may be made for qualifying benefit payments, including participant-directed transfers. Participants can transfer funds from the fund to other non-competing investment options. Amounts transferred from the fund may not subsequently be transferred to a competing fixed option or withdrawn for 90 days. Participant contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Semi-annually, TLIC declares an interest rate that applies to contributions received during the period. TLIC guarantees the interest rate until the end of the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Certain events may limit the Plan's ability to transact at contract value with TLIC. Such events may include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that may limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Changes in the fair value of investments, including realized/unrealized gains and losses on assets sold during the year or held at year-end, are reflected in the statements of changes in assets available for benefits as net appreciation or depreciation in the fair value of investments. Purchases and sales of securities are reflected on a trade day basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fair Value Measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

See Note 4 for a description of where the Plan's assets fall within the fair value hierarchy.

3. CERTIFIED INVESTMENT INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company and Transamerica Life Insurance Company, the Plan's custodians, have certified that the following data included in the accompanying financial statements is complete and accurate as of and for the period ended January 7, 2022, and as of and for the year ended December 31, 2021:

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Company believes its valuation methodologies is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participant accounts would become fully vested in the Company's contributions.

6. TAX STATUS

The Plan is tax-exempt under Section 401(a) of the IRC. A prototype document was used by the Plan to obtain its latest determination letter on March 31, 2014, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants of the Plan to invest in certain funds managed Transamerica Life Insurance Company, a custodian of the Plan. As such, transactions between the participants investing in these funds and the Plan qualify as party-in-interest transactions.

The Plan also allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants with these loans and the Plan qualify as party-in-interest transactions.
