Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cartegraph Systems 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 30, 2022, (in liquidation) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period then ended (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Cartegraph Systems 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2022 and 2021 and for the period ended December 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cartegraph Systems 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 2 to the financial statements, the governing body of Cartegraph Systems 401(k) Retirement Plan approved a plan of liquidation on August 31, 2022. As a result, the Plan has changed its basis of accounting from a going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Cartegraph Systems 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Termination

The Plan Administrator approved an amendment to terminate the Plan effective August 31, 2022. All participants were 100 percent vested as of the closing date and were given the option to take their balance as a distribution or rollover out of the Plan. The Plan had distributed all remaining accounts as of December 30, 2022.

General

The Plan was a defined contribution plan covering generally all employees (excluding interns) of Cartegraph Systems Payroll, LLC (the Company) who had three months of service and were age 21 or older. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees was responsible for oversight of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan's Board of Trustees.

Contributions

Prior to August 31, 2022, participants could elect to contribute up to 100% of eligible compensation as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan offered mutual funds and an insurance investment contract as investment options for participants. Under the provisions of the Plan, the Company was permitted to make matching contributions equal to a uniform percentage of each participant's elective deferral. Prior to August 31, 2022, the Company matched 50% of the first 7% of compensation deferred by each participant. Additional profit sharing amounts may be contributed at the discretion of the Company. The Company did not make any additional profit sharing contributions to the Plan for the period ended December 30, 2022. Contributions are subject to certain IRS statutory limitations.

New participants were automatically enrolled with their deferral rate set at 7% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. The benefit to which a participant was entitled to, was the benefit that can be provided from the balance of the participant's vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant is 100% vested after three years of credited service. All participants became fully vested on August 31, 2022 in coordination with the Plan Termination.

Notes Receivable From Participants

Participants could borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The number of outstanding loans for any participant at any time was limited to two. The notes were secured by the balance in the participant's account. Principal and interest were paid through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant with an account balance greater than \$5,000 could elect to receive installment payments or a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution. Participants with an account balance less than \$5,000 must receive a lump-sum amount upon termination. Upon Plan termination, lump-sum distributions and rollovers out of the plan were permitted.

Forfeitures

On December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$17,951. These accounts were be used to reduce the Plan's administrative expenses and future employer contributions. In 2022, Plan administrative expenses of \$11,811 were paid from the forfeited nonvested accounts, \$6,736 was reallocated to participants and \$8,674 was applied to employer contributions.

Liquidation Basis of Accounting

Effective August 31, 2022, the governing body of the Plan decided to liquidate and terminate the Plan. The financial statements for 2022 have been prepared using the liquidation basis of accounting. The 2021 financial statements were prepared on the ongoing accrual basis of accounting. There were no material differences in the Plan's financial statements using liquidation basis of accounting compared to accrual basis of accounting.

Investments held by a defined contributions plan were required to be reported at fair value, except for fully benefit-responsive investment contracts. As of December 31, 2021, contract value was relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to full benefit-responsive investment contracts because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments in the 2022 statement of net assets available for benefits are reported at liquidation value. For all investments, fair value approximated the amount the Plan expected to collect at liquidation.

All investments in the 2021 statement of net assets available for benefits are reported at fair value, except for full benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were reflected on a trade-date basis. Interest income was recorded as earned on an accrual basis. Dividends were recorded on the ex-dividend date. The net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2021. If a participant does not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants was charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 5, 2023, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 30, 2022 and December 31, 2021, and net depreciation in fair value of investments, dividends and interest for the period ended December 30, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, (the custodians of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

At December 31, 2021, the Plan's investments were reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Plan's Trustees determined the Plan's valuation policies. Although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Observable inputs such as unadjusted quoted prices in active markets and have the highest priority;

Level 2 - Observable inputs, other than quoted prices in active markets, which are observable either directly or indirectly; and,

Level 3 - Unobservable inputs where there is little or no market data, which requires the reporting entity to develop its own assumptions.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended mutual funds that were registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the period ended December 30, 2022 were reported in net depreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period ended December 30, 2022, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had a fully benefit-responsive guaranteed investment contract with Empower Insurance Company of America (Empower) totaling \$96,306 for December 31, 2021. Empower maintained the contributions in a guaranteed interest fund which was a part of the general account of Empower. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rating was based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)

This contract met the fully benefit-responsive contract criteria and was therefore reported at contract value. Contract value was the relevant measurement for fully benefit-responsive investment contracts because this was the amount received by the participant and if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with the issuer. Such events included the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA and premature termination of the contract. No events occurred that limited the ability of the Plan to transact at contract value with the contract issuers and that limited the ability of the Plan to transact at contract value with the participants.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle with an amount different from contract value. Such events included (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligations under the contract, (c) a material misrepresentation, (d) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were in a guaranteed interest fund managed by Empower. Empower was the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net depreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment. In 2022, the Plan made a direct payment for administrative fees of \$55,807.

All of these party-in-interest transactions were exempt from the prohibited transaction rules of ERISA.

NOTE 7 - TAX STATUS

The Company used a prototype non-standardized Plan sponsored by Great-West Trust Company, which received a favorable opinion letter from the IRS on June 30, 2020, that states the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 30, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
