### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Worldwide Equipment Enterprises, Inc. Employee Savings Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Worldwide Equipment Enterprises, Inc Employee Savings Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan *Adoption Agreement* for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of Worldwide Equipment Enterprises, Inc. and Subsidiaries (the Plan Sponsor and Administrator). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and became effective April 1, 1989 and was restated effective January 1, 2021.

#### Eligibility

The Plan covers all employees of the Plan Sponsor age 18 or older. Employees are eligible to participate beginning on the first day of the month following 90 days of employment.

#### Contributions

Each year, participants may contribute up to the maximum percentage of pretax annual compensation, as defined in the Plan, subject to certain annual limits established by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified benefit plans. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1 percent per year up to a maximum of 6 percent of compensation unless the participant makes a change. The employer may make a discretionary matching contribution equal to 100% of the first \$1,000 of each participants' annual contribution. At the end of each plan year, the employer may elect to establish a discretionary profit-sharing contribution. During the year ended December 31, 2022, the employer contributed discretionary matching and profit-sharing funds totaling \$531,332.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, employer contribution, and an allocation of Plan earnings. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. Description of the Plan, continued

### Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

### Payment of Benefits

All distributions from the Plan, except required minimum distributions, will be in lump sums and paid in cash. Required minimum distributions may be paid through partial withdrawals or installments.

### Forfeited Accounts

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$226,580 and \$191,370, respectively. These accounts are made available to reinstate previously forfeited account balances of former participants, if any, in accordance with the Plan document. The remaining forfeitures may be used to reduce future employer contributions or pay administrative expenses. For the year ended December 31, 2022, the Plan used the forfeiture account to pay \$11,896 of administrative expenses. During 2022, additional forfeited non-vested accounts totaled \$140,958.

### Risks and Uncertainties

The Plan provides for participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

### Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan *Adoption Agreement*. All other administrative expenses are paid by the Plan Sponsor.

## 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Corrective Distributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability with a corresponding reduction to contributions. Contributions received from participants are net of payments of \$63,591, for the year ended December 31, 2021, made after year end to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. No corrective distributions payable existed at December 31, 2022.

### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

### Subsequent Events

The Plan's management has evaluated subsequent events through October 16, 2023, which is the date that the financial statements were available to be issued.

## 3. Information Certified and Provided by Trustee

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule were prepared by or derived from information provided by the Reliance Trust Company (Reliance Trust), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that investment information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information in this note and which appears throughout the financial statements and the supplemental schedule.

Reliance Trust also certified to the completeness and accuracy of \$5,057,676 of net depreciation in the fair value of investments and \$336,639 of interest and dividends related to the investments for the year ended December 31, 2022.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the investments measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the methodologies used at December 31, 2022 and 2021.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2022, there were no significant transfers in or out of Level 3.

## 5. Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Automatic Data Processing (ADP). ADP is the recordkeeper as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Indirect fees are paid to ADP based on investment account values. These fees range from 0.03% to 0.41% of the investment account value. The fees are included with net depreciation in fair value of investments on the statement of changes in net assets available for benefits.

## 6. Tax Status

The Plan uses a prototype Plan document sponsored by Benefits Administrators, LLC. Benefits Administrators, LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
