**NOTE 1 DESCRIPTION OF PLAN**

The following description of Hollander Sleep Products, LLC Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective January 1, 1988. The Plan has been amended and restated throughout the years to comply with tax legislation. The Plan was last restated effective September 1, 2022 and most recently amended January 1, 2023. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

**Eligibility**

Employees of Bedding Acquisition, LLC dba: Hollander Sleep Products, LLC (the Company) are eligible to participate in the Plan upon attaining age 18. The Plan excludes collective bargaining employees, part-time/temporary/seasonal employees (unless they have completed 1,000 hours within 12 months of service), nonresident aliens, and Puerto Rican employees.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. The Plan has an automatic deferral provision whereby the Plan Sponsor will automatically withhold 3% of the participant's eligible compensation, unless elected otherwise by the participant. The Plan also includes an automatic increase provision whereby participants are increased annually by 1% up to a maximum deferral percentage of 6%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company will make a safe-harbor matching contribution for all participants who participate in the deferral portion of the Plan. For the year ended December 31, 2022, the Company safe-harbor matching contribution was 100% of the first 1% of eligible compensation deferred plus 50% of the next 5% of eligible compensation deferred. The Company may, at its discretion, make an additional discretionary matching or nonelective profit sharing contribution to the Plan. There were no additional discretionary Company matching or nonelective contributions made for the year ended December 31, 2022.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's safe-harbor matching contribution, the Company's additional discretionary matching or nonelective profit sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions. Vesting in the Company's safe-harbor match contributions and the Company's discretionary matching and nonelective profit sharing portion of their accounts plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested in the Company's safe-harbor matching contributions after two years of continuous service under a cliff vesting schedule. A participant is 100% vested in the Company's discretionary matching and nonelective profit sharing contributions after five years of continuous service under a graded vesting schedule. Notwithstanding the above, participants are 100% vested in their account upon reaching normal retirement age, disability, or death.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installment. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions, subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Forfeited Accounts**

Forfeited nonvested accounts are used to pay Plan administrative expenses or used to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2022 and 2021 totaled \$275,500 and \$57,943, respectively. There were \$10,800 forfeitures used to pay Plan administrative expenses and \$50,000 used to reduce Company contributions for the year ended December 31, 2022.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the investment management, investment advisory, administration of benefit payments, loans, and participant accounts are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Vanguard Fiduciary Trust Company, the Plan's custodian effective September 1, 2022 and qualified institution, has supplied the Plan administrator with certification as to the completeness and accuracy of the notes receivable from participants and the investment information presented in the accompanying statement of net assets available for benefits as of December 31, 2022, the statement of changes in net assets available for benefits for the period from September 1, 2022 through December 31, 2022, and the supplemental schedule of assets (held at end of year) as of December 31, 2022.

State Street Bank and Trust Company, the custodian through September 1, 2022 and qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of the notes receivable from participants and the investment information presented on the accompanying statement of net assets available for benefits as of December 31, 2021 and the statement of changes in net assets available for benefits for the period from January 1, 2022 through September 1, 2022.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Collective Funds:* Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Interest Bearing Cash:* Valued at cost, which approximates fair value.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the prototype Plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments were managed by State Street Bank and Trust, the custodian through September 1, 2022. Effective September 1, 2022, the Plan investments are managed by Vanguard Fiduciary Trust Company, the trustee of the Plan. Mercer Trust Company was the Plan's trustee through September 1, 2022. Transactions with these parties qualify as party-in-interest transactions.

**NOTE 10 NONEXEMPT TRANSACTIONS**

During 2021 and 2022, the Company failed to remit employee 401(k) deferral contributions for certain payroll periods within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC. The Company corrected the prohibited transactions in 2022 and 2023.

**NOTE 11 PLAN MERGER**

Effective September 8, 2022, the Plan Administrator authorized the merger of the Sure Fit Inc. Non Union 401k Savings Plan. Investments and notes receivable from participants of \$10,830,342 were merged into the Plan on September 8, 2022.

**NOTE 12 SUBSEQUENT EVENT**

The Plan Administrator authorized the merger of the Keeco, LLC Profit Sharing Plan & Trust. Investments and notes receivable from participants of approximately \$29,047,906 were merged into the Plan in July 2023.
