Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of IDEX Corporation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2022 and 2021, and for the year ended December 31, 2022 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material

misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the IDEX Corporation Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined benefit plan covering certain salaried and hourly employees not subject to collective bargaining agreements of IDEX Corporation and its United States subsidiaries (collectively the “Company” or “Employer”). The Plan was restated effective January 1, 2011 since it is an individually designed plan and restatement was required by the Internal Revenue Service. The Plan is intended to be a qualified profit-sharing plan within the meaning of Section 401(a) of the Internal Revenue Code (the “Code”). IDEX Corporation is the Plan’s administrator (“Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The primary purpose of the Plan is to provide benefits to employees or their beneficiaries upon retirement, death or disability.

Plan Termination. Effective May 1, 2020, the Plan was amended to terminate the Plan. Participants were notified in February 2020 and the Plan officially notified the Pension Benefit Guaranty Corporation of its intent to terminate in October 2020. The Plan settled all plan liabilities during 2021 and was in the process of transferring excess Plan assets as of December 31, 2022 and 2021.

The net assets of the Plan will be allocated for payment of Plan benefits to the participants in order of priority determined in accordance with ERISA and the Plan document.

Typically, the priority is indicated as follows:

- a) To provide retirement benefits for participants and other individuals who, three years prior to the Plan termination date, were either receiving retirement benefits or would have been eligible to receive retirement benefits had they then retired;
- b) To provide all other retirement benefits guaranteed under Title IV of ERISA;
- c) To provide all other retirement benefits not guaranteed by ERISA, but which would be at least partially vested, assuming that the Plan termination date is also the employment termination date;
- d) To provide all other retirement benefits accrued by participants as of the Plan termination date, but which are not then vested.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (“PBGC”) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor’s pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan’s termination, subject to a statutory ceiling on the amount of an individual’s monthly benefit.

Whether all participants receive their benefits will depend on the sufficiency, at that time, of the Plan’s net assets to provide those benefits, the priority of those benefits to be paid, and the level and type of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guarantee, but other benefits may not be provided for at all.

Benefits and Vesting. The Plan is designed to provide normal retirement benefits to eligible employees at age 65 or, if employed after age 60, five years from date of hire. Employees were eligible to participate as of the first day of the month coincident with or the next date following the date of employment or transfer to an eligible class of employees. Effective January 1, 2005, there were no new entrants to the Plan. All participants employed at December 31, 2005 were 100% vested in their accrued benefit. The Plan is an ongoing “career average” plan that provides a level of benefit times the participant’s compensation for the year, historically with periodic updates to average compensation over a fixed five-year period. Effective January 1, 1996, the Plan was amended to update the benefit formula for service prior to 1996.

Benefits and Vesting (Concluded). At December 31, 2005, if a participant was less than 40 years of age or had less than 15 years of service, his or her benefit was frozen and he or she became a participant of the IDEX Defined Contribution Plan. If a participant was 40 years of age or older or had 15 or more years of service, he or she made a one-time election to either stay in the IDEX Corporation Retirement Plan or to enter the IDEX Defined Contribution Plan. Participants who elected to move to the IDEX Defined Contribution Plan, effective January 1, 2006, had their benefit under the IDEX Corporation Retirement Plan frozen effective December 31, 2005. Participants may elect to receive their pension benefits in various forms of joint and survivor annuities, include a lump sum payment option. In October 2016, the Plan offered participants the limited-time opportunity to elect to receive their pension benefits immediately in the form of a one-time lump sum or monthly annuity through the Immediate Pension Benefit Opportunity Program.

Effective September 30, 2019, the Plan was amended to freeze the accrual of retirement benefits for all participants.

Death and Disability Benefits. In addition to normal retirement benefits, the Plan provides for early and disability retirement benefits upon satisfaction of certain age and service requirements. Survivor's benefits are also payable in the event of death after certain age and service requirements are met.

Investments. The Company, as the Plan sponsor, appointed The Bank of New York Mellon/BNY Mellon, N.A. as trustee of the Plan (the "Trustee"). The IDEX Corporation Pension and Profit Sharing Committee (the "Committee") and the Plan Administrator control and manage the operations and administration of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared using the liquidation basis of accounting for the years ended December 31, 2022 and 2021.

Estimates and Assumptions. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Investment Valuation and Income Recognition. The fair value of the Plan's interest in the Master Trust is based on beginning of the year value of the Plan's interest in the trust plus actual contributions and allocated investment income less allocated contractual administrative expenses. The Master Trust's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurement. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits. Benefits are recorded when paid. There were no accounts outstanding for participants who elected to withdraw from the Plan at December 31, 2022 and 2021.

Administrative Expenses. Certain administrative expenses, including investment manager fees, are paid by the Plan and the Company, at its discretions, pays certain other expenses of the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Concluded)

Concentration of Credit Risk. Substantially all the Plan’s assets are held by The Bank of New York Mellon/BNY Mellon, N.A. (“BNY Mellon”). BNY Mellon is referred to herein as the “Trustee” and is a qualified institution pursuant to ERISA.

NOTE 3 – FUNDING POLICY

Contributions to provide benefits under the Plan are made solely by the Company. The Company’s funding policy is to make quarterly contributions to the Plan in amounts computed by the Plan’s independent actuary. No employee contributions are permitted. The Company met the minimum funding requirements in 2022 and 2021.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the unaudited information regarding the Plan, included in the Plan’s financial statements that was prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate:

- Investments, as shown in the statements of net assets in liquidation available for benefits as of December 31, 2022 and 2021.
- Net investment income, as shown in the statements of changes in net assets in liquidation available for benefits for the years ended December 31, 2022 and 2021.
- Notes 5 and 6: All investment balances.

NOTE 5 – INTEREST IN MASTER TRUST

The Plan’s investments are held in a trust account by the Trustee and consist of an interest in an investment account of the IDEX Corporation Master Retirement Trust (the “Master Trust”), a Master Trust established by the Company and administered by the Trustee. Use of the Master Trust permits commingling of trust assets of a number of pension plans of the Company for investment and administrative purposes. Although assets are comingled in the Master Trust, the Trustee maintains supporting records for the purpose of allocation of the net gain (loss) of the investment account to the various pension plans. The net assets and net gain (loss) on the account for each month is allocated by the Trustee to each participating plan based on the relationship of the interest of each plan to the total of the interest in all participating plans.

NOTE 6 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Master Trust assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Common Collective Trust Funds. The common collective trust funds are valued at the net asset value (“NAV”) or its equivalent of the funds, which is based on the fair value of the funds’ underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Interest-bearing Cash. Valued at cost plus accrued interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated July 21, 2020, that the Plan and related trust agreement used by the Plan in termination was designed in accordance with applicable sections of the Code.

NOTE 8 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments in the Master Trust are shares of mutual funds managed by the Trustee. The Trustee is the investment custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 9 – RISK AND UNCERTAINTIES

Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect amounts reported in the statements of net assets available for benefits.

In 2021, the Plan purchased annuities in the amount of \$50,392,000 as part of the termination of the Plan. The gain at Plan termination was \$10,133,316. This amount was directed to a qualified suspense account and be used to fund the DC benefit contributions for the Company's Savings Plan.

In 2022, insurance companies partially refunded the Plan for purchases of annuities in 2021. Refunds in the amount of \$1,063,320, along with earnings thereto, were distributed to the Company's Savings Plan and are included in Transfers from Plan on the Statement of Changes in Net Assets for the year ended December 31, 2022.

NOTE 11 – SUBSEQUENT EVENTS

Management has evaluated all known subsequent events from December 31, 2022 through October 13, 2023, the date the accompanying financial statements were available to be issued and is not aware of any material subsequent events that have not been disclosed in the notes to the financial statements.
