Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Sharpness Inc. 401(k) Profit Sharing Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedule of delinquent participant contributions and schedule of assets (held at end of year) as of and for the year ended December 31, 2022, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Notes to the Financial Statements

---

### (1) Description of Plan

The following description of the Sharpness Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Sharpness Inc. (Plan Sponsor), who have completed one year of service and have attained age 21. These eligibility requirements were waived for employees employed on January 1, 2017, the effective date of the Plan. Employees covered by a collective bargaining agreement, nonresident aliens and employees acquired as part of a merger/acquisition are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has adopted a prototype plan document that has been provided by Paychex Inc. The Plan's prototype plan document obtained its latest opinion letter on August 31, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with all applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

#### **Contributions**

Participants may contribute up to 92% of their gross compensation to the Plan annually, subject to the amounts allowed by Internal Revenue Service (IRS) regulations. Participants can elect to make pretax contributions, Roth contributions or a combination of both. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

In addition, the employer makes matching contributions equal to 100% of employee elective deferrals up to 2% of eligible compensation.

#### **Participant Accounts**

Each participant's account is credited with the participant's elective and rollover contributions, employer matching contributions and an allocation of Plan earnings (losses) and charged with an allocation of administrative expenses. Allocation of the employer's matching contributions is based on participant contributions. Because all accounts are 100% participant directed, Plan earnings are attributable to the investments selected by each participant and allocated to each participant in a manner that reflects the investment experience of each participant's directions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

As of December 31, 2022 and 2021, there were no amounts allocated to the accounts of terminated participants who had requested distributions but had not yet been paid.

#### **Vesting**

Participants are immediately vested in their entire account balance.

### (1) Description of Plan

#### Investment Options

Participants direct the investment of their contributions among several registered investment companies (mutual funds) offered by the Plan. Participants may change their investment elections between those various options as often as they wish.

#### Payment of Benefits

If a participant's account balance is more than \$5,000 at the time of termination of service, the participant may elect to receive a lump-sum payment or installment payments of their account balance. Distributions of account balances \$5,000 or less can be made without the participant's consent.

In-service distributions are permitted in the event of a qualified financial hardship or upon attaining age 59-1/2.

### (2) Summary of Significant Accounting Policies and Other Matters

#### Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities and the reported changes in net assets available for plan benefits.

#### Financial Instruments and Concentration of Credit Risk

The Plan's investments subject the Plan to concentrations of credit risk in that substantially all of those investments are held by Mid Atlantic Trust Company. Following customary practices, the Plan does not hold collateral for investments made through this source. The maximum potential credit loss to the Plan is limited to total Plan investments as shown on the accompanying statement of net assets available for plan benefits.

#### Valuation of Investments

Investments in registered investment companies are valued using quoted market prices.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the historical cost method. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Net appreciation (depreciation) in fair value of investments is reflected in the statement of changes in net assets available for plan benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next.

#### Payment of Benefits

Benefits are recorded when paid.

## Notes to the Financial Statements

### (2) Summary of Significant Accounting Policies and Other Matters

#### Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for plan benefits. All administrative expenses are charged to participant accounts.

#### Third-Party Fee Agreements

In addition to the administrative fees deducted from net assets on the face of the statement of changes in net assets available for plan benefits, the various investment providers to the Plan retain investment earnings to help cover the cost of operating the funds. These fees, which were less than 1% of investments for the years ended December 31, 2022 and 2021, have been netted against investment income.

#### Income Tax Status

Plan management is required to evaluate tax positions taken by the Plan and disclose a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, as of December 31, 2022 and 2021, there were no audits for any tax periods in progress.

### (3) Investments

The Plan's investments were held by Mid Atlantic Trust Company, which has provided the Plan with certifications that the information below is complete and accurate.

### (3) Investments

The Financial Accounting Standard Board Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly; and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

#### Level 1 Fair Value Measurements

The fair value of registered investment companies are based on quoted net asset values of the shares held by the Plan at year end.

#### Level 2 Fair Value Measurements

No investments are measured using Level 2 inputs.

#### Level 3 Fair Value Measurements

No investments are measured using Level 3 inputs.

### (5) Related-Party and Party-in-Interest Transactions

The Plan Sponsor did not pay any fees on behalf of the Plan during the years ended December 31, 2022 and 2021. In addition, the Plan Sponsor provides management and participant data services to the Plan at no charge.

The Plan directly enters into party-in-interest transactions with service providers, including third-party administrators, investment advisors and auditors. Such transactions resulted in administrative fees as reflected in the statement of changes in net assets available for plan benefits.

All stockholders of the Plan Sponsor are also participants in the Plan. One of the stockholders of the Plan Sponsor is also the Limited Trustee of the Plan

### **(6) Risk and Uncertainties**

The Plan invests in various registered investment companies. These investments are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right at any time to terminate the Plan subject to the provisions of ERISA.

### **(8) Subsequent Events**

Management has evaluated subsequent events through October 2, 2023, the date which the financial statements were available to be issued.

On June 20, 2023, the Plan joined the Paychex Pooled Employer 401(k) Plan (employer identification number 85-3275179, plan number 001). The trustee of the Plan and major plan provisions remained the same.
