We have performed audits of the financial statements of the Bravo Wellness, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 1, 2023 and December 31, 2022 and 2021, the related statements of changes in net assets available for benefits for the period ended January 1, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter—Plan Merger

As discussed in Note 1 to the financial statements, the Pension Investment Committee of Medical Mutual of Ohio, the Plan's sponsor, approved to merge the net assets of the Plan related to employees of Bravo Wellness, LLC into the Medical Mutual of Ohio Employees' Retirement Savings Plan effective January 1, 2023. All plan assets were transferred to the Medical Mutual of Ohio Employees' Retirement Savings Plan on January 1, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Notes to Financial Statements

Note 1. Description of the Plan

The following description of Bravo Wellness, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established and sponsored by Bravo Wellness, LLC (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). In 2021, Bravo Wellness, LLC was acquired by Medical Mutual of Ohio and the plan sponsor was changed to Medical Mutual of Ohio (the Plan Sponsor). Effective January 1, 2022, the Plan covers substantially all employees of Bravo Wellness, LLC not covered by a collective bargaining agreement, leased, reclassified or employees whose compensation is paid by a third party. Temporary employees and interns are eligible after completing 1,000 hours of eligibility service in a Plan year ending December 31. Entry into the plan is immediate upon becoming eligible.

On December 29, 2022, the Medical Mutual of Ohio Pension Investment Committee, serving as the Plan Administrator, adopted a resolution, effective January 1, 2023, to merge the Plan with Medical Mutual of Ohio Employees' Retirement Savings Plan. Effective on January 1, 2023, participant investments of the Plan were transferred in-kind into the Medical Mutual of Ohio Employees' Retirement Savings Plan, resulting in a transfer into the Plan of \$4,212,347, which has been disclosed as such on the Statement of Changes in Net Assets Available for Benefits for the period ended January 1, 2023.

Administration and trustee: The Plan is administered by the Medical Mutual of Ohio Benefits Administration Committee (the Committee) comprised principally of management. The Committee appointed Fidelity Management Trust Company (Fidelity) as trustee of the Plan. Fidelity is designated as the trustee and investment manager of the Plan. Fidelity holds all contributions made to the Plan and allocates the amounts among various investment alternatives as directed by participants. An affiliate of Fidelity is recordkeeper of the Plan.

Contributions: Each year, participants may contribute up to 75% of annual compensation, as defined in the Plan, on a pre-tax or after-tax basis. New employees are given a 35-day grace period to opt in or out of the Plan before they are automatically enrolled with a contribution equal to 5% of annual compensation. Before the effective date of the automatic enrollment, a notice is provided to allow participants the opportunity to revoke or modify the deemed salary deferral agreement. Participant contribution deferrals are subject to an automatic annual increase of 1% up to a maximum of 10%, unless disabled by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan is a discretionary safe-harbor plan. For the year ended December 31, 2022, no safe harbor contributions or profit sharing contributions were made. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and Company safe harbor contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor and profit sharing contributions is also immediate.

Notes to Financial Statements

Note 1. Description of the Plan (Continued)

Effective January 21, 2021, participants are immediately vested in the Company's profit sharing contribution.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest loan balance during the past 12 months. The loans are secured by the balance in the participants' account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the loan is for a principal residence in which case the loan may be repaid over a period not to exceed 10 years.

Payment of benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or a direct rollover to a qualified retirement account equal to the value of the participant's vested interest in his or her account.

Terminated participants with vested account balances less than \$5,000 but greater than or equal to \$1,000 will automatically have their vested account balance rolled into an individual retirement account unless they otherwise instruct the third-party administrator and take a lump-sum distribution as soon as practicable following termination. Terminated participants with vested account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

Forfeited accounts: At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$3,930 and \$5,117, respectively. These amounts will be used to reduce future employer contributions and pay plan expenses. During 2022, \$1,186 of forfeitures were used to pay plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan holds units in the T. Rowe Price Stable Value Common Trust Fund P (the Fund), a common/collective trust, which invests in fully benefit-responsive investment contracts. The Fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. Were the Plan to initiate a full redemption of Fund units, the trustee reserves the right to temporarily delay withdrawal from the Fund to ensure that securities liquidations will be carried out in an orderly business manner.

All other investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion and disclosures related to fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Realized gains or losses on the sale of investments are computed on the specific identification basis. Net changes in appreciation or depreciation of investments are combined with realized gains or losses and are reflected as net depreciation in fair value of investments in the statements of changes in net assets available for benefits.

Notes receivable from participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest, which ranges from 3.25% to 6.5% at December 31, 2022. Notes receivable have various maturities through September 2026 at December 31, 2022. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Benefit payments: Benefit payments to participants are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administration, recordkeeping and financial advisor fees are included in administrative expenses. Investment related expenses are included in net depreciation on fair value of investments.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 12, 2023, the date these financial statements were issued.

Note 3. Information Certified and Provided by Fidelity

The following is a summary of the Plan's asset information as of December 31, 2022 and 2021, and for the year ended December 31, 2022, included throughout the Plan's financial statements and ERISA required supplemental schedule, obtained by management and agreed to or derived from information certified by Fidelity (the Trustee). The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

The Trustee also certified to the completeness and accuracy of the investment results information (including investments bought, sold and held during the year) and interest income on notes receivable from participants for the year ended December 31, 2022, included on the accompanying statements of changes in net assets available for benefits.

Note 4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described below:

Level 1: Values are unadjusted quoted prices for identical assets in active markets accessible at the measurement date.

Level 2: Inputs include quoted prices for similar assets in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads, and yield curves.

Level 3: Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the Plan's best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in valuation methodologies at December 31, 2022 compared to December 31, 2021.

The following is a description of the valuation methodologies used for Plan assets measured at fair value:

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at amortized cost, which approximates fair value.

Common collective trust: Valued at the NAV of units held by the Plan at year end. The net asset value of units held by the Plan is based on the most recent bid prices in the principal market in which such securities are normally traded for underlying securities for which notations are readily available and for underlying securities for which qualifications are not readily available. See Note 2 for further information regarding common/collective trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party and Party-in-Interest Transactions

The Plan holds interests in registered investment companies managed by Fidelity. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. The fees paid to Fidelity during the year ended December 31, 2022, were \$13,141. The Plan also maintains notes receivable from participants which are exempt from prohibited transaction rules.

Note 5. Related-Party and Party-in-Interest Transactions (Continued)

Per the recordkeeper agreements, Fidelity is authorized to receive compensation for the record keeping and shareholder services they provide to certain funds in the form of annual distribution fees or shareholder servicing fees. Any fees received by Fidelity related to the Plan's investments in excess of the revenue threshold, in accordance with its revenue sharing arrangement, are deposited on a quarterly basis back into an administrative budget account, from which certain administrative expenses for the Plan are paid. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

The Company also provides certain accounting, record keeping and administrative services to the Plan for which it is not compensated.

Note 6. Tax Status

The Plan has adopted a volume submitter plan sponsored by Fidelity. The volume submitter plan provider has received an advisory letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
