Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of Controlled Products, LLC Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for more complete descriptions of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Controlled Products, LLC (CP). The Plan covers employees of CP and the following affiliated companies, Synthetic Turf International, LLC, effective January 10, 2010, and Path to Prosperity, LLC, effective January 1, 2021 (collectively the "Company"). The Plan was restated on February 17, 2022, and a pre-approved plan of Principal Life Insurance Company was adopted. The Plan provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan upon reaching one month of employment. Employees are also eligible to receive employer contributions as of the eligibility date. Employees, once meeting the service requirement, are eligible to participate in the Plan as of the day the entry requirements are satisfied.

Contributions

Each year, participants may contribute Roth and pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). For the year ended December 31, 2022, the maximum contribution allowed by an employee under 50 years of age is \$20,500. For an employee at or over 50 years of age, the maximum contribution allowed is \$27,000.

The Company provides a safe harbor match equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. Additionally, any person who was an active participant at any time during the Plan year dies, has a severance of employment after reaching normal retirement age, or has become disabled while performing qualified military service during the plan year, would be eligible for Company match contributions. The matching Company contribution is invested as directed by the participant.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 - DESCRIPTION OF PLAN

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, safe harbor match and allocation of Plan earnings (losses) reduced by administrative expenses which are allocated proportionately among all participants based on their investment in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The vesting percentage for a participant who is an employee on or after the date he reaches normal retirement age or early retirement age shall be 100%. The vesting percentage for a participant who is an employee on the date he dies or the date he becomes disabled shall be 100%. Beginning March 31, 2014, the vesting percentage shall also be 100% for a participant who dies or becomes disabled while performing qualified military service.

All elective deferral contributions, qualified matching contributions, and qualified nonelective contributions are 100% vested.

Payment of Benefits

The Plan allows participants to make two withdrawals of vested account balances in a 12 month period. On termination of service due to death, disability, retirement, early retirement at age 55, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments under a variety of annuity forms available for election by the participant or beneficiary. Additionally, if the vested account is \$5,000 or less, the vested account will be paid in a lump-sum.

The Plan allows participants to acquire a hardship withdrawal to satisfy an immediate and heavy financial need. Participants may withdraw up to the value of the participant's contributions in his or her account and attributable earnings. In addition, the Plan allows withdrawals for participants who meet the requirements to have a qualified reservist distribution.

Forfeitures

At December 31, 2022 and 2021, there were no amounts forfeited from non-vested accounts. Forfeitures may be used to reduce future Company contributions. There were no forfeitures used to reduce Company contributions for the year ended December 31, 2022.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions which affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (not including investment in fully-benefit insurance contracts, more fully described in Note 5). Fair value is the price which would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Plan’s administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain administrative functions are performed by the employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions are charged directly to the participant’s account. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Insurance Company (the custodian of the Plan). This information has not been audited by the Plan's independent auditors.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan utilizes Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements*. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have highest priority, Level 2 inputs consist of quoted prices for similar assets or identical assets that are not active, and Level 3 inputs are unobservable and have lowest priority. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices which are observable for the asset or liability; and d) inputs derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input which is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2022 and 2021:

Pooled Separate Accounts: Investments are valued at net asset value, and held in pooled separate accounts through sub-accounts of an insurance company. The underlying securities in pooled separate accounts are listed on national securities and valued on the basis of year-end closing prices. While the underlying assets are actively traded on an exchange, the pooled separate accounts are not and, therefore, are classified as Level 2 investments.

NOTE 4 – FAIR VALUE MEASUREMENTS

Mutual Funds: Shares held in mutual funds are listed on national security exchanges and are valued at quoted market prices which represent the net asset value (“NAV”) held by the Plan at year-end. It is not probable the shares of registered investment companies will be sold at amounts which differ materially from the NAV of shares held. The mutual funds held by the Plan are deemed to be actively traded (Level 1) investments.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company. Principal Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and the crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Trust Company represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – TAX STATUS

The Plan sponsor adopted a pre-approved non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan has been amended since receiving the opinion letter. Although the Plan was restated on February 17, 2022, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

NOTE 6 – TAX STATUS

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken which would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PARTY-IN-INTEREST

Certain Plan investments are managed by Principal Life Insurance Company, the Trustee for the Plan, and Principal Global Investors Trust Company, an affiliate of Principal Life Insurance Company, and therefore, these transactions qualify as exempt party-in-interest transactions.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – SUBSEQUENT EVENTS

The Plan assessed events that have occurred subsequent to December 31, 2022 through October 6, 2023 for potential recognition and disclosure in the financial statements.

Effective July 1, 2023, the Company merged the plan into The Recreational Group Holdings, LLC 401(k) Plan. All participants became 100 percent vested in employer contributions upon rollover into the new plan.

No other events have occurred that would require adjustment to or disclosure in the financial statements which were available to be issued on October 6, 2023.
