Opinion on the 2022 Financial Statements

We have audited the financial statements of Carl Warren & Company Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits (*in liquidation*) as of December 30, 2022, and the related statement of change in net assets available for benefits (*in liquidation*) for the period January 1, 2022 to December 30, 2022, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 30, 2022, and the changes in net assets available for benefits for the period January 1, 2022 to December 30, 2022 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Terminating Plan

As described in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation on January 31, 2019, and management determined liquidation is eminent. In accordance with accounting principles generally accepted in the United States of America, the 2022 and 2021 financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2022 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2022 Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our report dated October 17, 2022, as permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). Management obtained a certification from a qualified institution as of and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate. In our opinion, based on our audit:

- The amounts and disclosures in the 2021 accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Carl Warren & Company Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for complete information.

General

The Plan became effective January 1, 1975, to provide retirement benefits for the employees of Carl Warren & Company and its subsidiary (the “Plan Sponsor”). The Plan is an employee stock ownership plan (ESOP) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a defined contribution plan covering all eligible employees of the Plan Sponsor and is not leveraged.

Alerus Financial, N.A. serves as the Trustee and Custodian of Plan assets.

Plan Termination

On January 31, 2019, the Plan entered into a stock purchase agreement with a third party to sell the 122,688 shares of Plan Sponsor common stock owned by the Plan (the “Transaction”). The shares were acquired by the third party for a total purchase price of \$10,454,818. In connection with the acquisition, the governing body of the Plan approved a plan of liquidation on January 31, 2019. The Plan was formerly terminated on August 27, 2020. In addition, the Plan was amended for the following:

- To transfer sponsorship of the Plan to Claims Technology Group of America as of August 27, 2020;
- To provide that no new participants are to be admitted to the Plan as of August 27, 2020;
- To discontinue Plan Sponsor contributions to the Plan as of January 31, 2019;
- To provide that participants who have not incurred a five-year consecutive-year break in service or received a complete distribution of their vested benefit as of January 31, 2019 will become 100% vested in their account balances as of that date; and
- To permit the distribution of 85% of the accounts of participants after the close of the Transaction and to provide that the remaining participant account balances will be distributed after receipt of the favorable determination letter from the IRS. The letter was received May 17, 2021.

All Plan assets were liquidated to participants on December 30, 2022.

Eligibility

Employees age twenty-one (21) years or older who are not members of a collective bargaining unit are eligible to participate in the Plan once they have completed one year of service with at least 1,000 hours of service. As disclosed under “Plan Termination”, the Plan was amended to provide that no new participants will be admitted to the Plan as of August 27, 2020.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Vesting

Plan Sponsor contributions and gains/losses credited thereon vest on a six-year schedule as follows:

Less than 2 years credited service	0%
After 2 years credited service	20%
After 3 years credited service	40%
After 4 years credited service	60%
After 5 years credited service	80%
After 6 years credited service	100%

For vesting purposes, participants must work at least 1,000 hours of service in each Plan year. In the event of a currently employed participant's death or disability, benefits become 100% vested. As disclosed under "Plan Termination", the Plan was amended to provide that participants who have not incurred a forfeiture or received a complete distribution of their account balance as of January 31, 2019 will become 100% vested in their account balances as of that date.

Normal Retirement

Normal retirement age is defined as the earlier of the participant's attainment of age sixty-two (62) with 15 years of service, or the participant's attainment of age sixty-five (65).

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive a distribution equal to the value of the participant's vested account balance. Benefit payments are paid to participants in either a lump-sum payment or six substantially equal installments which is determined based on date and cause of termination and account balance. Benefit payments are paid in the form of cash.

Diversification

Participants who reach the age of fifty-five (55) with 10 years of participation in the Plan have the ability to diversify up to 25% each year of the Plan Sponsor shares allocated to their accounts based on the diversification formula in the Plan. The ability to make such an election extends until age sixty (60), at which time participants may elect to diversify up to 50% of the Plan Sponsor shares in their accounts. If participants decline the election at that point, they have no further ability to diversify the Plan Sponsor stock in their accounts. The Plan is permitted to distribute the amounts eligible for diversification in lieu of providing other investment options.

Contributions and Allocations

Plan Sponsor contributions to the Plan are determined by the Plan Sponsor's Board of Directors. Employee contributions to the Plan are not permitted. Plan Sponsor made no contributions for the period ended December 30, 2022 and the year ended December 31, 2021. As disclosed under "Plan Termination", the Plan was amended to discontinue Plan Sponsor contributions to the Plan as of January 31, 2019.

Plan Sponsor contributions and Plan forfeitures are allocated to each active participant's account based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. Participants must be credited with a minimum of 1,000 hours of service during the Plan year and be employed with the Plan Sponsor on the last day of the Plan year to receive an allocation of Plan Sponsor contributions and Plan forfeitures. The Plan's earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

NOTE 1: DESCRIPTION OF PLAN (Continued)

Administration of Plan Assets

The Plan is administered by an ESOP Administrative Committee comprised of three to seven members appointed by the Plan Sponsor's Board of Directors.

The Plan's investments are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No officer or employee receives compensation from the Plan. Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, at the discretion of the Plan Sponsor.

Participants' Voting Rights

Participants have limited voting rights attributable to the shares allocated to their accounts and are notified by the Trustee prior to the time that such rights are to be exercised. The participants are given the right to vote on certain corporate matters, as defined by the Plan document.

Forfeitures

Forfeitures of the unvested balances of terminated participants are reallocated to the remaining active participants. As disclosed under "Plan Termination", the Plan was amended to provide that participants who have not incurred a forfeiture or received a complete distribution of their account balance as of January 31, 2019 will become 100% vested in their account balances as of that date. There were no forfeitures remaining in 2022 or 2021.

Stock Purchase Requirement

Under federal income tax regulations, the Plan Sponsor stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Plan Sponsor buy any shares of stock distributed to participants for which there is no market and to ensure that participants have the ability to ultimately obtain cash. The put price is representative of the current appraised value of the stock.

Plan Termination

The Plan Sponsor may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination participants will become 100% vested in their account balances. The Plan was terminated effective August 27, 2020.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan's financial statements are presented using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") as a result of the Plan termination.

Benefits

Benefits are recorded when paid.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value and are non-participant directed. Investments in securities are stated at fair market value using quoted market prices when available. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Investments are valued daily.

Income Taxes

The Plan obtained a favorable determination letter on May 17, 2021, in which the Internal Revenue Service (IRS) stated that the termination of the Plan does not affect its qualification under the Internal Revenue Code.

Plan management evaluates tax positions taken by the Plan to recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has determined that as of December 30, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities and there are currently no examinations for any tax periods in progress.

Use of Estimates

The preparation of financial statements, in conformity with U.S. GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 4: FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 30, 2022 and December 31, 2021.

Money Market Fund: Underlying short-term investments with quoted prices in active markets to preserve the value of the investment at \$1.00 per share.

NOTE 6: ACCRUED ADMINISTRATIVE EXPENSES

In accordance with the liquidation basis of accounting, the Plan accrued estimated costs expected to be incurred during the dissolution of the Plan. The Plan Sponsor estimated that the Plan will incur and pay costs through December 30, 2022, the date all assets of the Plan were distributed, for administrative expenses in the amount of \$110,023. As a result, a total of \$110,023 has been recorded in accrued liabilities on the statement of net assets available for benefits as of December 31, 2021. These expenses were paid in 2022.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fees for investment management and administrative services are paid to the trustee and third-party administrator of the Plan. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 9: SUBSEQUENT EVENTS

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2023, the date the financial statements were available to be issued, and management determined that no subsequent events have occurred that should be recorded or disclosed.
