### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Penn Jersey Paper Company Defined Contribution Plan for Union Local 107 Unit A Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## (1) Description of Plan

The following brief description of the Penn Jersey Paper Company (the Company) Defined Contribution Plan for Union Local 107 Unit A Employees (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan covering all employees that are members of the International Brotherhood of Teamsters Union, Local 107 A. Employees are eligible to enroll in the Plan on the first day of each calendar month beginning after their hire date. The participant must have completed 18 consecutive months of employment in order to be eligible to receive the employer contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

The Plan was amended and restated as of June 1, 2021 to incorporate prior amendments.

### *Contributions*

Participants may contribute up to 15% of pretax annual compensation, as defined by the Plan, subject to the federal maximum of \$20,500 and \$19,500 for 2022 and 2021, respectively. Participants who have attained age 50 before the end of the plan year may also make a catch-up contribution of up to \$6,500 for the years ended December 31, 2022 and 2021. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may direct (a) their contributions and (b) employer contributions into various investment options. Participants may change their investment options daily.

The Company is required to contribute amounts under a collective bargaining agreement. During each Plan Year, the Company will make Employer Contributions on behalf of each Participant in the amount and manner described in the Plan Document. Employer contributions are made to the Plan on a weekly basis and are based on each Participant's mandatory contribution rate multiplied by the total number of regular hours he/she worked during the particular week. Employer contributions for overtime hours worked shall be calculated at 1.5 times such Participant's mandatory contribution rate.

## (1) Description of Plan, Continued

### *Participant Accounts*

Each participant's account is credited with the (a) participant's contributions, (b) employer contributions, and (c) an allocation of the Plan's earnings or losses. Participant accounts may also be charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or losses, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are immediately vested in their contributions and employer contributions plus actual earnings thereon.

### *Notes Receivable from Participants*

Participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balances not to exceed \$50,000. Loan terms may vary as determined by the plan administrator, to a maximum of five years (unless such loan is used to acquire a principal residence). The loans are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%. Interest rates on outstanding loans range from 3.25% to 8.00%. Principal and interest are paid ratably through regular payroll deductions.

### *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant may take their benefit in a lump sum.

### *Withdrawals*

Participants under age 59½ may withdraw all or part of their account in cases of hardship. Participants over age 59½ may make a one-time lump sum withdrawal from their account for any reason.

## (2) Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting.

## (2) Summary of Significant Accounting Policies, Continued

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

All administrative expenses of the Plan are paid for by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued.

### (3) Certified Financial Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and contract value, and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from the information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (Voya).

### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**(4) Fair Value Measurements, Continued**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

**(5) Investment Contract with Insurance Company**

The Plan has a fully benefit-responsive investment contract with Voya totaling \$268,072 and \$353,642 at December 31, 2022 and 2021, respectively. Voya maintains the amounts allocated to the contract in a separate investment account. The account is credited with contributions and earnings in the underlying investment and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based upon a formula agreed with the issuer but may not be less than 3%. The interest rate is reviewed on an annual basis for resetting. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### **(5) Investment Contract with Insurance Company, Continued**

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the Plan contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with participants, are probable of occurring.

### **(6) Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are managed by Voya and Voya acts as trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments.

### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### (8) Tax Status

The Plan uses a volume submitter sponsored by FIS Business Systems LLC (FIS). The Internal Revenue Service (IRS) has determined and informed FIS by a letter that the volume submitter document and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (9) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
