Note 1 - Plan Description

The following description of Vosges Holdings, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Vosges Holdings, LLC (the "Company") who have completed 1,000 hours of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions of a percentage of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions in addition to their regular deferral contributions. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for discretionary employer matching contributions in an amount determined by the Company. The Company did not make a discretionary employer matching contribution during 2022.

The Plan also provides for discretionary nonelective employer contributions. The Company did not make a nonelective employer contribution in 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Vesting in the Company's discretionary employer matching contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in discretionary matching contributions made by the Company 20 percent after one year of service and another 20 percent per year thereafter until they become fully vested after five years of service.
