Independent Auditor's Report

To the Plan Administrator

Opinion

We have audited the accompanying financial statements of IMG Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of IMG Welfare Benefit Plan as of December 31, 2022 and 2021, and the changes in its net assets available for benefits for the year ended December 31, 2022, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of IMG Welfare Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination

As discussed in Note 1 to the financial statements, effective December 27, 2022, the Board of Directors of the Employer passed a resolution to close the Plan's trust account and claims going forward will be paid out of the Employers' general account. In addition, effective December 31, 2022, all coverages of the Plan ceased, and the participants were eligible to participate in the health and other benefits plans offered by Sirius RE Holdings Inc.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, including determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTES TO FINANCIAL STATEMENTS
December 31, 2022 and 2021

NOTE 1 - DESCRIPTION OF PLAN

The following description of IMG Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan was organized, effective July 1, 2000, to provide certain health and other benefits covering all employees of International Medical Group, Inc. (the Employer) working 30 hours or more per week, and their eligible dependents and domestic partners. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees (appointed by the Board of Directors) are responsible for oversight of the Plan and serve as the Plan Administrator.

Plan Termination: The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, the Plan Trustees are required to compute the value of the trust and will retain, distribute or transfer the assets. No part of the corpus or income can be used for the benefit of the Employer.

Effective December 27, 2022, the Board of Directors of the Employer passed a resolution to close the Plan's trust account and claims going forward will be paid out of the Employers' general account. In addition, effective December 31, 2022, all coverages of the Plan ceased, and the participants were eligible to participate in the health and other benefits plans offered by Sirius RE Holdings Inc.

Contributions: Participants made contributions to the Plan based on monthly premiums for benefits they had elected. Participant contributions were primarily made through payroll deductions. The Employer was required to make contributions to provide the Plan with sufficient funds to pay all claims and other benefits provided under the Plan, and the expenses of administering the Plan.

Participants and former participants could make contributions at various participation rates as determined by the Employer. Participant contributions also included Consolidated Omnibus Budget Reconciliation Act (COBRA) insurance premium payments.

The Plan provided participants who elected a high deductible plan to contribute to a Health Savings Account (HSA). Additionally, the Employer had elected to make an annual discretionary contribution of \$1,000 for individuals and \$2,000 for couples of a family allocated into two payments. The first half of contributions were funded for all employees who were active on January 1, 2022. The second half of employer contributions were funded in July provided the respective employee was still actively employed and met the wellness criteria, i.e. proof of physical. Contributions to the HSA were 100% pre-tax. Interest earnings accumulated tax-deferred, and if used to pay for qualified medical expenses, were tax-free. Any unused money was not forfeited at the end of the year and could be rolled over to the following year.

The Plan also provided participants the ability to enroll in a Flexible Spending Account (FSA) in order to save money to pay for qualified expenses. FSA contributions were made through payroll withholding and covered services, as defined, were paid directly by the participant.

Total HSA and FSA contributions for the year ended December 31, 2022, were \$691,730.

Benefits: The Plan provided health and welfare benefits which included medical, prescription drug, dental, vision, term life, short-term disability, and long-term disability insurance to employees of the Employer and their covered dependents. Medical, prescription drug, and short-term disability benefits were self-insured. All other benefits were fully insured.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

The Plan also provided continuation of certain benefits upon termination of employment or loss of coverage in certain circumstances through COBRA.

The Plan's participants and their dependents were protected from catastrophic medical claims through the Plan's purchase of a stop-loss insurance policy, which covered claims in excess of specified amounts on an annual individual basis and on an annual aggregate basis.

Cash Accounts: The Plan's cash was maintained in bank deposit accounts which, at times, could exceed federally insured limits. The Plan did not experience any losses related to these accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions are recognized when received, rather than when earned, and benefits and expenses are recognized when paid, rather than when the obligation is incurred. Although the modified cash basis represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the requirements of ERISA.

Estimates: The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Health and prescription drug claims submitted for participants and their dependents and beneficiaries were processed by Anthem Insurance Companies, Inc. (Anthem), dental claims were processed by Delta Dental Plan of Indiana, Inc. (Delta Dental) and vision claims were processed by EyeMed Vision Care (EyeMed). However, the responsibility for payments to participants and providers was retained by the Plan.

Benefits were recorded when paid.

Expenses: Administrative expenses for maintaining the Plan were paid by the Employer or by the Plan, at the Employer's discretion.

Tax Status: The trust utilized to hold the Plan's net assets was a grantor trust established under the applicable requirements of the Internal Revenue Code (IRC). The plan sponsor is responsible for income taxes on investment income when the Plan is determined to be overfunded as defined by the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt. See Note 1 regarding the trust being terminated.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in process.

Subsequent Events: The Plan Administrator has evaluated the financial statements for subsequent events occurring through October 13, 2023, the date the financial statements were available to be issued.

NOTE 3 - BENEFIT OBLIGATIONS

Plan obligations for claims payable and claims incurred but not reported for self-insured benefits are estimated to be approximately \$0 and \$486,000 at December 31, 2022 and 2021, respectively.

NOTE 4 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Anthem Insurance Companies, Inc. and/or its affiliates were the Plan's third-party administrators for the processing of self-funded health and prescription claims. Delta Dental Plan of Indiana, Inc. (Delta Dental) was the Plan's third-party administrators for the processing of dental claims. During 2022, administrative expenses paid by the Plan to Anthem and Delta Dental totaled \$197,255 and \$16,707, respectively.

Prudential Life Insurance Company of America (Prudential) provided insurance policies for short-term and long-term disability and life insurance benefits and receives insurance premiums from the Plan. The Employer administered the Plan's short-term disability at no cost to participants. During 2022, administrative expenses paid by the Plan to Prudential totaled \$7,503.

The Employer provided certain accounting and administrative services to the Plan for which it received no compensation.

NOTE 5 - STOP-LOSS INSURANCE CONTRACT

Under a contract with an insurer, self-funded health claims for participants and their dependents in excess of \$175,000 per participant on an annual basis and aggregate annual claims in excess of approximately \$5,314,000, as defined, were reimbursed to the Plan by the insurer.

NOTE 6 - RISKS AND UNCERTAINTIES

In March 2010, the Patient Protection and Affordable Care Act and the Health Care and Education Affordability Reconciliation Act were enacted into law. Provisions included in this health care reform legislation impact the Plan by requiring changes in health care design, funding and pricing structure. The legislation includes insurance reforms, requirements to provide essential health benefits, extension of dependent coverage until 26 years of age and elimination of lifetime limits and restriction of annual limits. The Plan's management continues to assess the impact that compliance with this health reform legislation has on the Plan's operations.
