Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BluSky Restoration 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of the Plan

General

The following description of BluSky Restoration 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by BluSky Restoration Contractors, LLC, (the Company) for the benefit of substantially all of its employees who have completed three months of service and are age 18 or older. An employee must be an active participant on the last day of the plan year in order to be eligible to receive company profit-sharing contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Company is the plan administrator. Two executives of the Company serve as the trustees of the Plan. The Plan's custodian is Capital Bank and Trust Company (CBTC).

Effective January 1, 2023, the Plan was restated and merged into the SuccessWise Pooled Employer Plan (Successor Plan) and the Company became a participating employer in the Successor Plan. In connection therewith, the Plan's assets were transferred to the Successor Plan during January 2023. As the transfer commenced prior to January 1, 2023, the Plan's investments were liquidated during December 2022 and the proceeds thereof are reflected as "cash in transit" on the accompanying 2022 statement of net assets available for benefits.

During 2021, the Company acquired J.C. Restoration, LLC (JCR), which sponsored a 401(k) Plan (JCR Plan). Additionally, during 2021, the Company acquired Menold Construction, LLC (Menold), which also sponsored a 401(k) Plan (Menold Plan). On June 24, 2022, the JCR Plan was merged into the Plan, and on September 9, 2022, the Menold Plan was merged into the Plan. In connection therewith, an aggregate of \$711,554 was transferred into the Plan from the JCR Plan and an aggregate of \$1,479,948 was transferred into the Plan from the Menold Plan, which are included within "plan transfers in" on the statement of changes in net assets available for benefits for the year ended December 31, 2022.

During 2019, the Company acquired Sharp, Robbins & Popwell, LLC (SRP), which sponsored the Sharp, Robbins & Popwell, LLC 401(k) Plan (SRP Plan). On April 29, 2021, the SRP Plan was merged into the Plan. In connection therewith, an aggregate of \$2,944,494 was transferred into the Plan from the SRP Plan, which is included within "plan transfers in" on the statement of changes in net assets available for benefits for the year ended December 31, 2021.

Contributions

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 100% of eligible compensation. Employee rollover, catch-up, and Roth contributions are also permitted. The Company is required to make safe-harbor matching contributions equal to 100% of the employee's elective deferrals that do not exceed 3% of the employee's compensation for the plan year, plus 50% of the employee's elective deferrals that exceed 3%, but do not exceed 5% of the employee's compensation for the plan year. Profit-sharing contributions may be contributed at the option of the Company's Board; however, there were no profit-sharing contributions made in 2022 and 2021. The Company will make a prevailing wage contribution in an amount necessary to meet the Company's requirements under an applicable prevailing wage statute; however, such prevailing wage allocations will offset any profit-sharing contribution allocations otherwise allocable to a participant. During 2022 and 2021, the Company did not make any prevailing wage contributions. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. However, the Company did not elect to utilize this feature in 2022 or 2021.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings, and is charged with an allocation of investment and administrative expenses. An individual participant's account is charged a fee for certain participant-initiated transactions, such as the ongoing maintenance of notes receivable from participants. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus earnings thereon, and the Company's safe-harbor matching contributions, plus earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service. The nonvested balance is forfeited upon termination of service.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years through payroll withholdings unless the participant is paying the loan in full. Loans for purchase of a primary residence may have a term of up to 30 years. Interest on the loans is based on the prime rate listed in the *Wall Street Journal*, plus 2.0%.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her account, installment payments, or may choose to maintain the account in the Plan and continue to share in investment earnings.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$1,175 and \$14,529, respectively. Forfeitures may be used to reduce employer contributions or pay expenses of the Plan. During the years ended December 31, 2022 and 2021, forfeitures of \$28,634 and \$10,102, respectively, were used to reduce employer contributions, and forfeitures of \$12,052 and \$0, respectively, were used to pay expenses of the Plan.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought, sold and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Pension Profit Sharing Services, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statements date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3: Certification of Plan Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, CBTC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2022 and 2021
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits and related disclosures for the years ended December 31, 2022 and 2021
- Notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Related-party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain investments managed by affiliates of CBTC, and invested in certain investments managed by Principal or its affiliates; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. During 2022 and 2021, individually nonmaterial expenses paid to parties-in-interest aggregated \$230,479 and \$83,168, respectively.

Additionally, the Plan incurs expenses related to general administration and record keeping, and for certain accounting and auditing fees relating to the Plan. The Company pays these expenses and performs certain administrative functions at no cost to the Plan.

Note 5: Plan Amendments

During 2022, in addition to the restatement and merger (Note 1), the Plan was amended to provide for force-out distributions of small accounts, add a special participation rule for employees of entities acquired by the Company in a stock purchase, and to expand the definition of an eligible employee.

Note 6: Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Recurring Measurements

As of December 31, 2022, the Plan had no investments measured at fair value (see Note 1). The following tables present the fair value measurements of assets recognized in the accompanying 2021 statement of net assets available for benefits measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements fall at December 31, 2021:

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2022 and 2021. The Plan had no liabilities measured at fair value on a recurring basis. Additionally, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy and include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan does not hold any Level 2 or Level 3 securities.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2022, the Plan had no investments (see Note 1).

Note 8: Subsequent Events

Subsequent events have been evaluated through October 16, 2023, which is the date the financial statements were available to be issued.
