## INDEPENDENT AUDITOR'S REPORT

To the Investment Committee of the MUL 401(k) Profit Sharing Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). ### ***Emphasis of Matter – Subsequent Event***

As discussed in Note 9 to the financial statements, on April 19, 2022, the Plan Administrator and 401(k) investment committee of the Plan voted to merge into the Mitsubishi HC Capital America, Inc. 401(k) Plan as of January 1, 2023. The Plan will transfer its net assets into the Mitsubishi HC Capital America, Inc. 401(k) Plan and will cease operations as of that date. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

#### **NOTE 1 – PLAN DESCRIPTION**

The following is a brief description of the MUL 401(k) Profit Sharing Plan (the “Plan”) which is provided for general information purposes only. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan’s provisions.

#### **A. GENERAL**

The Plan is a qualified defined contribution and safe harbor 401(k) plan covering eligible employees who are members of control group sponsored by Mitsubishi HC Capital USA and adopted by various affiliates (collectively the “Company”). The Plan provides for elective deferral of wages and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). John Hancock Trust Company LLC is the trustee and custodian of the Plan (“Trustee”) and holds the Plan’s investments. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The Trustee and the Plan administrator are appointed by the Company.

#### **B. ELIGIBILITY**

The Plan covers all eligible employees of the Company who have attained the age of 21. The Plan covers all eligible (part-time or seasonal meeting eligibility) employees of the Company who have attained age 21 and have completed at least 1,000 hours of service in one year. Entrance in the Plan is the first day of the month subsequent to meeting the above eligibility requirements. The Plan excludes those employees who are: (1) non-resident aliens, (2) union employees covered by a collective bargaining agreement, (3) part-time, temporary employees or seasonal employees not meeting eligibility, (4) rotating staff members on temporary assignment in the U.S. from outside the U.S.

#### **C. PARTICIPANT CONTRIBUTIONS**

Pre-tax and after-tax salary deferral contributions may be made by participating employees up to 100% of the participant’s eligible compensation up to the maximum contributions allowed under the Internal Revenue Code (“IRC”) limits. Employee contributions are made through authorized payroll deductions.

#### **D. EMPLOYER CONTRIBUTIONS**

The Company provides for Safe Harbor matching contributions of 100% of elective deferrals that do not exceed 3% of compensation, plus 50% of the amount of the elective deferrals that exceeds 3%, but does not exceed 5% of total compensation, up to the maximum covered compensation level. The Safe Harbor matching contribution was approximately \$1,300,000, for the year ended December 31, 2022.

The Company also has the option of providing a discretionary employer profit sharing contribution. Participants must be employed on the last day of the Plan year to share in any allocation of discretionary profit-sharing contributions. There was no profit-sharing contribution for the year ended December 31, 2022.

#### **E. PARTICIPANT ACCOUNTS**

Each participant account is credited with the participant’s contribution and allocations of employer contributions, plan earnings, and distribution and loan fees (if applicable). Allocations are based on participant earnings or account balances, as defined.

##### **F. NOTES RECEIVABLE FROM PARTICIPANTS**

Each participant may borrow up to the lesser of: (1) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the date of the new loan over the current outstanding balance of loans as of the date of the new loan or (2) one-half of the vested interest in the Plan. The notes are secured by the vested balance in the participant's account. No note shall be less than \$1,000. The notes shall bear a reasonable rate of interest as determined by the Plan administrator. Any such borrowings are to be repaid within five years, unless the note is for the purchase of a principal residence for which the repayment period may be extended. Principal and interest are to be repaid by payroll deductions. A note becomes immediately due and payable upon a participant's termination of employment, death or disability.

##### **G. PAYMENT OF BENEFITS**

An active participant, or a designated beneficiary, is entitled to withdraw the entire vested amount (or in some cases, a portion thereof) in the event of normal retirement, death, disability, termination of employment, termination of the Plan, attainment of age 59 ½, or under hardship circumstances, as defined in the Plan document. Distributions are made only in the form of a lump sum distribution.

Terminated employees whose vested balance exceeds \$5,000 at termination may elect to leave their account balances in the Plan. Participants must begin receiving Required Minimum Distributions, under IRC guidelines, upon reaching the age of 72. Terminated employees whose vested balances are under \$5,000 will be subject to an involuntary distribution.

A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions.

##### **H. PLAN EXPENSES**

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses are paid from the Plan's trust funds and allocated to all participants on a pro rata basis.

##### **I. PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100 percent vested in their employer contributions.

##### **J. VESTING**

Participants are immediately vested in their contributions, employer Safe Harbor contributions as well as any earnings thereon. In regards to the profit-sharing contribution, there is no vesting in the first 2 years of service and the participant becomes 100% vested after 3 years of service.

#### **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### **A. FINANCIAL REPORTING FRAMEWORK**

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

##### **B. BASIS OF ACCOUNTING**

The financial statements of the plan are prepared on the accrual basis of accounting.

##### **C. ESTIMATES AND ASSUMPTIONS**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **D. INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is stated at contract value, see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) of the fair value of its investments, which includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **E. PAYMENT OF BENEFITS**

Benefit payments to participants or beneficiaries are recorded when paid.

##### **F. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

While the immediate impacts of the COVID-19 pandemic have been assessed, the long-term effects of the disruption and resulting impact on the economy and financial markets remain unpredictable and depend on future developments, such as the possible resurgence of the virus, variant strains of the virus, vaccine availability and effectiveness, and future government actions in response to the crisis. Subsequent changes in interest rates and volatility in financial markets could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. Plan management continues to monitor the impact of these economic factors but is unable to estimate the total impact the pandemic will have.

##### **G. NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022.

##### **H. SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through October 16, 2023, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

#### **NOTE 3 – FORFEITURES**

Upon termination of employment participants forfeit their non-vested balances. These accounts may be used to pay administrative expenses and/or Company contributions. At December 31, 2022 and 2021, forfeited non-vested accounts were \$46,815 and \$42,137, respectively. There were no forfeitures used to reduce Company contributions or to pay administrative expenses for the year ended December 31, 2022.

#### **NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan's investments are held in a trust fund administered by John Hancock Trust Company, LLC, the trustee of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2022.

#### **NOTE 5 – TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – PARTY-IN-INTEREST**

Certain of the Plan's investments are managed by the Trustee. Included within administrative expenses are certain payments to the Trustee. Transactions with the Trustee qualify as party-in-interest transactions. Notes receivable from Plan participants also qualify as party-in-interest transactions. As of December 31, 2022 and 2021, there were investments that qualify as party-in-interest transactions totaling \$1,528,839 and \$1,276,180 respectively. The Plan also has notes receivable from participants that qualify as party-in-interest transactions. The total of the notes receivable from participants were and \$323,550 and \$380,437 as of the years ended December 31, 2022 and 2021, respectively.

#### **NOTE 7 – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive group annuity contract with Metropolitan Life Insurance Company (“MetLife”, who is a related party of the Trustee). MetLife maintains the contributions in an unallocated fund within its general account which adds interest. The account is also charged for participant withdrawals and administrative expenses. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The contract is included in the financial statements at contract value. Contract value represents the amount of contributions deposited, plus interest credited daily as determined by the contract, less any participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The account balance was \$1,528,839 and \$1,276,180 as of December 31, 2022 and 2021, respectively.

Certain events limit the Plan’s ability to transact at contract value with the insurance company including plan termination and other events as specified in the group annuity contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed by the Plan. The crediting interest rate is based on a formula agreed upon with the insurance company. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate is based on a formula established by the contract issues but may not be less than zero percent.

#### **NOTE 8 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded, and the reliability of the assumptions used to determine fair value.

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2022 and 2021.

#### **NOTE 8 – FAIR VALUE MEASUREMENTS**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

- *Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial institutions could result in a different fair value measurement at the reporting date.

#### **NOTE 9 – SUBSEQUENT EVENT**

Due to this merger, the Form 5500 as of December 31, 2022, recorded no assets with the conversion happening December 31, 2022. On the accompanying financial statements, the assets are shown as of December 31, 2022, with an offsetting liability for the full transferred amount.
