Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sports Facilities Management, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sports Facilities Management, LLC 401(k) Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Plan Description

The following description of the Sports Facilities Management, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Sports Facilities Management, LLC and affiliated participating employers (collectively, the "Company") who have completed one year of service and are age twenty one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The effective date of the Plan is January 1, 2020.
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed one year of service and are age twenty one or older. Once an eligible employee has satisfied the eligibility requirements the employee will become a participant in the Plan on the first day of the month coinciding with or next following the date eligibility requirements are satisfied.
- c) *Employee Contributions* – Each year participants may contribute annual compensation, as defined by the Plan, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans. The Plan does not include an automatic deferral feature.
- d) *Employer Contributions* –The Company made safe-harbor matching contributions in 2022, contributing 100% of the first 3% of compensation contributed to the Plan by participants, and 50% of the next 2% of compensation contributed (maximum 4% Company of compensation contribution). For the year ended December 31, 2022 and 2021, the Company made safe harbor matching contributions of \$213,913 and \$166,840 respectively.

The Plan also allows additional employer matching contributions and profit sharing contributions. No such additional contributions were made in 2022.

- e) *Investment Options* - Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or internet. Participants who do not select specific investments are invested in accordance with the default investment alternatives established under the Plan.
- f) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- g) *Vesting* – Participants are vested immediately in their contributions and Company safe harbor contributions, plus actual earnings thereon. Participants are vested in other Company contributions (matching and profit sharing) based on a six-year graded vesting schedule, with an initial 20% vesting after two years of service, and 20% additional vesting each year thereafter (fully vested after 6 years of service).
- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution or installment payment sufficient to satisfy required minimum distributions (RMD).
- i) *Forfeited Accounts* – Forfeitures of non-vested balances may be used to reduce employer contributions or pay plan expenses. At December 31, 2022 and 2021 the forfeiture account balance was \$402 and \$116, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the guaranteed investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Investments in common/collective trust funds are stated at net asset value as determined by the issuer of the funds based on the underlying investments. The guaranteed investment contract is stated at contract value which is principal plus accrued interest, the value at which participants ordinarily transact.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2022 through October 13, 2023, which is the date the financial statements were available to be issued.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts – Investments are measured at net asset value provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is not a publicly traded quoted price in an active market but is used as a practical expedient to estimate fair value. In accordance with the Fair Value Measurements topic 820-10, certain investments that are measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

6. Guaranteed Investment Contract

The Plan' holds a guaranteed investment contract (GIC) with Great West Life and Annuity Insurance Company (Great West), under the investment fund name, Guaranteed Interest Fund. Great West maintains the contributions in a general account. The contract underlying this investment option is considered to be fully benefit responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and for 2022 was 1.18% and 2021 was 1.15%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Great West's ability to meet its financial obligations. Great West's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Great West may impose restrictions on the ability to move funds into or out of this investment option. Withdrawals from the Great West Guaranteed Interest Fund for other than the payment of benefits to participants may be subject to a liquidation value adjustment and a surrender charge.

7. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that

such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Related-Party Transactions and Party in Interest Transactions

Empower Retirement is the current recordkeeper of the Plan and qualifies as a party-in-interest. Recordkeeping fees of \$14,621 were paid to Empower in 2022.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10. Tax Status

The Internal Revenue Service has determined and informed the Company that the Volume Submitter Profit Sharing Plan with Coda are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
