Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of B.V. General, Inc. 401(k) Salary Reduction Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

Without qualifying our opinion, we draw attention to Note 1 to the financial statements, which describes the circumstances that have led to the discontinuation and termination of the Plan. The financial statements have been prepared on a basis other than the going concern basis, as the Plan has ceased its operations during the year and all assets and liabilities were settled and distributed to the participants.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about B.V. General, Inc. 401(k) Salary Reduction Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of B.V. General, Inc. 401(k) Salary Reduction Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about B.V. General, Inc. 401(k) Salary Reduction Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Auditors' Report on the 2021 Financial Statements

We were engaged to audit the 2021 financial statements of B.V. General, Inc. 401(k) Salary Reduction Plan and Trust. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 4, which was certified by AdvisorTrust, Inc., the trustee of the Plan, except for comparing such information with the related information included in the financial statement. In our report dated October 15, 2022, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2021 financial statements, and (b) the form and content of the information included in the 2021 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Nature of Operations and Description of the Plan

The following description of the B.V. General, Inc. 401(k) Salary Reduction Plan and Trust ("the Plan") provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions, including those described herein.

In August 1, 2022, B.V. General, Inc. and its related entities were sold to International Equity Partners, Inc. The Plan was immediately terminated following the aforementioned sale.

The termination of the Plan was completed in accordance with the Plan's provisions and applicable regulations. For this purpose, termination included a complete discontinuance of contributions. Subsequent to the termination, the Plan ensured all participants received their respective account balances, including vested employer contributions and earnings, if any. The distribution of assets was completed by the end of July of 2022, and the Plan's accounts were subsequently closed.

Upon the termination of the Plan, the Participants were entitled to a distribution of their entire vested benefit. Such distribution was made directly to the participants or, at their direction, or was transferred directly to another qualified retirement plan or IRA. If the Participants did not consent to a distribution of their benefit upon termination of the Plan, the Plan Administrator transferred their vested benefit directly to an IRA that the Plan had established for their benefits.

The discontinuation and termination of the Plan were completed in compliance with the Employee Retirement Income Security Act (ERISA) and other relevant regulatory requirements governing retirement plans.

The following notes pertain to the time period prior to the termination of the plan:

General

The Plan is a defined contribution plan covering all full-time employees of B.V. General, Inc. ("the Company") and its related entities who have one year of service and are age of 21 or older. It is subject to the provisions of ERISA. The Administrative Committee is in charged with plan governance and determines the appropriateness of the Plan's investment offerings, monitors investment performances.

The Lincoln National Corporation is the record keeper for the Plan, and The Lincoln National Life Insurance Company ("Lincoln") is the trustee for the Plan.

Contributions

Each year, participants may contribute up to 15% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a guaranteed account and pooled separate accounts as investment options for participants. The Company may match 15% of the participant's contribution. Contributions are subject to certain limitations.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, the Company's discretionary contributions, if any, and the allocation of earnings or losses and administrative expenses. Investment income or losses are allocated to the participant's account in relation to the investment performance of each fund and the proportion of the participant's account balance to the total balance in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accumulated vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, or applied to the purchase of an annuity contract, other than a life annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-Service Distributions

The employer also authorizes an in-service hardship distribution deemed to be made on account of an immediate and heavy financial need of the employee upon providing the written request for such existence of a proper hardship event representing insufficient cash or liquidity after taking available distributions or loans under the plan.

The employee may not receive a hardship distribution more than to satisfy the need and maximum limit may include any amounts necessary to pay federal, state or local income taxes or penalties reasonably anticipated from the distribution or any such additional limits must be imposed as per authorization by Plan Administrator under the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.75% to 10%, which are commensurate with local prevailing rates from commercial institutions for similar loans. Principal and interest is paid ratably through monthly payroll deductions.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited non-vested account totaled \$0 and \$32,297, respectively. This account is usually to pay administrative expenses.

Transaction Expenses

This includes asset, loan and distribution fees paid by the participants on their respective accounts. Third party administration fees are charged directly to and paid for by the Company.

Plan Amendments

The company have the authority to amend this Plan at any time. Any amendment, including the restatement of an existing Plan, may not decrease the vested benefit under the Plan, except to the extent permitted under the Internal Revenue Code, and may not reduce or eliminate any "protected benefits" (except as provided under the Internal Revenue Code or any regulation issued thereunder) determined immediately prior to the adoption or effective date of the amendment (whichever is later). However, we may amend the Plan to increase, decrease or eliminate benefits on a prospective basis.

Plan Termination

Although it has not expressed such intent, the Company, by action of its Board of Directors, reserves the right to amend or terminate, at any time, the Plan subject to the provisions of ERISA. In the event of Plan termination, net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan at the time of liquidation.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's pooled separate account investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in orderly transaction between market participants at the measurement date. See note 4 for discussion of the fair value measurements. Participant loans are valued at their outstanding balances, which approximate fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation in Fair Value of Investments

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is recorded in the accompanying statements of changes in net assets available for benefits as net appreciation in fair value of investments.

Payments of Benefits

Benefits to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent loans are treated as distributions based on the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Income Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 26, 1996, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator notes that the Plan is a 'prototype' plan and it is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan has adopted guidance on accounting for uncertainty in income taxes issued by FASB. The Plan Administrator believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan files information returns annually. As of December 31, 2022, information returns for years subsequent to 2017 were subject to examination by authorities.

Recent Accounting Developments

3. Information Certified by the Plan's Trustee

In accordance with Section 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the following investment information shown in the accompanying financial statements and supplemental schedule as of December 31, 2022 and 2021 and for the years then ended, has been certified as being complete and accurate by Lincoln, the trustee of the Plan.

- Investments at fair value as of December 31, 2022 and 2021 as reflected in the Statements of Net Assets Available for Benefits;
- Investment activity as reflected in the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2022 and 2021;
- Investment information disclosed in Note 4 to the Plan's financial statements.

The Plan Administrator instructed the Plan's independent auditors' not to perform any audit procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

The Plan has adopted Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements. ASC Topic 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which the transaction for the asset or liability occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Observable inputs other than Level 1 measurements such as quoted prices for similar assets or liabilities; quoted market prices in markets that are active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Following is a description of the Plan's valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts (PSA):

The PSA are segregate investment accounts established by Lincoln. The value of the Plan's investment in the PSA reported in the plan year report is equal to the contract value. The contract value is equal to the number of participation units owned under the contract in each PSA times the unit value of the participation units. The unit values of the participation units in the PSA are estimated by Lincoln based on the value of the underlying assets owned by the fund minus the fund's liabilities, divided by the number of participation units outstanding. This value is commonly referred to as the net asset value (NAV). This NAV calculation is in accordance with the AICPA Audit and Accounting Guide, *Investment Companies*. The PSA's NAV is not a public quoted price in an active market. Based on these facts, FASB ASC 820 allows the use of NAV as a practical expedient to estimate their fair value.

During the year ended December 31, 2022 the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) depreciated in value by \$962,220.

5. Contract Investment

The guaranteed account by the Lincoln Director is a fully benefit-responsive group investment contract ("GIC") issued by Lincoln. This Guaranteed Account is reported at contract value in the statement of net assets available for benefits. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate, as shown on the contract specifications. The interest crediting rate is declared on quarterly basis. This contract is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on Lincoln's ability to meet its financial obligations from general assets.

Unlike a traditional GIC with a defined maturity date, Lincoln Director's guaranteed account contracts do not have a specified maturity date. Therefore, unlike a traditional GIC contract, there are no known scheduled cash flows associated with this contract.

6. Party-In-interest Transactions

The PSAs and the guaranteed account are managed by Lincoln. Lincoln is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions that are exempt under ERISA prohibited transaction rules.

7. Plan Termination

The Company, effective July 31, 2022, has exercised its right under the Plan to discontinue contributions and terminate the Plan in its entirety. This action aligns with the provisions established by ERISA. In light of the Plan's termination, all impacted participants retain nonforfeitable rights to the benefits accrued up to the termination date, subject to the extent of funding at that time.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Subsequent Events

Management has evaluated subsequent events through October 15, 2023, the date on which the financial statements were available to be issued.

Management has not identified any other subsequent events that required adjustments or disclosures in these financial statements.
