We have performed an audit of the accompanying financial statements of Hammersmith Management, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.



**Note A – Description of Plan**

The following description of the Hammersmith Management, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of the Company who have the required twelve months of service and are age 21 or older. Employees may enter the Plan on the first day of each month once eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees who attain 1,000 hours of service within a service period or full-time employees with two months of service and are age 21 or older will automatically be enrolled in the Plan with the choice of opting out if they choose to not participate.

The Company underwent an acquisition and the Plan was merged effective December 1, 2022. Refer to Note E for additional disclosures regarding the merger.

**Contributions**

Each year, participants may contribute up to a maximum dollar amount of pretax annual compensation, as defined in the Plan, up to the maximum amounts allowed by law. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Company contributions are at the discretion of the Company's administrative committee. Contributions are subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participants' Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Non-vested participants' accounts that are forfeited upon termination of service may be used to reduce future employer contributions. Forfeitures of contributions for the Plan year ended December 31, 2022 and 2021 were \$1,184 and \$211, respectively. The Plan's sponsor (employer) pays for the majority of administrative expenses.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with an annual minimum of 1,000 hours and employed on last day of the Plan year. A participant is 100 percent vested after six years of credited service.

**Note A – Description of Plan (continued)**

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or defer receipt until age 65 or his or her normal retirement age (as defined in the Plan agreement), whichever is later. Participants with a balance less than \$5,000 receive a lump-sum distribution net of required federal taxes withheld, unless a rollover request is received within 30 days of notice of distribution.

**Participant Loans**

Participants may borrow from their fund accounts in accordance with the Plan provisions. Loan terms range from one to five years and must be secured by the balance in the participant's account. The Plan limits loans to the lesser of \$50,000 or 50% of the vested account balance. Interest rates are determined by the Plan administrator commensurate with local prevailing rates. Interest rates as of December 31, 2022 and 2021 ranged from 3.25 to 5.50 percent. Payments are made ratably through semi-monthly payroll deductions.

**Note B – Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investments and Valuation**

The Plan utilized Charles Schwab Bank and The Standard Insurance Company as its service providers. Participants may contribute and allocate earnings to sponsored funds that include domestic and international stocks, bonds and money market mutual funds.

The Plan's investments and earnings are stated at fair value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Participant loans are valued at their outstanding balances, which approximate fair value.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is accrued when earned. Dividend income is recorded on ex-dividend date. Capital gain distributions are included in dividend income.

**Note C – Certification**

Charles Schwab Bank and The Standard Insurance Company, as of December 31, 2022 and 2021, the trustees of the Plan, have certified the investments and notes receivable maintained by the Plan and the receipts and disbursements of the Plan for the years then ended. All Plan investments are participant-directed with the exception of contributions by employees that are auto-enrolled which are contributed into the insurance contracts with The Standard Insurance Company.

**Note D – Tax Status**

The IRS has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan's federal tax returns are subject to examination by the IRS, generally for three years after they were filed.

**Note E – Plan Termination and Merger**

The Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

On July 1, 2022 (Merger Date), Hammersmith Management, Inc. was merged with and into RealManage, LLC. Effective on the merger date, RealManage, LLC became the sponsor of the Plan and established the investment committee to oversee the Plan's investment structure. Overall responsibility for administering the Plan rests with RealManage, LLC. Fidelity Management Trust Company became the trustee for the Plan effective on the merger date.

On December 1, 2022 (Plan Merger Date), the Plan was merged with and into the RealManage, LLC 401(k) Plan for all participants in the former Hammersmith Management, Inc 401(k) Plan. Net assets transferred into the RealManage, LLC 401(k) Plan totaled \$2,189,645.

**Note F – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

**Note G – Fidelity Bond**

The Company was covered by a fidelity bond of \$1,000,000 during 2022 and 2021, respectively.

**Note H – Date of Management Evaluation**

Management has evaluated subsequent events through October 10, 2023, the date on which the financials were available to be issued.

**Note 1 – Fair Value Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement of accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest level of priority. Level 2 inputs are quoted prices included within Level 1 that are observable to the asset, either directly or indirectly. Level 3 inputs are generated from model-based techniques that use significant assumptions not observable in the market.

There are three types of valuation techniques used to measure assets recorded in the Plan at fair market value.

- The market approach, which uses prices or other relevant information generated by market transactions involving identical or comparable assets.
- The income approach, which uses the present value of cash flows and earnings.
- The cost approach, which uses replacement costs more readily adaptable for valuing physical assets.

The Plan uses both the market and income approach in its fair value measurements.

Level 1 fair value measurement are based on quoted prices available in active markets for identical investments as of the reporting date.

Level 2 fair value measurements are based on pricing inputs other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value is determined through the use of models or other valuation methodologies

Level 3 fair value measurements are determined using the fair value measurement policies and procedures in consultation with advisory groups who provide an interest rate for the coming month based on the investments underlying the contracts. Based on the rates and margins, a credit rating is declared for financial activity and approved by the Plan administrator's management.

**Note K – Party-in-Interest Transactions and Related Party Transactions**

Stancorp Financial Group owns Standard Insurance Company and Standard Retirement Services, Inc. As described in Note K, the Plan is invested in a group annuity contract with Standard Insurance Company. Standard Retirement Services, Inc. provides Plan administrative and recordkeeping services. These transactions qualify as party-in-interest transactions.

**Note L – Group Annuity Contract**

The Plan entered into a traditionally fully benefit-responsive guaranteed investment contract with Standard Insurance Company (SIC) totaling \$0 for 2022 and \$40,113 for 2021. SIC maintains the contributions in a general account and is contractually obligated to repay the principal and a specified interest rate that is declared at the beginning of each calendar year. The guaranteed investment contract only permits the insurance company to terminate the contract within 30 days by written notice due to reasonable cause, which include the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualifications, and failure to adopt the Plan in a reasonable period of time.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by SIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive the amounts due is dependent on this issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition of competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. During 2022, the Plan merged with another plan and was unable to transact at contract value with the contract issuer.

**Note M – Covid-19 Pandemic**

On January 30, 2020, the World Health Organization (“WHO”) announced a global health emergency because of the new strain of coronavirus originating in Wuhan, China (the “COVID-19 outbreak”) and the risks to the international community as the virus spreads globally beyond its point of origin. In March 2020, the WHO classified the COVID-19 outbreak as a pandemic, based on the rapid increase in exposure globally.

The full impact of the COVID-19 outbreak continues to evolve as of the date of this report. This pandemic had adversely affected the global economic activity and greatly contributed to significant deterioration and instability in financial markets. As a result, many of the Plan’s investments have incurred a significant decline in fair value. It has also significantly reduced interest rates. Because the values of the Plan’s individual investments have and will fluctuate in response to changing market conditions, the extent of the adverse impact of the Covid-19 pandemic on the Plan’s participant account balances and the net assets available for benefits cannot be reasonably estimated at this time.
