Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Caregiver 2, Inc. dba Unified Care Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Opinion

Basis for Opinion

Note 1 – Plan Description

The following description of the Caregiver 2, Inc. dba Unified Care Companies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Caregiver 2, Inc. dba Unified Care Group Companies and its related employers (collectively, the “Employer” or “Company”). The Plan commenced effective January 1, 2004, and was amended and restated effective January 1, 2022 to comply with current rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodians and Trustees

Prior to December 1, 2022, John Hancock Life Insurance Company (“John Hancock”) served as the Plan’s custodian. Effective December 1, 2022, Standard Insurance Company (“Standard”) was appointed as the new custodian and record-keeper of the Plan. Collectively, John Hancock and Standard are referred to herein as the “Custodians.” Among other duties, the Custodians receive contributions, hold and invest the fund assets in accordance with the directions of participants, and make distributions as directed by the Plan Administrator. Certain officers of the Company serve as Trustees of the Plan.

As a result of the change in custodian noted above, the Plan’s assets were transferred from John Hancock to Standard, and the Plan experienced a blackout period from December 10, 2022 until January 2023. During this blackout period, participants could not direct or diversify their investments, nor obtain a distribution from the Plan.

Eligibility and Plan Entrance Date

Except for those employed on a PRN basis, all employees of the Company are eligible to participate in the Plan upon fulfilling the eligibility requirements. Prior to December 1, 2022, employees became eligible upon reaching 20 ½ years of age and completing 30 days of service. Effective December 1, 2022, the age and service requirements were changed to 21 years of age and 3 months of service, respectively. Eligible employees are permitted to enter the Plan on the first day of each month coincident with or next following the date upon which the eligibility requirements are fulfilled.

Contributions

All eligible participants may elect to contribute, on a before-tax basis, up to 100% of their eligible compensation as defined by the Plan, subject to the maximum amount permitted for deferral annually by the IRC, which was \$20,500 for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions up to the maximum amount permitted annually by the IRC, which was \$6,500 for 2022. Effective December 1, 2022, the Plan also permits after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Employer may elect to make discretionary matching contributions to the Plan as determined annually by management. No discretionary Employer matching contributions were made to the Plan in 2022.

Note 1 – Plan Description (continued)

Participant Accounts

Each participant account is credited with the participant's contributions, Employer contributions, and allocations of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. These options vary in types of investments, rates of return, and investment risk, and participants may direct their account balances to one or more options.

Vesting

Participants are always 100% vested with respect to their own contributions and rollover contributions. Vesting in Employer contributions, plus any income or loss thereon, is based upon years of service according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Such loans are secured by the balance in the participant's account, and interest is charged at the prevailing rate when the loan is issued. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

The payment of benefits may occur upon the participant reaching the age of 59 ½, or upon the participant's retirement, disability, death, or termination of employment, or if the participant reaches the age of 70 ½ while still employed. Upon normal retirement, defined by the Plan as age 62, disability, or death, the participant or beneficiary is automatically entitled to receive 100% of the participant's account balance. Upon termination for any other reason, a participant or beneficiary is entitled to receive the vested portion of the participant's account balance. Benefits are paid in a lump-sum amount or annuity, as defined by the Plan. Terminated participants with account balances under \$5,000 receive automatic distributions in the form of lump-sum payments or direct rollovers to individual retirement plans as designated by the Plan Administrator. In addition, the Plan permits hardship withdrawals for participants who have incurred a substantial financial hardship, as defined by the Plan.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded on the accompanying statements of net assets available for benefits as a liability with a corresponding reduction to contributions. The Plan distributed 2021 excess contributions to affected participants after March 15, 2022.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Employer and are thus excluded from these financial statements. Investment-related expenses are included in net depreciation of fair value of investments on the accompanying statement of changes in net assets available for benefits. Certain expenses specifically incurred by, or attributable to a participant, are paid from that participant's account. Plan expenses could include, but are not limited to, costs to process loans and distributions.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

- **Pooled Separate Accounts** – Valued using the net asset value ("NAV") of units held by the Plan at year-end as provided by the Custodians. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the pooled separate account, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

- Stable Value Fund** – Composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the pooled separate account. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information with the related information included in the financial statements and supplemental schedule.

Note 5 – Guaranteed Investment Contract with Insurance Company

Prior to December 12, 2022, the Plan maintained a traditional fully benefit-responsive investment contract with John Hancock in the form of a Separate Account Guaranteed Interest Contract ("SAGIC"). This contract was terminated effective December 12, 2022. Prior to termination, the SAGIC maintained contributions in a general account, which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by the SAGIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. As described in Note 2, because the SAGIC is fully benefit-responsive, contract value is the relevant measurement for the portion of the net assets available for benefits attributable to the guaranteed investment contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is reviewed on a quarterly basis for resetting. The SAGIC does not allow the crediting interest rate below 0%.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts and a stable value fund managed by the Custodian; as such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants as of December 31, 2022 and 2021. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

Prior to December 1, 2022, the Plan operated under an adoption agreement in connection with a non-standardized, pre-approved profit-sharing plan sponsored by Definiti LLC (the “Definiti Plan”). The Definiti Plan document has been filed with the appropriate agency and obtained an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, stating that the Definiti Plan and related trust, as then designed, constituted a qualified plan under Section 401 of the IRC, and therefore was not subject to tax.

Effective December 1, 2022, the Plan adopted a non-standardized, pre-approved profit-sharing plan sponsored by Standard Retirement Services, Inc. (the “Standard Plan”). The IRS has determined and informed the Standard Plan sponsor, by a letter dated June 30, 2020, that the Standard Plan and related trust are designed in accordance with applicable sections of the IRC. While the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2019.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 11 – Prohibited Transactions

During 2021, the Employer failed to remit to John Hancock certain participant contributions totaling \$539 within the period prescribed by the Department of Labor’s Rules and Regulations. Delays in remitting these contributions were the result of unintentional administrative errors, and the late remittances were corrected during 2022.

Note 12 – Subsequent Events

The Plan has evaluated subsequent events through October 16, 2023, the date these financial statements were available to be issued.

Effective January 1, 2023, the Plan was amended to change the computation period for discretionary Employer matching contributions to be determined on the Plan year basis and to include conditions for the allocation of such contributions. Per the amended Plan provisions, a participant must be employed by the Company on the last day of the Plan year in order to be eligible to receive a discretionary Employer matching contribution. A waiver of conditions was also added to address discretionary Employer matching contributions for participants not employed on the last day of the Plan Year due to death, disability, and normal retirement age.
