NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Consumers Petroleum 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established to provide retirement benefits for employees of Consumers Petroleum of Connecticut, Inc., and its affiliate, Wheels of CT, Inc. (collectively, the Company) who had at least six months of service and were at least 21 years old. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator was responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring investment performance.

In January 2022, Global Partners LP completed an acquisition of the Company's assets and real properties. As a result of the acquisition, Plan management elected to terminate the Plan on March 4, 2022. All participants became 100% vested in their share of the employer contributions as of this date. The Plan completed processing distributions of participants' account balances on October 14, 2022, which will be considered the effective termination date of the Plan.

Contributions

Participants were allowed to contribute up to 100% of compensation, as defined in the plan document, on a pre-tax or Roth basis, subject to certain Internal Revenue Service (IRS) limitations. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants were also allowed to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan included an auto-enrollment provision, whereby all newly eligible employees would be automatically enrolled in the Plan unless they affirmatively elected otherwise. Automatically enrolled participants would have their deferral rate set at 2% of eligible compensation, and their contributions would invest in a designated fund until changed by the participant.

The Company could also make discretionary contributions to participants based on a pro rata allocation based on participants' compensation, which were determined annually. The Company made discretionary contributions of 3% of participants compensation to the Plan during 2022 in the amount of \$143,491. Approximately \$22,100 of the contribution was made using forfeited nonvested assets of the Plan.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's discretionary contributions, and plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Investment Options

Participants were allowed to direct their contributions into any of the funds offered by the Plan. These funds included a variety of mutual fund investment options maintained in pooled separate accounts with various objectives and degrees of financial risk as well as a guaranteed investment contract. Participants were allowed to change investment elections at any time.

Vesting

Participants were immediately vested in their deferral and rollover contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions was based on years of continuous service. Participants were fully vested in employer contributions upon the completion of six years of service. Participants were also fully vested upon reaching normal retirement age, death or total disability.

The vesting schedule for the Company's matching contributions was as follows:

In connection with the plan termination in March 2022, participants were 100% vested in all employer discretionary contributions.

Notes Receivable from Participants

Participants may have borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years, except for loans to purchase a primary residence, which may have been offered over a term of up to thirty years. The loans were secured by the balance in the participants' accounts and bore interest at 2% above the prime rate. The prime rate was 3.25% at both March 4, 2022 and December 31, 2021. Outstanding loans bore interest at rates ranging from 4.25% to 6.25% for the period January 1, 2022 to October 14, 2022 (date of termination) and as of December 31, 2021. Participants may only have had one loan outstanding at any given time. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon retirement, disability, death or termination of employment, a participant may have elected to receive either a lump-sum distribution or installment payments over a number of years, up to the vested portion of their account, based upon the election of the participant, as defined in the plan document or the Internal Revenue Code (Code). If a participant terminated employment for any reason and his or her vested account balance did not exceed \$1,000, the plan administrator may have distributed such amount in a lump-sum payment to the participant without consent of the participant. If the participant's balance was between \$1,000 and \$5,000, the plan administrator may have rolled the amount into an individual retirement account on behalf of the participant without the consent of the participant.

The Plan also provided for in-service withdrawals by participants who had attained the age of 59½. In addition, upon proving financial hardship, a participant was entitled to an in-service withdrawal, as defined, which was payable immediately in a lump-sum distribution.

Forfeited Accounts

Upon termination of participants from the Plan, forfeitures of nonvested contributions were accumulated in forfeiture accounts. The plan administrator may have elected to use the forfeitures to reduce the Company's future discretionary contributions or to pay plan administrative expenses. As of December 31, 2021, forfeited nonvested accounts totaled approximately \$22,100. These funds were used to offset the Company's discretionary contributions during the period January 1, 2022 to October 14, 2022 (date of termination). No forfeited nonvested assets remain in the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value (except for the fully benefit-responsive investment contract, which was reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measurement for the portion of assets attributable to the fully benefit-responsive investment contract.

Investment Valuation and Income Recognition (continued)

The plan administrator determined the Plan's valuation policies utilizing information provided by investment advisers. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on the trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded. No allowance for credit losses has been recorded as of October 14, 2022 (date of termination) and December 31, 2021.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022. There were no excess contributions payable as of October 14, 2022 (date of termination).

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued. Through that date there were no material events that would require recognition or additional disclosure in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurement* (ASC 820), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at October 14, 2022 (date of termination) and December 31, 2021. Following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts - Mutual Funds

The underlying mutual funds were held in pooled separate accounts at Mass Mutual Life Insurance Company (MMLIC) and were required to publish their net asset values and to transact at that price. The reported fair values have been measured by quoted marked prices in an active market. Mutual funds were valued at the daily closing price as reported by the funds.

The preceding methods described above may have produced a fair value calculation that may not have been indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had entered into a fully benefit-responsive guaranteed investment contract with MMLIC, which maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MMLIC was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract was presented in the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by MMLIC, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may have ordinarily directed the withdrawal or transfer of all or a portion of their investments at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract was a traditional investment contract.

Certain events limited the ability of the Plan to transact at contract value with MMLIC. Such events included the following: 1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that caused a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In connection with the termination of the Plan, management elected a market value adjustment for the funds invested in the guaranteed investment contract. The total market value adjustment resulted in a decrease of approximately \$100.

NOTE 5 - INCOME TAX STATUS

The Plan had adopted a non-standardized prototype plan sponsored by MMLIC, and as a result, had not applied for a separate letter of determination from the IRS. The MMLIC prototype plan received a favorable IRS advisory letter dated March 31, 2014 that the prototype plan was in compliance with the applicable requirements of the Code. During the period January 1, 2022 to October 14, 2022 (date of termination), the Plan adopted a non-standardized pre-approved plan sponsored by Empower Retirement, LLC (ERL). The Plan had also not applied for a separate letter of determination from the IRS for the ERL pre-approved plan, which received a favorable IRS advisory letter dated November 14, 2022 for its submission dated December 31, 2018.

Although the Plan had been amended since the advisory letter for the MMLIC prototype plan was provided, the plan administrator believed that the Plan was designed and being operated in compliance with the applicable requirements of the Code. Therefore, the plan administrator believed the Plan was qualified and the related trust was tax exempt.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities, which were exposed to various risks such as interest rate, market, and credit risks while invested by the Plan. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could have occurred and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits. All of the Plan's investment securities were liquidated during the period January 1, 2022 to October 14, 2022 (date of termination).

NOTE 7 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by MMLIC or its affiliates, and, therefore, these transactions qualify as party-in-interest transactions.

Participant accounts were charged directly for fees related to loan processing and certain other fees. During 2022, participant accounts were charged approximately \$25,900, which were paid to an affiliate of MMLIC. The Plan paid service provider fees of approximately \$4,000 during 2022 to Merrill Lynch Pierce Fenner Smith, Inc.

Notes receivable from participants qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 - PLAN TERMINATION

As discussed in Note 1, the Company terminated the Plan during the period January 1, 2022 to October 14, 2022 (date of termination). In connection with the termination, participants became 100% vested in their employer contributions.

Furthermore, the Plan's independent auditors did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements.
