Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Compound Photonics US Corp. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation effective March 31, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

DECEMBER 31, 2022 (IN LIQUIDATION) AND 2021 (ONGOING)

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Compound Photonics US Corp. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Compound Photonics US Corp. (the Company), who are age 21 or older and have completed three months of service. The Plan excludes nonresident aliens and leased employees from participation. The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA).

Plan Termination - On January 6, 2022, the Company closed an agreement providing for the sale of certain assets of the Company to a third-party. As a result of this transaction, all of the participants in the Plan terminated their employment with the Company. The Plan was excluded from the purchased assets and the Company's Board of Directors elected to terminate the Plan subject to the provisions of ERISA effective March 31, 2022 (termination date). The Plan's termination ceased employee and employer contributions into the Plan and ceased new participant notes receivable from the Plan. All affected participants became fully vested in their accounts as of the termination date. There were no assets held at the end of the Plan year as the Plan's assets were fully distributed by December 31, 2022.

Plan Amendment - Effective July 31, 2022, the Plan was amended and restated in order to adopt required regulatory updates, through adoption of a Non-Standardized Pre-Approved Defined Contribution Plan document sponsored by ADP, LLC. The Plan provisions remained substantially unchanged as a result of the restatement.

Contributions - Contributions consist of employee pretax elective deferrals, Roth elective deferrals and discretionary employer matching and discretionary profit sharing contributions. Each participant may elect to contribute up to 90% of their eligible compensation, as defined by the Plan, limited to \$20,500 in 2022 and \$19,500 in 2021, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 or older may elect to make an additional catch-up contribution of \$6,500 in 2022 and 2021, annually. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby 3% of the compensation of newly eligible participants will be automatically deferred into the Plan unless the participant affirmatively elects not to participate in the Plan or elects to contribute a different amount. Discretionary employer matching and discretionary profit sharing contributions are determined annually by the Company. For the years ended December 31, 2022 and 2021, there were no discretionary employer contributions or discretionary profit sharing contributions made to the Plan. Contributions are subject to certain limitation as prescribed by the IRC.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service. Participants also become 100% vested in Company contributions upon death or disability. All affected participants became fully vested in their accounts as of the termination date.

Payment of Benefits - On termination of service, retirement, permanent disability or death, a participant may elect distribution as a lump-sum amount equal to the vested interest in his or her account. The Plan further provides for in-service distributions upon attaining age 59½, and hardship distributions. Hardship distributions are available only for the purpose of meeting immediate and heavy financial need. Account balances of terminated participants that are under \$1,000 may be automatically paid out at the discretion of the Company. Balances of terminated participants between \$1,000 and \$5,000 may be transferred to an IRA, also at the discretion of the Company.

Expenses - Administrative expenses may be paid by the Company. Expenses not paid by the Company are charged to participant's accounts. Certain expenses of Plan administration, including computer services, professional fees, office supplies and payroll expenses or administrative and clerical personnel, are provided by the Company without charge to the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - Financial Accounting Standards Board (FASB) issued Accounting Standards Codification (ASC) 205-30, Presentation of Financial Statements: Liquidation Basis of Accounting, which requires an entity to prepare its financial statements using the liquidation basis of accounting when liquidation is imminent. The Plan implemented ASC 205-30 for the 2022 plan year as this is when liquidation was determined to be imminent. Therefore, the accompanying financial statements have been prepared on a liquidation basis of accounting as of and for the year ended December 31, 2022 and in the ongoing (accrual) basis of accounting as of December 31, 2021. The adoption did not have a material impact on the financial statements.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, and management and operating expenses associated with the Plan's investments.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons who have elected to withdraw from the Plan but are not yet paid have not been accrued. At December 31, 2022 and 2021, there were no amounts payable to participants.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events - The Plan’s management has performed an evaluation of subsequent events through October 13, 2023, which is the date these financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY TRUSTEE OF THE PLAN

The following is a summary of unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedule, that was certified by the trustee of the Plan, Reliance Trust Company, as of December 31, 2022 and 2021 and for the years then ended, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate:

NOTE 4 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units held by the Plan at year end as reported by the investment managers. The NAV provided by the trustee is used as a practical expedient to estimate fair value. Units in common collective trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in common/collective trust funds represents the value of the Plan's interests in the overall value of the common/collective trust fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS

The Plan made loans to participants based on their vested account balance. The minimum loan amount was \$1,000 and was limited to 50% of their vested account balance or \$50,000, whichever is less. Loans were secured by the vested account balance of the participant. Loans must be repaid within five years, except for loans made for the purchase of a primary residence. Loans were payable through payroll deductions. Interest was charged at rates set by the plan administrator, which was set at the Prime Rate plus an additional 1.00%. There are no loans outstanding at December 31, 2022. Loans were secured by the vested account balance of the participant.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company was the trustee of the Plan. Certain Plan investments were managed by Reliance Trust Company; therefore, these transactions qualify as party-in-interest transactions. Fees for investment management services charged by the trustee are netted against Plan earnings at a rate of 0.59% for the MetLife Reliance Trust Company Stable Value Fund.

NOTE 7 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There were no assets held by the Plan as of December 31, 2022. There were two investments that individually represented more than 10% of the investments held as of December 31, 2021.

NOTE 8 – INCOME TAX STATUS

The Plan is the adoption of a prototype non-standardized pre-approved plan document sponsored by ADP, LLC. The prototype plan document obtained an opinion letter dated October 6, 2020, stating that the plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter, however, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC, and therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 – PROHIBITED TRANSACTIONS

During 2014, employee withholdings totaling \$52 were not remitted to the Plan within the appropriate time period required by the Department of Labor. These transactions constitute prohibited transactions as defined by ERISA. The Company is aware of the occurrences and is in the process of taking the appropriate steps to correct the situation.
