## **INDEPENDENT AUDITORS' REPORT**

To the Participants and Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of API Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the period from inception (March 1, 2022) through December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of API Group 401(k) Plan 's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2022 and for the period from inception (March 1, 2022) through December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of API Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about API Group 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about API Group 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## API Group 401(k) Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF PLAN**

The following description of the API Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan adopted effective March 1, 2022 covering substantially all employees of API Group Holding, Inc. and its subsidiaries API Enterprises, Inc., Advance Polybag (Nevada), Inc., Advance Polybag (Northeast), Inc., Advance Polybag (Texas), Inc., and Accredo Packaging, Inc. (collectively the Company or Sponsor). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, and engaged a third-party investment manager (Investment Manager) to monitor investment performance on a quarterly basis.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan recordkeeping and administrative services, including annual ERISA compliance testing, are provided by The Vanguard Group (Vanguard). Vanguard entered into an agreement with Ascensus, LLC (Ascensus) to provide certain recordkeeping and administrative services on behalf of Vanguard. Plan assets are held and managed by Ascensus, the custodian and the qualified institution for the Plan which invests contributions and Plan earnings, and makes investment transactions as directed by the Investment Manager.

The Plan was adopted March 1, 2022. Accordingly, the accompanying financial statements include the activities of the Plan from the date of inception (March 1, 2022) through December 31, 2022.

#### ***Eligibility***

Employees may become a participant of the Plan at any age. An eligible employee may enter the Plan on the first day of the calendar month subsequent to the employee completing two consecutive months of service. This service requirement is waived for employees hired on or before March 1, 2022. Employees are also eligible to receive employer matching contributions, safe harbor matching contributions and profit sharing contributions upon satisfaction of the eligibility requirement.

## API Group 401(k) Plan Notes to Financial Statements

### Note 1: DESCRIPTION OF PLAN (Continued)

#### **Contributions**

Each year, participants may contribute up to the maximum amount allowed by statute, which was \$20,500 for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching or profit sharing contributions. The Company did not make any discretionary matching or profit sharing contributions during the period ended December 31, 2022. The Plan also includes a safe harbor employer contribution whereby the Company will make a non-elective contribution equal to 3%, and 50% when greater than 3% but less than 5% of compensation for all eligible employees. Company safe harbor contributions during the period from inception (March 1, 2022) through December 31, 2022 totaled \$793,768. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollover contributions and the Company's discretionary matching and safe harbor contributions, as well as allocations of the Company's profit sharing contributions and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Participants are automatically vested in Company contributions upon death, disability or retirement. Vesting in the Company's discretionary matching and profit sharing contributions plus actual earnings thereon is based on years of service as defined in the Plan document. The following schedule describes the participant's level of vesting after each year of service.

***Notes Receivable from Participants***

The Plan does not provide for loans to participants.

***Benefit Payments***

On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive a lump-sum distribution based on the valuation of the participant's vested interest in his or her account as of the date of termination. If the vested account balance does not exceed \$5,000, the Plan Sponsor may pay the distribution in a direct rollover to an individual retirement account. Also, if a participant has reached the age of 70½, certain rules require these participants to take minimum distributions. These distributions may be paid in the form of an annuity.

***Forfeitures***

At December 31, 2022, there were no forfeited nonvested accounts. Forfeitures can be used to reduce administrative expenses or employer contributions to the Plan.

***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC), and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

**Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## API Group 401(k) Plan Notes to Financial Statements

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment manager, advisors, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during 2022.

#### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

#### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation of fair value of investments.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Plan's financial statements.

#### ***Subsequent Events***

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 16, 2023, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in the financial statements.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The Plan Sponsor has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified to be complete and accurate by the qualified institution:

- a) Total investments, at fair value, included in the statement of net assets available for benefits at December 31, 2022.
- b) Interest and dividends and net depreciation in fair value of investments information included in the statement of changes in net assets available for benefits for the period from inception (March 1, 2022) through December 31, 2022.
- c) All amounts included in Note 4, *Fair Value Measurements*;
- d) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2022.

### Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### Note 4: FAIR VALUE MEASUREMENTS (UNAUDITED) (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Funds:* Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are primarily invested in securities issued by the U.S. government or its agencies. These funds are required to publish their daily NAV which is maintained at a stable share price of \$1 and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5: TAX STATUS**

The Plan uses a Prototype Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Ascensus. The IRS has determined and informed Ascensus by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan incurs expenses related to general administration, recordkeeping services and investment advisory services. These expenses qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Certain Plan investments are managed by Vanguard. Vanguard is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### **Note 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer discretionary matching and profit sharing contributions.

### **Note 8: DELINQUENT PARTICIPANT CONTRIBUTIONS**

The Department of Labor (DOL Regulation 2510.3-102) requires an employer to segregate participant contributions from its general assets as soon as practicable, but in no event later than the 15th business day following the end of the month in which amounts are contributed by participants or withheld from their wages. During the period from inception (March 1, 2022) through December 31, 2022, the Company failed to segregate contributions totaling \$125,347 in a timely manner. Although the contributions were remitted to the Plan in 2022, the Company did not contribute lost earnings associated with these late remittances. As required by the Department of Labor, the late remittances continue to be reported as late through the year the lost earnings are contributed. The Company calculated lost earnings pursuant to guidelines established by the Department of Labor. The amount, which is immaterial to the financial statements, is not recorded in the accompanying statement of net assets available for benefits. The Company is in the process of contributing lost earnings and interest, filing Form 5330, paying all applicable excise taxes and filing under the Voluntary Fiduciary Compliance Program.

### **Note 9: VOLUNTARY CORRECTION PROGRAM**

The Company is in the process of filing a Voluntary Correction Program (VCP) submission with the IRS to address (a) retroactive amendment of the Plan's definition of compensation, and (b) certain administration errors resulting in missed deferral opportunities (employee contributions) of \$39,284 and safe harbor contributions of \$2,047 which are both included in the corrective contributions receivable at December 31, 2022. The Plan administrator does not expect the pending VCP submission to affect the Plan's tax status.
