INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
David's Bridal 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of David's Bridal 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the David's Bridal 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan sponsored by David's Bridal, LLC (the "Company" or "plan sponsor") for the benefit of its employees, except for employees covered by collective bargaining agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was adopted on January 28, 2007. The Plan was amended on August 1, 2023 at which time David's Bridal, Inc. became the plan sponsor. See Note 10.

Contributions - Participants may contribute up to 50% of pre-tax annual compensation, as defined in the Plan document, up to amounts allowable by law. Participants are also permitted to contribute Roth Elective Deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan document. In the event that participant contributions exceed amounts allowable by law, such excess contributions are refunded to the participants.

The Company may make a discretionary matching contribution. Profit sharing (nonelective) contributions may be contributed at the option of the Company. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. There were no discretionary matching contributions for the year ended December 31, 2022. There were no profit sharing (nonelective) contributions for the year ended December 31, 2022.

Participant investment account options - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common/collective trust funds as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations of Company contributions are based on participant contributions or compensation. Allocations of earnings and administrative expenses are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions, qualified nonelective contributions (QNEC), and actual earnings thereon. Employees hired before January 1, 2012, are 100% vested in matching contributions. Nonelective contributions for all employees and employer matching contributions for employees hired after January 1, 2012, are subject to the following vesting schedule:

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.25%, which are commensurate with local prevailing rates as determined periodically by the plan administrator. Principal and interest are paid ratably through payroll deductions. Generally, the term of the loan cannot exceed five years. The term of a home purchase loan cannot exceed fifteen years.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant or his/her beneficiary(ies) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his/her account or installments over a period of not more than the participant's and/or his/her beneficiary's life expectancy. If a participant's vested benefit does not exceed \$5,000, the participant will be entitled to a lump sum distribution within a reasonable time after termination of service due to other reasons. A participant may also withdraw all of his or her vested balance in the event of financial hardship, as defined in the Plan.

Forfeited accounts - Forfeitures of employer profit sharing contributions may be used to pay Plan expenses or reduce future employer matching or profit-sharing contributions. As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$11,312 and \$45,338, respectively. For the year ended December 31, 2022, \$47,521 of forfeitures were used to reduce employer contributions.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Other income - Other income includes revenue share payments received from ADP. In 2022, the Plan received \$90,072 in revenue share receipts. In addition, other income of \$1,200 was recorded in 2022.

Payment of benefits - Benefits are recorded when paid.

(2) Summary of significant accounting policies (continued)

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Certain investment-related expenses are paid by the Plan. Fees paid by the Plan for recordkeeping, consulting, and attest services were \$409,677 for the year ended December 31, 2022.

Stale check liability - Distribution checks that were not cashed by participants were voided and deposited into one of the Plan's forfeiture accounts. As these funds represent amounts due to former participants, they are included in the Plan's statements of net assets available for benefits as stale check liability.

(3) Information prepared and certified by the trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held on December 31, 2022 and 2021, and net depreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "*Fair Value Measurements and Disclosures*," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

(4) Fair value measurements (continued)

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at estimated fair value as determined by the issuer of the common/collective trust fund based on the fair market value of the underlying investments. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust funds, the investment adviser reserves the right to temporarily delay withdrawal from the funds in order to ensure that the securities' liquidations will be carried out in an orderly business manner.

All of the Plan's mutual fund investments at fair value are considered to be Level 1 investments within the fair value hierarchy. The Plan's investments in common/collective trust funds are excluded from the fair value hierarchy as they are measured daily at NAV on a nonpublic market. There are no unfunded commitments and participants may transact daily. The Invesco Stable Asset ADP Z fund has a 12-month plan level redemption notice period and the other common/collective trust funds do not have a plan level redemption notice period.

(5) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(7) Tax status

The Internal Revenue Service ("IRS") has determined that the Automatic Data Processing, Inc.'s ("ADP") prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in a letter dated October 6, 2020. The plan administrator has adopted the ADP prototype plan and believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Related-party transactions and party-in-interest transactions

The Plan investments are held by Reliance Trust Company, the trustee. Fees paid to the Plan's recordkeeper for the year ended December 31, 2022, were \$153,385 and fees paid to other service providers were \$256,292. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net depreciation in fair value of investments.

In 2022, the Plan used \$142,010 from the unallocated revenue share account to pay Plan expenses.

(9) Risks and uncertainties

The Plan provides for various investment fund options. Investment securities are exposed to various risks such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

(10) Subsequent events

Plan Sponsor

On April 17, 2023, the plan sponsor filed for Chapter 11 bankruptcy protection. As a result of the bankruptcy proceedings, on July 21, 2023, a significant portion of the plan sponsor's assets were purchased and certain of its liabilities were assumed by David's Bridal, Inc. In addition, on August 1, 2023, the Plan was amended to provide for David's Bridal, Inc. to be the named plan sponsor. David's Bridal, Inc. has no intentions to terminate the Plan.

The Plan has evaluated subsequent events through October 16, 2023, which is the date the financial statements were available to be issued.
