Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **Emphasis of Matter**

As described in Note 5 to the financial statements, the governing body of Blaine Larsen Farms, Inc. Retirement Savings Plan approved a plan of liquidation in August 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from accrual basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to the matter.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Blaine Larsen Farms, Inc. Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. Description of Plan**

The following description of the Blaine Larsen Farms, Inc. (“Company”) Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute up to the IRS statutory maximums of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100 percent of the first 4 percent of base compensation that a participant contributes to the plan. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants’ are vested immediately in their contributions plus actual earnings thereon. The Company’s matching contribution portion of their accounts is also calculated based on years of service, being fully vested after 2 years.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance minus the participants’ highest outstanding loan amount during the prior 12 months. The loans are secured by the balance in the participant’s account and bear interest at a reasonable rate as determined by the investment committee. Principal and interest is paid ratably through bi-weekly payroll deductions.

**1. Description of Plan (continued)**

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive amounts in excess of \$5,000 as either a lump-sum amount equal to the participant's vested interest in his or her account, or annual installments over a ten year period. Account balances less than \$5,000 will be distributed in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures**

Participants, who terminate service prior to being fully vested in the Employer Contribution Account(s), forfeit the amount not vested. Forfeitures are used to reduce future Employer Contributions to the Plan. For the period ended December 12, 2022 and year ended December 31, 2021, forfeited non-vested accounts totaled \$0 and \$457, respectively.

**Investment Options**

Participants may direct contributions, including Company matching contributions, in whole percentage increments to any of the investment options offered by the Plan.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements for the period ended December 12, 2022 and the year ended December 31, 2021 are prepared on the liquidation basis (due to plan termination) and accrual basis of accounting, respectively, in conformity with the accounting principles generally accepted in the United States of America. Investments held by the Plan are required to be reported at fair value. Participant loans are valued at amortized, which represents fair value. See Note 3 for further information regarding fair value measurement.

**Change in Basis of Accounting**

Due to the plan termination and the imminent liquidity of plan assets in 2022, the net assets for the period ended December 12, 2022, were presented on the liquidation basis of accounting. The financial statements are presented in a comparative format and the statements ended December 31, 2021 were presented on the accrual basis of accounting. There are no changes to the plan assets other than ending balances are zero at December 12, 2022, due to all assets being transferred to employees. See note 5 for further information.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Administrative Expenses**

Fees deducted from the plan assets at the plan administrator's direction were \$314 and \$183 for the period ended December 12, 2022 and year ended December 31, 2021, respectively. These fees included compensation paid with respect to funds for certain investment options included in the plan.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the plan at year end. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

All expenses of maintaining the Plan are paid by the Company.

**Subsequent Events**

The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued.

**3. Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 12, 2022 and December 31, 2021.

**Mutual funds:** Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset values (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Classification within the fair value hierarchy table is based on the lowest level of any inputs that is significant to the fair value measurement.

**4. Party in Interest**

Certain plan investments are shares of mutual funds managed by Great-West Life & Annuity Insurance Company and Great-West Trust Company, LLC ("Great-West") and MassMutual. Great-West and MassMutual are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Other party-in-interest transactions include fees paid to third party administrators and audit fees. Fees paid by the Plan to parties-in-interest amounted to \$314 and \$183 for the period ended December 12, 2022 and year ended December 31, 2021. Fees paid by the Company to parties-in-interest amounted to \$7,250 and \$6,900 for the period ended December 12, 2022 and year ended December 31, 2021.

**5. Plan Termination**

The Company has the right under the Plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants become fully vested in their account balances. Due to the small size of the plan and low participation, the Plan was terminated on August 31, 2022 and the fully vested balances were paid to the participant by December 12, 2022. There are no contributions that need to be paid out to the employer or employees and assets are zero, as the distribution was completed as of December 12, 2022.

**6. Income Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the letter, the Plan continues to fulfill the requirements of a qualified plan under Section 401(a) of the Internal Revenue Code and that the Plan is not subject to tax. Accordingly, no provision for federal or state income taxes has been provided.

**7. Information Certified by the Trustee**

Great-West holds the Plan's investment assets and executes transactions therein. The following financial information of the Plan as of December 12, 2022 and December 31, 2021, and for the period/year then ended, is included in the accompanying financial statements and supplemental schedule and was obtained from data that has been prepared and certified as complete and accurate by Great-West. This information, which has not been audited by us, is summarized as follows:

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Delinquent Participant Contributions**

During 2022, the Company failed to remit to the Plan's custodians certain employee contributions totaling approximately \$3,689 within the period prescribed by the DOL regulations. Delays in remitting contributions to the custodians were due to administrative errors, and the Company has made all contributions to the affected participants' accounts and will make additional contributions to compensate the participants for potential lost income due to the delay as necessary.
