## Independent Auditors' Report

Plan Participants and Board of Trustees  
Medical Service Company 401(k) Plan and Trust

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Medical Service Company 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2022, and February 28, 2022, and for the period March 1, 2022, through December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## NOTES TO THE FINANCIAL STATEMENTS

## 1. DESCRIPTION OF PLAN

The following description of the Medical Service Company 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all employees of Medical Service Company (the Company) who had attained 21 years of age and had completed 250 hours of service in a 3 month period, except for (1) union employees; (2) leased employees; (3) non-resident aliens; and (4) interns and co-ops. Once eligible, employees could enroll in the Plan on the first day of each plan quarter on March 1, June 1, September 1, or December 1. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversaw the governance of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's Board of Trustees.

Transfer Out of Plan

During 2022, Plan management elected to merge the Plan with the Greater Akron Chamber of Commerce Multiple Employer 401(k) Plan (Greater Akron Plan), with an effective date of January 1, 2023.

As part of the transfer, Plan management instituted a blackout period under which any and all activity relating to employee or employer contributions, distributions, loan activity, investment election changes, and deferral percentage changes were suspended for participants under the Plan. The blackout period began at market close on December 30, 2022, and end during the week of January 2, 2023. Plan assets were valued as of the market close on December 31, 2022, and transferred to the Greater Akron Plan. As such there are no net assets available for benefits under the Plan at December 31, 2022. Upon transfer to the Greater Akron Plan, Plan investment balances were liquidated and reinvested under the Greater Akron Plan default investment options, the Vanguard Target Retirement – Investor Target Maturity series, closest to the participant's normal retirement age.

Contributions

Each year, participants could make voluntary pre-tax and Roth contributions up to 100% of their eligible annual compensation, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company could, at its discretion, make matching contributions. Matching contributions equal to 25% of the first 6% of the compensation that a participant contributed to the Plan were made for the period March 1, 2022, through December 31, 2022. The Company could also authorize discretionary profit sharing contributions to the Plan for the related year. These contributions were funded in the year subsequent to their authorization. There were no profit sharing contributions authorized for the period March 1, 2022, through December 31, 2022. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

## NOTES TO THE FINANCIAL STATEMENTS

## 1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

A separate account was maintained for each participant. Each participant's account was credited with the participant's contributions, rollover contributions, allocations of the Company's contributions, and Plan earnings or losses as defined by the Plan agreement. Allocations of the Company's profit sharing contribution were given only to participants employed at the end of the Plan year who had completed at least 1,000 hours of service during the Plan year, and were based on participants' compensation for the Plan year relating to the contribution. Plan earnings or losses were allocated daily based on each participant's account balance. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions plus actual earnings thereon was based on years of continuous service, or upon reaching the normal retirement age, as defined. A participant vested on a graded schedule, vesting 20% after 2 years of credited service and each year thereafter, resulting in 100% vesting after 6 years of credited service.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account. The loan interest rate, determined at inception, was set at Prime (7.50% at December 31, 2022, and 3.25% at February 28, 2022), as defined, plus 2%, in accordance with the Plan's loan policy. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's account balance was more than \$1,000, but less than \$5,000, the plan administrator directed the custodian to make a lump-sum distribution, rollover the distribution to an individual retirement account, or a rollover to the qualified plan of your new employer. If the participant's account balance was \$1,000 or less, the participant's vested account balances will be distributed directly as a single lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions of a participant's 401(k) account balance may be authorized at any time by the plan administrator under certain hardship conditions.

## NOTES TO THE FINANCIAL STATEMENTS

## 1. DESCRIPTION OF PLAN (Continued)

Forfeited Accounts

Forfeited nonvested accounts were used to reduce administrative expenses or to reduce future employer contributions. At February 28, 2022, forfeited nonvested accounts totaled approximately \$21,000. For the period from March 1, 2022, through December 31, 2022, approximately \$35,000 was used to reduce employer contributions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All Plan assets were transferred to the Greater Akron Plan at the close of business on December 31, 2022. As of February 28, 2022, investments were reported at fair value by Empower Trust Company, LLC (Empower Trust) and Empower Annuity Insurance Company of America (Empower), former known as Great-West Trust Company, LLC and Great-West Life and Annuity Insurance Company, respectively, the custodians of the Plan (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

## NOTES TO THE FINANCIAL STATEMENTS

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (continued)

Assets of the Plan were held in separate accounts of a trust administered by Great-West and Great-West Trust, representing investments in mutual funds and a guaranteed investment contract.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits were recorded when paid.

Plan Expenses

The Plan's administrative expenses were paid either by the Plan or the Company as provided by the Plan agreement. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Income Taxes

In accordance with GAAP, the plan administrator was required to evaluate tax positions taken by the Plan and recognize a tax liability for any significant uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2022, and February 28, 2022, and for the period from March 1, 2022, through December 31, 2022, the Plan did not have a liability for unrecognized tax benefits. The Plan was subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Subsequent Events

Plan management has evaluated subsequent events through October 13, 2023, the date the financial statements were available to be issued.

## NOTES TO THE FINANCIAL STATEMENTS

## 3. INFORMATION CERTIFIED BY CUSTODIANS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022, and February 28, 2022, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period March 1, 2022, through December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower and Empower Trust, the custodians.

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

As a result of the plan transfer on December 31, 2022 (Note 1), there were no investments held at December 31, 2022. Following is a description of the valuation methodology used for assets measured at fair value at February 28, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds that were held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

## NOTES TO THE FINANCIAL STATEMENTS

## 4. FAIR VALUE MEASUREMENTS (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Assets measured at fair value are comprised of Level 1 mutual funds \$8,651,574 at February 28, 2022.

## 5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had a fully benefit-responsive investment contract with Empower. Empower maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan by Empower, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The crediting interest rate was based on a formula established by the issuer. Such interest rates were reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract was dependent on the third-party issuer's ability to meet its financial obligations.

## 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are management by Empower and Empower Trust. Empower and Empower Trust are the custodians as defined by the Plan and, therefore, such transactions qualified as party-in-interest transactions.

Qualified Pension Consultants, Inc. (QPC), the recordkeeper, provided certain administrative services to the Plan pursuant to an Administrative Services Agreement between the Company and QPC. QPC receives revenue from mutual fund and collective trust fund service providers for services QPC provides to the funds. This revenue was used to offset certain amounts owed to QPC for its administrative services to the Plan. There were no revenues remitted during the period March 1, 2022, through December 31, 2022.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

## NOTES TO THE FINANCIAL STATEMENTS

## 7. TAX STATUS

The Plan adopted a pre-approved plan provided by QPC. QPC received an opinion letter dated June 30, 2020, from the IRS stating that the pre-approved plan was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan had been amended since receiving the opinion letter, the plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC.
