Basis For Opinion On The 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The 2022 Financial Statements section of our report. We are required to be independent of the Campos EPC, LLC Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities Of Management For The 2022 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Campos EPC, LLC Retirement Savings Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities For The Audit Of The 2022 Financial Statements

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the 2022 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Campos EPC, LLC Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Campos EPC, LLC Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matters

2022 Supplemental Schedules Required By ERISA

The supplemental schedules of assets held at end of year as of December 31, 2022 and the delinquent participant contributions for the year ended December 31, 2022 are presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Auditors' Report On The 2021 Financial Statements

Predecessor auditors performed an audit of the 2021 financial statements of Campos EPC, LLC Retirement Savings Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior-year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report, dated July 15, 2022, indicated that (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2021 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2021 supplemental schedule, other than the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2021 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or was derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

December 31, 2022

1. Description Of The Plan

The Campos EPC, LLC Retirement Savings Plan (the Plan) is sponsored by Campos EPC, LLC (the Plan Sponsor) and various related companies (the Adopting Employers) (collectively, the Company). Participants and all others should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted by the Plan Sponsor, effective January 1, 2018. The Adopting Employers have also adopted the Plan. The Plan is a defined contribution plan covering eligible employees of the Company. The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (the IRC), which includes a qualified deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian And Administration Of The Plan

Reliance Trust Company is the designated custodian of the Plan (the Custodian). The Custodian holds all assets of the Plan in accordance with the custodial agreement with the Company. The recordkeeper of the Plan is Transamerica Retirement Solutions, LLC (Transamerica). The administrator of the Plan is the Company.

Eligibility

Each employee is eligible to become a participant in the Plan and eligible for discretionary employer matching contributions, discretionary profit-sharing contributions and Safe Harbor matching contributions on the first day of the month, coincident with or following attainment of age 21 and completing a service requirement of 6 months. Union and nonresident aliens are not eligible.

Contributions

Eligible participants may contribute, on a pre-tax basis or after-tax Roth basis, up to 100% of their qualifying annual compensation as elected in their salary deferral agreements. Participant contributions are subject to certain IRC limitations. Effective January 1, 2021, the Plan was amended to permit automatic deferral provisions whereby eligible newly hired employees will be automatically enrolled in the Plan at deferral rate of 3% unless they actively opt out of participating in the Plan or elect a different deferral rate. Salary deferral agreements shall be made, terminated or changed according to procedures and limitations set up by the plan administrator and the Plan document. The Plan also allows catch-up contributions for participants age 50 and over subject to certain IRC limitations. Participants may change their contribution percentage and may cease making pre-tax and after-tax Roth contributions at any time.

The Company may make discretionary employer matching contributions and discretionary profit-sharing contributions. No discretionary employer matching contributions or profit-sharing contributions were made for the plan year ended December 31, 2022. The Company makes a Safe Harbor matching contribution, on a pay period basis, equal to 100% of first 3% and 50% of next 2% of eligible compensation contributed by participants. Rollover contributions transferred from other qualified retirement plans are accepted as permitted by the Plan document.

Participant Accounts

Participants' accounts are credited with employee pre-tax and after-tax Roth contributions, rollover contributions, discretionary employer matching and profit-sharing contributions and Safe Harbor matching contributions, as well as an allocation of plan earnings or losses. Participants are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. The benefit to which participants are entitled is the vested portion of their accounts.

Investment Options

Participants may direct the investment of their account balance into various investment options offered by the Plan. The Plan offers various mutual funds and an insurance contract. Participants may change their investment directions at any time subject to such restrictions and procedures as are established by Transamerica. The Plan committee and investment advisor determine the appropriateness of the Plan's investment offerings and monitors investment performance.

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions, Safe Harbor matching contributions and earnings thereon. Discretionary employer matching contributions and discretionary profit-sharing contributions are vested as follows:

Forfeitures

At December 31, 2022 and 2021, there were \$2,527 and \$1,539 forfeited nonvested accounts, respectively. The amount of any nonvested forfeiture attributed to a participant's break in service, as specified by the Plan document, will be used to reduce future discretionary employer matching contributions, discretionary profit-sharing contributions and/or pay Plan expenses. For the 2022 plan year, there was \$2,069 of forfeitures used to pay Plan expenses.

Notes Receivable From Participants

A participant may borrow from their account the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Participants may only have 2 loans outstanding at any given time. Loans are secured by the participant's vested account. The loans are to be repaid over a 5-year period unless they are for the purchase of a principal residence, which allow for up to a 30-year period. Principal and interest are collected ratably through bi-weekly payroll deductions.

Payment Of Benefits

A participant's vested interest in the Plan is payable upon death, attainment of normal retirement age (age 65), disability, as defined, or termination of service. A participant may elect to receive his/her benefit payment in the form of a lump-sum amount, a partial distribution, rollover the funds to another qualified plan or individual retirement account, or remain in the Plan if his/her vested account balance has a minimum of \$5,000. Distributions of vested account balances of \$1,000 or less may be distributed to participants in cash. Distributions of vested account balances greater than \$1,000, but less than or equal to \$5,000, are paid as a direct rollover to an individual retirement account in the name of the Plan participant. These mandatory distributions apply only to participants who have separated from service and do not affirmatively elect a distribution of their accounts. Hardship withdrawals and certain other in-service withdrawals at age 59½ are also allowed by the Plan if certain criteria are met.

2. Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments held in a defined contribution plan, other than fully benefit-responsive investment contracts, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits, and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investments held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Stable Value Strategy Option is a fully benefit-responsive investment contract and is reported at the contract value in the statement of net assets available for benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefits

Benefits are recorded when paid.

Subsequent Event

Management evaluates subsequent events through the date the financial statements were available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021 and net change in fair value of investments, interest and dividends for the year ended December 31, 2022, was obtained or derived from information supplied to the Plan Administrator and certified by a qualified institution.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Assets are valued at the daily closing price as reported by the registered investment company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

There have been no changes in the valuation methodology in 2022 or 2021.

5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Transamerica. Contract value represents contributions made under the contract, plus earnings, less plan withdrawals and administrative expenses (Level 2, Fair Value Measurement). There are no reserves against contract value credit risk of Transamerica or otherwise. The contract value of the investment contract at December 31, 2022 and 2021 was \$1,571,500 and \$1,049,601, respectively. Prior to January 1st and July 1st, the effective annual rate of interest is established for the corresponding six-month period. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate. Transamerica is contractually obligated to repay the principal and an interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit Transamerica to terminate the agreement prior to the scheduled maturity date. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable, for example, a significant decline in creditworthiness of Transamerica, the Stable Value Option investment choice may no longer be considered fully benefit responsive.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks And Uncertainties

Investments, in general, are subject to various risks, such as significant world events, interest rates, market volatility and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Income Tax Status

The Plan uses a volume submitter defined contribution plan sponsored by Transamerica. The “pre-approved plan” has obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Party In Interest Transactions

Plan investments consist of a fully benefit-responsive investment contract managed by Transamerica. These transactions qualify as party in interest transactions allowable under ERISA.

The Plan incurs expenses related to general administration and recordkeeping. The Company performs certain administrative functions at no cost to the Plan.

Certain participants in the Plan have outstanding loans with the Plan as of December 31, 2022 and 2021. These loans are considered party in interest transactions in accordance with Department of Labor guidelines.
