Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Acreage 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2022, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Acreage 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL/ELIGIBILITY

The Plan, which was established on April 1, 2019 with an effective date of January 1, 2019 is a defined-contribution plan covering all employees of Acreage Holdings, Inc. (the “Company”), who have completed three months of credited service and have attained the age of 21. The Plan is qualified under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Company’s management is responsible for oversight of the Plan. The Company’s management determines the appropriateness of the Plan’s investment offering and monitors investment performance. John Hancock Life Insurance Company of New York (the “Trustee”) is the Plan’s trustee and record keeper.

CONTRIBUTIONS

Participants

An eligible participant may elect to contribute up to 100% of its eligible compensation, as defined in the Plan, up to the maximum allowable under the IRC, which was \$20,500 for 2022. Participants age 50 or older are allowed a “catch-up” contribution, subject to the Internal Revenue Service (“IRS”) prescribed limit of \$6,500 for 2021 and 2022.

Employer

The Company shall contribute and allocate to each non-highly compensated participant matching contributions equal to 100% of the elective contribution made for the participant's benefit up to a maximum matching contribution of 3% of the participant's compensation and 50% of the elective contribution made for the participant's benefit on the next 2% of the participant's compensation. The Company may also make additional discretionary contributions to the Plan for each participant who made contributions to the Plan during the year. During the year ended December 31, 2022, the Company did not make any discretionary matching contributions.

Rollovers

The Plan has a rollover-contribution election to which a participant is permitted to make a rollover contribution to the Plan from certain other types of qualified benefit or contribution plans.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of (i) the Company's contributions, if any, and (ii) Plan earnings or loss thereon. Certain fees incurred by John Hancock Life Insurance Company of New York or the Plan administrator in connection with the direction of a participant on any plan account maintained on the participant's behalf may be charged and paid from the assets of such account.

As a participant-directed plan, each participant's investments determine his or her share of earnings or losses. Allocations of Company contributions are based on a participant's elected contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are fully vested in their contributions and any actual earnings or loss thereon. Vesting of the Company's contributions and discretionary matching contribution, if any, and any income or loss is based on continuous service. A participant shall have a vested interest in Company contributions and earnings or loss thereon according to the following schedule:

2 but fewer than 3	66%
3 years of Service or more	100%

A participant shall become fully vested in the entire value of the participant's account upon death, attaining normal retirement age of 65, or permanent disability.

NOTES RECEIVABLE FROM PARTICIPANTS

Generally, the Plan does not permit loans to be made to participants from the Plan. As of December 31, 2022 and 2021, there was \$0 and \$2,804, respectively, outstanding at a rate of 6%. The outstanding loan as of December 31, 2021, which was repaid during 2022, resulted from a Company acquisition in September 2018, where a participant loan transferred to the plan.

PAYMENT OF BENEFITS

The Plan permits hardship withdrawals, in-service withdrawals and lump sum distributions to be made as defined by the Plan agreement.

Payment of benefits is based on the participant's vested account balance and shall be payable by reason of a participant's death or total and permanent disability or, after attainment of normal retirement age, shall be payable as of the anniversary date following the event entitling the participant (or beneficiary) to such distribution.

At the election of the participant, the Plan administrator may direct the trustee to cause the entire vested portion of the vested participant's account to be payable to such vested participant as of the valuation date coincident with or next following the participant's termination of employment.

Participants may elect to receive benefit payments in one lump-sum, or a joint and survivor annuity. If the value of a vested participant's account does not exceed \$5,000, the Plan administrator may direct the Trustee to cause the entire benefit to be paid to such participant as of such date. The Plan also allows for in-service distributions to participants who have attained age 59½, or who qualify for hardship distributions, as defined by the IRS.

CARES ACT

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was enacted, which included provisions, which among others, provide temporary relief for those retirement plan participants affected by the coronavirus disease (COVID-19). Participants who met certain criteria could take a penalty-free hardship withdrawal, borrow from their accounts at higher limits and suspend making payments on their participant loans until 2021. During the period between March 27, 2020 and September 22, 2020, participants impacted by COVID-19 could borrow from their account up to the lesser of \$100,000 or the vested account balance and could suspend loan repayments due during that period until January 2021.

FORFEITED ACCOUNTS

Forfeitures resulting from non-vested portions of participants' accounts, which terminate prior to being fully vested, are used to reduce the Company's current Plan year or future year's contributions. During the Plan year ended December 31, 2022, the Plan did not apply any forfeitures against Company contributions. At December 31, 2022 and 2021, there were no forfeited balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

These financial statements of the Plan are prepared under the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reported period. Actual results could differ from those estimates.

RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of the investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Users of the financial statements should be aware that the financial market's volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2022 may not necessarily be indicative of amounts that could be realized in a current market exchange.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected in the net change in fair value of investments for such investments.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default based upon the terms of the Plan agreement, the participant loan balance is reduced and a benefit payment is recorded.

MUTUAL FUND AND COMMON AND COLLECTIVE TRUST FEES

Investments in mutual funds and common/collective trusts are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These fees are annual fees deducted to pay for marketing and distribution costs of the funds/trusts. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no such amounts as of December 31, 2022 and 2021.

ADMINISTRATIVE EXPENSES

All significant administrative expenses of the Plan are paid by the Company, except for certain investment fees charged by the trustee, record keeper, or administrator.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

MUTUAL FUNDS

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Investments in these mutual funds can be redeemed daily upon request.

COMMON COLLECTIVE TRUSTS

Valued using NAV. The NAV of a common/collective trust is based on the market values of the underlying securities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV would not be used as a practical expedient if it is determined to be probable that the investment will be sold for an amount different than the reported NAV. The beneficial interest of each investor is represented in units. Units are issued and redeemed daily at the funds closing NAV.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by John Hancock Life Insurance Company of New York, the Trustee of the Plan. Transactions relating to these investments qualify as party-in-interest transactions. Transactions involving participant loans also qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. The Plan Sponsor pays directly any other fees related to the Plan's operations.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE 7 - TAX STATUS

The Company adopted a prototype plan, which received an opinion letter from the IRS, dated March 31, 2014, which stated that the Company may rely on the opinion letter with respect to the qualification of the Plan under IRC Section 401(a) except as stated below, and also informed the Company that the prototype plan will not receive a determination letter.

NOTE 7 - TAX STATUS (CONTINUED)

The opinion of the IRS does not apply for purposes of IRC 401(a)(10)(B) and 401(a)(16); however, the Company may separately request a determination from the IRS with respect thereto. The Company has not requested such a determination. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the requirements provision of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - SUBSEQUENT EVENTS

The Plan's management evaluated events occurring subsequent to December 31, 2022 through October 16, 2023, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements.
